On Saturday, September 1, 2007, complainant (loss prevention) advised investigation has revealed that on the above-cited dates, one of their cashiers rang up inexpensive items when suspects came through her line and allowed them to walk out with more expensive items she did not ring up. He advised the employee confessed that she met a guy in Virginia Beach who offered to help her out of financial problems she had due to a child with sickle cell anemia; he advised he would come through her line and she should ring up only the inexpensive items, he would sell the expensive items he just walked out with, and they would split the profit. She advised she never received any money.
