On Wednesday, December 5, 2007, complainant advised that since Thanksgiving weekend, an unknown subject(s) has **stolen a total of 209 red steel channel beams** left unsecured on a pallet at the site since they were delivered two months prior. He advised on Tuesday, November 27th, there were only 40 of 216 beams left, and by Wednesday, November 28th, there were only 7 left. He believes someone is taking them 30-40 at a time in some kind of pickup truck.
