

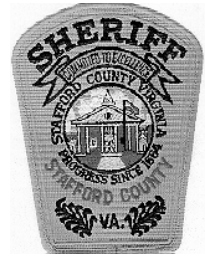

**BURGLARY TO HOUSE UNDER CONSTRUCTION/ ARSON/ VAND
WINNING COLORS RD**

ALPHA/ SEVEN LAKES

Complainant advised he had left windows open to vent staining fumes and found a rear window broken at the frame (possible entry point), an exterior pane of an adjacent window broken, and the side door unlocked (possible exit point). A portable stereo was broken after being dropped from the top floor to the basement. In addition, a jacket on the top floor banister was set on fire. A construction trailer in the front yard was entered, but nothing was damaged or stolen.
