COUNTERFEIT CHECKS/ IDENTITY FRAUD

FREDERICKSBURG MOTOR SPORTS/ 430 KINGS HWY

BRAVO

Owner advised she has received four fraudulent checks for \$3500 purportedly from her company's checking account sent to locations in KY, NH, CA, and FL. The checks reflect a different bank and an incorrect spelling (Fredricksburg), but have the correct account, routing, and check numbers. She advised the checks were sent via UPS from the Virginia Beach area with tracking identifiers for BAE Systems in NH. A subject in FL advised her he had received the check after placing items for sale on Craig's List; he also received an email allegedly from her advising to send the excess back to her via money order.
