On Thursday, July 17, 2008, complainant advised someone stole his .45 caliber semi-automatic handgun with walnut grips & custom sights from a holster on a chair in his downstairs den. He advised the gun was not visible until you walked over to the chair; he also advised nothing else was stolen. He suspects a male he allowed to live in the shop on his property during the above-cited time frame, and last saw him in Lake Arrowhead three weeks prior to reporting the theft.
