

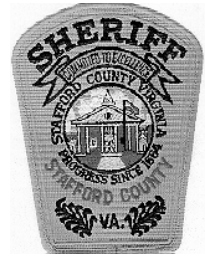

## General Assignment

**Friday, October 10, 2008 – Saturday, October 11, 2008** **2:30 pm – 6:00 am**

**LARCENY FROM NEW COMMERCIAL CONSTRUCTION (COPPER)  
SPORT & HEALTH SITE/ 315 GARRISONVILLE RD DELTA/ BRAFFERTON SHOPPING CENTER**

On Monday, October 13<sup>th</sup>, site electrical foreman advised an unknown subject(s) stole 4 spools of #3 copper wire and 4 spools of 1 AWG copper wire from the roof of the reference building under construction. The spools had been delivered Friday and immediately lifted onto the roof.

**GRAND LARCENY (BOAT ON TRAILER)  
CRESCENT BLVD/ GETTYSBURG CT CHARLIE/ CRESCENT POINTE**

Complainant advised an unknown subject(s) stole their gray 12' 2000 john boat with 9.9HP outboard motor on a 2000 boat trailer (VA/CT456495). The boat was parked on the street near the reference intersection.

**LARCENY (\$3800 IN ELECTRONICS FROM RV)/ VANDALISM  
DIGITAL IMPRESSIONS/ 1127 INTERNATIONAL PKWY #109 ALPHA/ STAFFORD INDUSTRIAL PARK**

Complainant advised he commonly leaves his 2007 Workhorse RV parked behind his company when not in use; he found a window broken and part of a TV mount outside. It appears an unknown subject(s) entered from the front and ripped electronics out throughout the RV. They also went through the kitchen cabinets, broke part of the counter, and attempted to steal the microwave. Items stolen include the vehicle radio, CD player, 42" flat panel TV with AV switch, 2 DVD players, 2 DirecTV receivers, 27" plasma TV, 19" flat screen TV, and a spare set of the RV keys.
