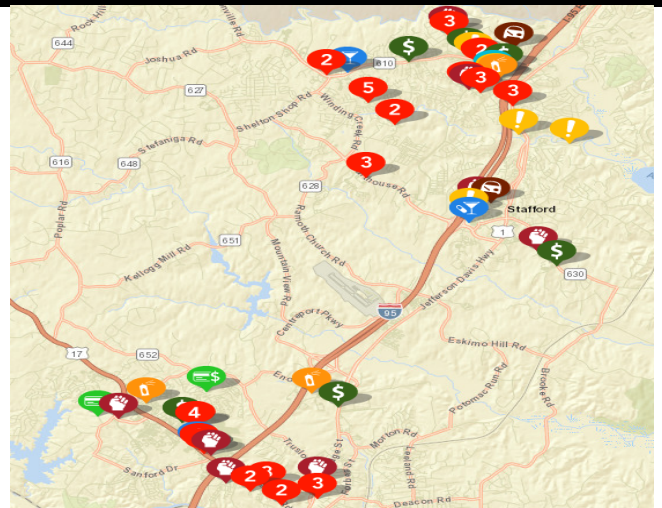

| Fraud: SCAM: Victim received a text to upgrade their phone by selecting the enclosed link. Victim attempted the upgrade but continued to have difficulties and decided to call the phone number provided in the original text. The individual who answered the call explained the victim would be required to set up a CashApp account in order to complete the upgrade, and offered to assist the victim in setting up an account; victim graciously accepted the assistance. The victim initially received funds into their newly set up account; however, the funds were immediately transferred out of the account as well as additional funds from the victim's account, and the call was then immediately disconnected. 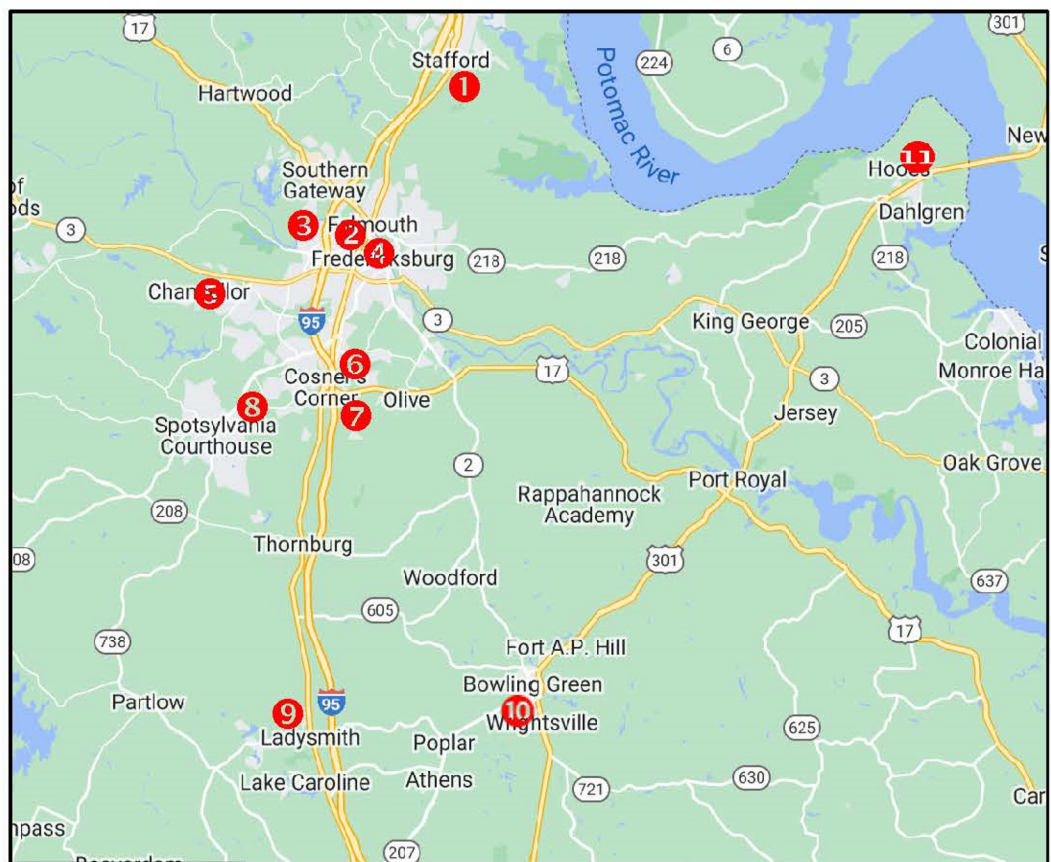
