WEEKLY CRIME REPORT



APRIL 14TH – APRIL 20TH, 2025

ALPHA ZONE

LARCENY

Motel 6, 401 Warrenton Road, a deputy was in the area when he observed a vehicle displaying a stolen license plate. The deputy made contact with the occupant, who admitted to “finding” the license plate behind a dumpster. The tag was seized, and a summons for larceny was issued.

Armor Court, a deputy was responding to an unrelated call when he observed a Dodge Ram. The vehicle in question was reported stolen out of Fredericksburg. Deputies conducted a high-risk stop and detained the suspended driver. The driver was charged with possession of a stolen vehicle and driving while suspended. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

FRAUD

Wawa, 9 South Gateway Drive, a deputy was in the area when he observed a pair engaging in a verbal altercation. In an attempt to quell the situation, he made contact with the male and female. The female identified herself as “Karen.” Using law enforcement databases, the deputy discovered that this “Karen” wasn’t providing her real identity. She was eventually identified and discovered to have a warrant out of Fredericksburg. She was served on her outstanding warrant and an additional charge of identity theft and providing a false identification to law enforcement. She was held at Rappahannock Regional Jail on a \$500 secured bond.



BRAVO ZONE

PUBLIC INTOXICATION

Sherwood Forest Farm Road. Deputies responded to a public intoxication call. Multiple callers advised that a male was dancing in the street. Deputies quickly located the "Footloose" suspect and observed signs of intoxication. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

TRESPASS

Smith Street, a deputy responded to an unlawful entry report. The victim advised that he discovered his cousin's ex-girlfriend crawling into the residence through a window. She would flee in a red Ford hatchback. A warrant for unlawful entry was obtained.



CHARLIE ZONE

DUI

Area of Richmond Highway and Hospital Center Boulevard, a deputy was traveling in the area when he observed a Maserati traveling southbound at speeds above 100 MPH. The deputy caught up to the vehicle on Hulls Chapel Road and conducted a traffic stop. The driver had signs of intoxication, no front license plate, and no vehicle inspection. After field sobriety tests, the driver was charged with driving under the influence, reckless driving, two counts of refusal, improper display of a license plate, and failure to inspect a vehicle. The vehicle was towed as the driver was held at Rappahannock Regional Jail without bond.

7-Eleven, 302 Town Center Boulevard, a deputy was traveling on Richmond Highway near Derrick Lane when he observed a vehicle traveling 56 MPH in a 35 MPH zone. The deputy conducted a traffic stop, and found that the driver had signs of intoxication, admitted to consuming two (2) beers, and a bottle of vodka was located under the driver's seat. The driver was charged with driving under the influence with a blood alcohol content above .2 and reckless driving. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

Area of Bells Hill Road and Hope Road, a deputy was traveling Southbound on Bells Hill Road when she observed the vehicle in front of her failing to maintain the lane of travel. After the vehicle conducted an improper turn at a red light, cutting off another vehicle in the process, the deputy conducted a traffic stop, and being a trained Drug Recognition Expert, made contact with the driver who had signs of being impaired. The driver was charged with driving under the influence, the traffic lane violation, and improper turn at a red light. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

LARCENY

Mile marker 147 of Southbound I-95, deputies were traveling into Stafford County when they observed a vehicle displaying a stolen license plate. A high-risk stop was conducted, and the driver was detained. The driver admitted he knew the tags were "illegal," and had no driver's license. The driver was charged with possession of stolen property, displaying a false license plate, driving without a license, and traveling in an unregistered vehicle.

VANDALISM

Cavalier Skating Center, a deputy responded to a report of vandalism. It was discovered that a male kicked a glass door "out of anger," causing it to shatter. He was charged with vandalism and was released by the magistrate on personal recognizance.

DISTURBANCE

Rappahannock Regional Jail, a deputy was in the middle of an unrelated bond hearing when an inmate began causing a disturbance. His disruption was so loud, the magistrate couldn't properly conduct the hearing. The inmate was charged with obstruction of justice.

DELTA ZONE

DUI

Sheehy Toyota, 95 Garrisonville Road, a deputy responded to a suspicious vehicle complaint. A security company advised that despite the business being closed, a driver was in the parking lot and appeared impaired. When the deputy arrived, she located the driver asleep in the Jeep, which was still running. When the driver awoke, he had signs of intoxication and admitted to consuming "three or four beers." The driver was charged with driving under the influence and two (2) counts of refusal. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

LARCENY

Rock Hill Honey Bee Farms, 45 Pinto Lane, a deputy responded to a vandalism. It was advised that the property owner discovered a large number of bees deceased. A total of 50 hives were affected, and the investigation is ongoing.

Walmart, a deputy responded to a larceny. Staff advised that "time" flew out the door when two (2) suspects stole watches. The suspects would flee the area in a "beat-up" vehicle with a New York license plate.

RECOVERED PROPERTY

Penns Charter Lane, a deputy responded to a recovered property call. The reporting party advised that he purchased a bike off of Facebook Marketplace only to discover it was reported stolen.

LARCENY

Stonegate Place, a deputy responded to a larceny. The victim advised that he ordered food through DoorDash. When he went to collect his goods, they were nowhere to be found, despite the DoorDash app stating the delivery was "handed to the customer."

WARRANT SERVED

Onville Road Marine Corps Gate, a deputy responded to a warrant service. Marine Corps authorities had a suspect at the gate that was wanted out of Maryland for a felony. The deputy took custody of the suspect and transported him to Rappahannock Regional Jail. He was charged with fugitive from justice and held without bond.



SCAM REPORT



Victim was contacted by an individual on Facebook who claimed to offer a lucrative investment opportunity. This individual was able to persuade the victim to invest \$250 through Apple Pay and an additional \$500 through Cash App. The claim was a “quick investment netting the Victim with a \$5000 return on the investment”. During the interaction, the scammers used “screen sharing” to convince the victim of the legitimacy of the transaction. They also gained access to the victim’s social media accounts, using them to further their scam by posting fraudulent messages. The victim has been unable to regain access to her social media accounts, and only after her social media accounts were compromised did she realize that sending \$750 to an unknown person was, in fact, a scam.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest.
