# WEEKLY CRIME REPORT



## **ALPHA ZONE**

#### **LARCENY**

Walmart, 11 Village Parkway, a deputy responded to a larceny. A staff member advised her purse was stolen while she worked. Using camera footage, it was discovered the purse was stolen by a couple. Walmart, 11 Village Parkway, a deputy responded to a larceny. Staff advised they observed a couple stealing nearly \$150 worth of items. The pair then fled the scene in a white sedan.

#### **ASSAULT**

Quality Inn, 543 Warrenton Road, a deputy responded to a disturbance between customers and employees. When the deputy arrived, both groups were still engaged in a verbal conflict that he had to de-escalate. It was discovered that the male and female customers stayed past check-out time and staff came to remind them. Instead, the customers exchanged profanities and the female customer assaulted a staff member. The female was checked out of the Quality Inn and placed into the Rappahannock Regional Jail Inn where she was charged with assault and battery.

#### **PUBLIC INTOXICATION**

Holy Cross Academy, 250 Stafford Lakes Parkway, a deputy responded to an intoxicated person call. The caller advised that a male left his baby in a stroller and the stroller fell over. When the male was confronted, he appeared intoxicated. The deputy made contact with the suspect, who advised he consumed two (2) beers. The mother of the children responded to take care of the kids; the suspect was charged with public intoxication and contributing to the delinquency of a minor.

#### **WEAPON OFFENSE**

England Run North Apartment Complex, a deputy was in the area when he observed three (3) males wearing face coverings. Given the recent crime in the area, the deputy was concerned by this and made contact with the three. The two juveniles removed their face coverings and were cooperative, while the 18-year-old did not. During their interaction, the deputy discovered the 18-year-old was carrying a concealed firearm that he got when he was a juvenile. The suspect was charged with carrying a concealed weapon, underage possession of a firearm, and felony wearing a mask in public. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.



## **BRAVO ZONE**

#### **BREAKING AND ENTERING**

Coventry Court, 4/14, a deputy responded to a breaking and entering. It was discovered an exboyfriend climbed through the victim's window and gained entry into her residence. When deputies arrived, he was located still in the residence. He was charged with unlawful entry.

#### DUI

Walmart, 125 Washington Square Plaza, a deputy responded to an unknown problem. The caller advised there was a driver in the parking lot who was passed out. When the deputy arrived, he discovered a pretty big clue that this would be a DUI, the driver had a half-consumed 1.5-liter bottle of alcohol in his lap. Upon further inspection, eight (8) other empty 1.5-liter bottles were located. The driver was charged with driving under the influence and held at Rappahannock Regional Jail on a \$2,500 secured bond.

Coventry Court, a deputy was on scene of a domestic when she observed a vehicle parked askew. The driver was still inside and had clear signs of intoxication. She advised she consumed "a lot" of wine before getting behind the wheel. She was charged with driving under the influence and was held at Rappahannock Regional Jail until sober.

Fas Mart, 620 Cambridge Street, a deputy was traveling on Cambridge street when he observed a vehicle traveling 78 MPH in a 45 MPH zone. He conducted a traffic stop and made contact with the driver, who had a bottle of alcohol next to him. The driver, who had signs of intoxication, admitted to consuming beer prior to driving in order to pick up his kids. He was charged with driving under the influence and speeding.

Woodford Drive, deputies responded to a hit and run. The victim had his parked unoccupied vehicle struck and damaged. Much like Hansel and Gretel, the deputies followed the trail of broken vehicle parts which led them directly to a suspect vehicle. The driver had signs of intoxication and admitted to consuming roughly four (4) shots. She was charged with driving under the influence with a blood alcohol content above .2, and hit and run. She was held at Rappahannock Regional Jail on a \$7,500 secured bond.

#### **LARCENY**

Walgreens, 50 White Oak Road, a deputy responded to a larceny. Staff advised they had video of a male suspect stealing over \$900 worth of items, including Plan B and Xyzal.

Meadow Drive, a deputy responded to a larceny. The juvenile victim advised his Air pods were stolen earlier in the day while at school. Using the power of technology, the victim was able to track the Air pods to a residence on Meadow Drive. While the juvenile suspect at the residence advised he didn't have them, he was wearing Air pods that automatically connected to the victim's phone. The deputy made contact with the suspect who turned over the stolen property. A criminal complaint for larceny was filed.

## **CHARLIE ZONE**



#### **PUBLIC INTOXICATION**

Stafford Hospital, 101 Hospital Center Boulevard, a deputy responded to an intoxicated person. Staff advised there was a female suspect who seemed rather intoxicated. The deputy made contact with the suspect and was able to confirm she was intoxicated. Not only did she have the classic signs of being intoxicated, but the suspect advised she was "pretty intoxicated." She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

#### DUI

Oak Drive, a deputy responded to an unknown problem. The caller advised there was a passed-out male behind the wheel. When the deputy arrived, he located the driver still napping in his running vehicle. After waking up, the driver advised he consumed three (3) beers approximately 30 minutes ago. After conducting field sobriety tests, the driver was charged with driving under the influence.

At the intersection of Richmond Highway and Coal Landing Road, a deputy was in the area when he observed a vehicle traveling 68 MPH in a 45 MPH zone. The deputy conducted a traffic stop and made contact with the driver, who had signs of intoxication. While the driver would at first deny consuming alcohol, he would later change his story. He was charged with driving under the influence, and reckless driving.

At the intersection of Brooke Road and Pocahontas Lane, a deputy responded to a single-vehicle accident. A Dodge Ram had too much "ram" and not enough "dodge" as it veered off the roadway. The driver had signs of intoxication and admitted to drinking two (2) beers before driving. He was charged with driving under the influence.

#### **LARCENY**

Genesis Logistics, 705 Bradburn Place, a deputy responded to a larceny. Two (2) staff members had their personal items stolen from a break room.

# **DELTA ZONE**

#### **LARCENY**

Walmart, 217 Garrisonville Road, a deputy responded to a larceny. Staff advised a male suspect stole approximately \$180 worth of items before peddling away on a mountain bike.

#### **WARRANT SERVED**

Fiddlers Court, a deputy responded to a warrant service. It was advised that a male suspect wanted out of Pennsylvania for felony money laundering decided to come and visit Stafford County. His stay would be extended. The deputy was able to locate him and take him into custody. He was charged with fugitive from justice and held at Rappahannock Regional Jail without bond.

#### **THREATS**

Short Branch Road, a deputy responded to threatening messages. The victims advised that they received threats of death after a disagreement over a Facebook Marketplace ad.

#### **ASSAULT**

Mountain View High School, a deputy was conducting his SRO duties when he was informed of an assault. Staff advised that they heard what they thought was a student being "jumped." Using camera footage, the deputy discovered two (2) students ganged up on another student and assaulted him. Criminal complaints for assault by mob were filed.

7-Eleven, 378 Garrisonville Road, a deputy responded to an angry customer. Staff advised a female suspect began cursing when there was a problem with her payment method. She would then toss cookies and spit on staff before leaving in a blue Nissan.

#### **BREAK AND ENTERING**

Harvest Green Court, deputies responded to a verbal disagreement between a juvenile couple. This disagreement ended when the male suspect was given his property back and was trespassed from the location. At 11:18 a.m. deputies responded back to the residence, for a breaking and entering. It was discovered the male suspect broke into the residence, assaulted the female victim, stole her phone, and damaged property. Deputies located the suspect still in the area with the victim's phone. Criminal complaints for breaking and entering with intent to commit a felony, trespassing, larceny, as well as, assault and battery were submitted. Juvenile Intake was contacted; however, refused to detain the suspect, so he was released to his mother.

#### DUI

Entrance ramp to Southbound I-95 from Westbound Garrisonville Road, a deputy was in the area when he heard what sounded like a vehicle driving on its rims. He would discover the source of the sound coming from a Toyota which indeed was traveling on a rim. The deputy made contact with the driver, who advised he was traveling from home to home. If the inconceivable sentence wasn't enough, the driver admitted to consuming alcohol prior to driving. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2.

# SCAM-AWARE

**Victim** was scammed by someone on Facebook Market Place. He reached out to a "Mike Martin", who claimed to be living in Alabama and selling a Ranger Bass Boat cover for \$300. The victim paid "Mike" \$150 via PayPal to an email of SpencerEugen123@jujjk.com. The victim began questioning things because "Mike" wanted him to send a screenshot of the payment to confirm he sent it. The victim began asking questions, and then "Mike" stopped all communications.

**Victim** said that on April 12th, 2024 at approximately 1728hrs she was contacted by phone number 888-842-6328 with the caller ID "Navy FCU" notifying her that there were multiple fraudulent transactions on her account. The caller was impersonating a Navy Federal Credit Union Fraud Investigator and told the victim that they were going to fix the fraudulent transactions and told her what she needed to do. The victim was instructed by the scammer to make a single \$5000 transaction and a \$4000 deposit to a "Tyshanna A. Alexander". The victim later received an email from Navy FCU saying that she was approved for a \$9000 loan and that she is to pay \$298.34 on the 23rd of every month. The victim realized this had been a scam and contacted Navy Federal only to discover that "Tyshanna Alexander" had been added as a 3rd Party to her account.

**Victim** received a phone call from a male claiming to be from PayPal fraud support. The individual claimed that her account was compromised and was showing a pending and approved transaction for an amount of \$499 on her account. The victim was given instructions over the phone to provide PID information, which was ultimately used by the scammer to gain access to her digital financial accounts. The caller signed into the victim's PayPal account, and through that, accessed her Wells Fargo Bank accounts.

**Victim** received phone calls on April 3rd, 4th, and 5th claiming she paid too much for a Geek Squad account. The victim told the caller she didn't have a Geek Squad account and they convinced her to create an account and provided them all of her information. In the three days of calls, the scammer convinced the victim to purchase gift cards that totaled \$21,200.00 and provided the scammers with the numbers on the back of the cards.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest.
