Fraud: SCAM: AMAZON: Victim received call from suspect claiming to be from Amazon. Advised victim her account had a fraudulent charge of \$1,500. Victim was transferred to a 'representative' from her bank. Victim provided bank account information in order to have money refunded. Victim became suspicious and contacted her back to freeze account, but a fraudulent transfer had occurred; loss of \$5,000.

2125 Mountain View Road Margaret Brent Elementary School

Larceny: Theft of traffic cone and sign from school property.

Lakebreeze Way Woods of Abel Lake 04/25/21

Larceny: Victim's cell phone account compromised. Phone service was transferred and bank account information obtained, resulting in the loss of \$4,500.
