# WEEKLY CRIME REPORT



**APRIL 21ST - APRIL 27TH, 2025** 

### **ALPHA ZONE**

#### DUI

Giant, 550 Celebrate Parkway, Deputies responded to an auto accident. The caller advised that a swerving Ford nearly struck pedestrians before crashing into another vehicle. The deputy made contact with the at-fault driver, who "honestly don't remember" what caused the crash. Signs of intoxication were observed, and field sobriety tests were conducted. Shortly after those tests, the driver was detained. She was charged with driving under the influence.

Area of Mountain View Road and Clover Hill, a deputy responded to a drunk driver complaint. The caller advised that a Lexus was stopped in the middle of the roadway. The deputy located the loitering Lexus and made contact with the driver, and stated she was just "hanging out." Given the signs of intoxication, field sobriety tests were conducted, and the driver was charged with driving under the influence, stopping on a highway, and refusal. She was held at Rappahannock Regional Jail on a \$3,000 secured bond.

#### **THREATS**

Rugby Road, a deputy responded to a disturbance. The victim advised that an unknown male was on their front porch. When confronted, the suspect began cursing and threatening to shoot the victim before leaving on a Fredericksburg Transit Bus. The incident was captured on camera, which the deputy used to identify the suspect, and warrants were obtained.

#### **ASSAULT**

America's Best Value Inn, 605 Warrenton Road, a deputy responded to an assault. The victim advised that an argument between a known male got heated when he assaulted her and attempted to strike her with his Mazda. Security cameras confirmed the incident, and a warrant for assault and battery was obtained.

#### **LARCENY**

Walmart, 11 Village Parkway, a deputy spent his Friday night dealing with a shoplifter. Staff advised that a male was switching price tags, which resulted in a nearly \$130 loss. The deputy made contact with the suspect and issued him a summons for shoplifting.



## **BRAVO ZONE**

#### **DRUGS**

Castle Rock Drive. Deputies conducted a traffic stop on a vehicle with no front license plate. During the traffic stop, it was discovered that the driver had a suspended license, and the 2025 registration sticker she had displayed was forged. In a fit of honesty, she would also admit to being in possession of a crack pipe. Suspected controlled substances were indeed located in her possession, and in the possession of the passenger. The driver was charged with possession of controlled substances, driving while suspended, and having a forged decal, and the passenger was charged with possession of controlled substances.

#### DUI

Cool Springs Road. Deputies responded to a suspicious vehicle report. The reporting party advised that an unknown vehicle was in his driveway and the driver seemed intoxicated. When deputies arrived, they located the driver asleep with the keys still in the ignition. After waking up, the driver displayed signs of intoxication and admitted to consuming "some beers." The suspended driver was charged with driving under the influence with a blood alcohol content greater than .2 and driving while suspended. He was held at Rappahannock Regional Jail without bond.

Wawa, 275 Butler Road, a deputy was in the area when a speeding Challenger caught his eye. As the deputy attempted a traffic stop, the passenger decided to have a prom-like moment by standing up through the sunroof and waving his arms in the air like he just didn't care. The deputy made contact with both occupants, who had signs of intoxication and admitted to consuming a few Jim Beam and Cokes. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, as well as speeding. The passenger was charged with public intoxication for his public display during the drive.

#### PUBLIC INTOXICATION

Little Whim Road, a deputy responded to an intoxicated person call. The caller advised that a known male was in an intoxicated state and on his way to steal more alcohol. The deputy located the stumbling suspect and made contact with him. Due to the signs of intoxication, he was charged with public intoxication and held at Rappahannock Regional Jail until sober.

#### WEAPON OFFENSE

Jett Street, a deputy responded to a disturbance. The caller advised that he observed a speedy Hyundai in a residential area and attempted to confront the driver. When he did, the passenger made threats to shoot him. The deputy located the Hyundai in question that was finishing up a DoorDash delivery and made contact with the occupants. It was discovered that the firearm was loaded and unsecured within the reach of three (3) children in the backseat. Both the driver and passenger were charged with carrying a concealed weapon and three (3) counts of contributing to the delinquency of a minor. The driver was released on personal recognizance while the passenger was held at Rappahannock Regional Jail on a \$2,000 secured bond

# **CHARLIE ZONE**

#### **ASSAULT**

Jay's Sport Lounge, 2866 Richmond Highway, a deputy responded to a fight between two (2) females in which pepper spray was involved. It was discovered that the victim took the suspect's keys to prevent her from driving intoxicated. In response, the suspect assaulted the victim and dragged her out of the establishment by her hair. In an act of self-defense, the victim pepper-sprayed the suspect. The suspect was charged with assault and battery, as well as public intoxication. She was held at Rappahannock Regional Jail without bond.

#### DUI

Wawa, 3099 Richmond Highway, a deputy responded to a "hysterical" driver in the area. The deputy was able to locate the suspect and made contact with her. The driver had signs of intoxication, admitted to consuming champagne, and believed she was in Hampton City. She was informed this was Stafford County and was charged with driving under the influence and refusal. She was held at Rappahannock Regional Jail without bond.

#### **FRAUD**

7-Eleven, 3623 Richmond Highway, a deputy responded to a reported fraud. Staff advised that a female suspect attempted to make a purchase with a counterfeit bill. When confronted, the suspect fled the area.

#### **THREATS**

Ford T. Humphrey Public Safety Building, 1225 Courthouse Road, a deputy was finishing an unrelated report when he was approached by a female regarding a threat report. The victim advised that an online boyfriend would not stop calling and texting her with threats on her life. The threats continued in the presence of the deputy. Warrants for threats of death, stalking, and annoying phone calls were obtained. A service request was sent to the local police department in Florida, which served the suspect on his warrants.

#### **PUBLIC INTOXICATION**

Cavalier Skating Center, deputies responded to a disturbance. Instead of skating the night away, one male was causing a scene. When the deputy arrived, the suspect began fleeing on foot; however, another deputy was able to block his path and detain him. The suspect had signs of intoxication, was very open about having consumed alcohol, and made derogatory remarks in the presence of other patrons. He was charged with public intoxication, disorderly conduct, and obstruction of justice. He was held at Rappahannock Regional Jail without bond.

Mega Auto Outlet, 3335 Richmond Highway, a deputy responded to a belligerent bargainer report. Staff advised that an intoxicated male was causing a disturbance when a transaction did not go his way. The deputy located the suspect across the street at another dealership and attempted to contact him. Instead, the suspect disregarded commands and fled the area. The deputy eventually located the suspect, who would attempt to hide in a nearby backyard. The suspect was charged with public intoxication and obstruction of justice. He was held at Rappahannock Regional Jail until sober.

## **DELTA ZONE**

#### **FRAUD**

Panera Bread, 1005 Stafford Market Place. Staff had two (2) males attempt to pay for an order with a fake \$100 bill. The bill was quickly discovered to be a fake, and the suspects quickly fled on foot. Luckily, a deputy was nearby for an unrelated call and located one of the suspects. While the suspect claimed he "doesn't even eat at Panera," video evidence proved otherwise. He was charged with 'conspiracy of uttering' and held at Rappahannock Regional Jail without bond. The other suspect has not yet been caught.

#### **LARCENY**

Shoppers, 1505 Stafford Market Place, a deputy responded to an alcohol theft. Staff advised that a repeat shoplifter stole two (2) bottles of wine before fleeing on his moped. The deputy located the suspect nearby, still on his moped and in possession of the stolen bottles. The bottles were returned to the business, and the suspect was charged with shoplifting. He was held at Rappahannock Regional Jail on a \$500 secured bond.

Kohl's, 1220 Stafford Market Place, a deputy responded to a larceny in progress. Staff advised that a known shoplifter was back at it, this time concealing items in the fitting room. The deputy located the suspect after he passed all points of sale with approximately \$355 worth of stolen items. The suspect was additionally discovered to be in possession of a burglary tool and connected to another larceny from the same location earlier this month. The suspect was charged with shoplifting and possession of burglary tools. He was held at Rappahannock Regional Jail without bond.

#### **PUBLIC INTOXICATION**

Kelly Way. Deputies responded to a disturbance. The victim advised that a neighbor threw items onto his property and urinated on a tree. The incident was captured on camera. While conversing with the victim, the suspect approached deputies in an intoxicated state, advising the victim that he was really an FBI agent spying on him, which was not factual at all. The suspect was charged with public intoxication, indecent exposure, littering, and vandalism. He was held at Rappahannock Regional Jail without bond.

#### **WARRANT SERVED**

Buffalo Moe's, 33 Wicomico Drive, a deputy responded to a disturbance. The caller advised that a male who was "talking crazy" was causing a scene. The deputy made contact with the suspect and discovered he was wanted out of South Carolina. The suspect was charged with fugitive from justice and held at Rappahannock Regional Jail without bond.

#### **VANDALISM**

Apricot Street, a deputy responded to a potential breaking and entering. The victim advised that while inside the residence, their front door was violently kicked in. While it was discovered that no entry was made into the residence, there was serious damage to the doorframe. A Ring doorbell camera captured the incident of a juvenile kicking in the door before quickly fleeing. A deputy located the suspect nearby, who admitted to the damages as a "prank." No one was laughing as a criminal complaint for vandalism was obtained.

## **SCAM REPORT**

**Victim** arrived at the Sheriff's Office because he had a bone to pick with "Captain Bone." A responding deputy made contact with the victim, who advised that this Captain informed him he missed jury duty and needed to pay to avoid being arrested. There is no Captain Bone with the Stafford County Sheriff's Office, and the victim was informed of the scam.
