

WEEKLY CRIME REPORT

ALPHA ZONE

PUBLIC INTOXICATION

America's Best Value Inn, 605 Warrenton Road, a deputy was on the scene of a 911 hang-up call when she heard a female yelling belligerently. The female was in an intoxicated state and advised deputies that she wanted to buy more alcohol. Considering this was not a good idea, the suspect was asked to stay in her room. Instead, as deputies were about to leave they observed the suspect again shouting towards Warrenton Road. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Super 8, 557 Warrenton Road, deputy responded to a disturbance. The caller advised that a female was yelling at a male. The deputy arrived on the scene and made contact with both parties. While the male was cooperative, the female was not. The female was intoxicated and screaming so violently that the deputies couldn't understand her, and wanted to fight the male. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

WARRANT SERVED

America's Best Value Inn, 605 Warrenton Road, a deputy was investigating a disturbance when she made contact with a male. The male provided an identity, which was reported stolen and used during crimes in other jurisdictions. The deputy identified the suspect as a wanted man out of Hanover County for felony probation violation. He was charged with providing a false identity to law enforcement, identity theft, and served on his outstanding warrant. He was held at Rappahannock Regional Jail on a \$4,500 secured bond.

DUI

America's Best Value Inn, 605 Warrenton Road, a deputy responded to a reckless driver complaint. The caller advised that a gray F-150 was driving all over the road and provided the deputy with live updates on the vehicle's whereabouts. The deputy arrived just in time to observe the suspect vehicle cross four (4) lanes of Warrenton Road and make an abrupt U-turn without using a turn signal. The deputy conducted a traffic stop and made contact with the driver. The driver assured the deputy that he was driving "normally" to get to the beach. He was informed that this was Stafford County and not Virginia Beach. The driver had signs of intoxication and an empty alcoholic bottle near him. His beach trip was put on hold and he was charged with driving under the influence and failure to properly signal. He was held at Rappahannock Regional Jail on a \$3,500 secured bond.

LARCENY

Excaliber Circle, deputies responded to a larceny. The victim advised she owns a Camaro, but it was not where she had left it. The parking space now contained shattered glass and broken pieces of a cinder block. The vehicle was entered as stolen into a law enforcement database.

BRAVO ZONE

ASSAULT

James Madison Circle, a deputy responded to an assault. It was discovered an adult student assaulted a juvenile student immediately after they exited the bus. While conversing with the victim, the suspect returned to the scene and informed the deputy of his transgression. He was arrested for assault and battery and was released by the magistrate on personal recognizance.

Stafford High School, 63 Stafford Indians Lane, a deputy was conducting his SRO duties when he was informed of a fight. Instead of having a normal game of volleyball, two (2) students decided to fight. A criminal complaint for assault and battery will be filed for student #1, while a warrant for assault and battery will be filed for student #2, an 18-year-old.

ARSON

Stafford High School 63 Stafford Indians Lane, a deputy was conducting his SRO duties when he was informed of a fire. A paper towel dispenser in the boy's bathroom was on fire. Fire Marshall responded and determined that the fire was intentionally set. The suspected student was found in possession of a lighter and vapes. Criminal complaints for the arson and underage possession of tobacco are pending.

DRUGS

Stafford High School, 63 Stafford Indians Lane, a deputy was conducting his SRO duties when he was informed of a bathroom party. Staff was advised that the bathroom smelled like marijuana. During an administration search, a student was discovered to be in possession of seven (7) THC vapes and a tobacco vape. Another student was discovered to be in possession of four (4) tobacco vapes. The contraband was seized. Student #1 received criminal complaints for possession of marijuana on school property and underage possession of tobacco while student #2 received a criminal complaint for underage possession of tobacco.



CHARLIE ZONE



PUBLIC INTOXICATION

Jessica Cheney Bridge, a deputy responded to a suspicious person. Multiple people reported a man walking across the bridge acting "strange." When the deputy arrived, he discovered the "strange" behavior was determined to be intoxication. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Jay's Sports Lounge, 2866 Richmond Highway, deputies responded to a disturbance. It was advised that there was a large group outside the business and a male and female were fighting. When deputies arrived, they made contact with the husband and wife involved. While a physical lovers quarrel was denied, neither one could deny their level of intoxication. The love birds were charged with public intoxication and held at Rappahannock Regional Jail until sober.

DISTURBANCE

Pilot Knob Loop, deputies responded to a neighbor dispute. While attempting to de-escalate the situation, a male suspect would continue to yell at other parties, refuse commands, and push against a deputy. The situation was finally defused after the suspect was detained. He was charged with disorderly conduct and released by the magistrate on personal recognizance.

DRUGS

Brooke Point High School, 1700 Courthouse Road, deputy was conducting his SRO duties when he was informed of drug activity. A student was under the influence in the nurse's office. It was discovered that the student received the THC vape pen from another student. When staff located the other student, she attempted to pass off the vape to a friend. The pass was fumbled, and the deputy submitted a criminal complaint for possession of marijuana on school grounds.

DELTA ZONE

VANDALISM

Garrison Woods, a deputy responded to a vandalism. The victim advised that her door knob was broken two days ago by someone she believed was attempting to enter her residence.

ASSAULT

Starbucks, 1495 Stafford Market Place. Sheriff's Office's "Badges and Barbeque" event was cut short due to a disturbance with a weapon down the street. The victim advised while he was dealing with an auto accident in the parking lot, an unknown male pulled a knife on him. A deputy located the suspect vehicle in the area of Richmond Highway and Foreston Woods Drive and conducted a traffic stop. The driver, who was on his way to court, was found in possession of a knife. He was charged with simple assault and held at Rappahannock Regional Jail.

DRUGS

North Stafford High School, 839 Garrisonville Road, a deputy was conducting his SRO duties when he was informed of two (2) separate drug activities. In each case, a student walked into a bathroom and observed a student doing something they weren't supposed to. Each student was found to be in possession of a THC vape and both received a criminal complaint for possession of marijuana on school grounds.

LARCENY

Lowe's, 1330 Stafford Market Place, deputy responded to a larceny. The victim advised that his phone was stolen from his vehicle while he was inside the store.

Walmart, 217 Garrisonville Road, a deputy responded to an apologetic culprit. Staff advised that they observed a male attempting to hide items in his backpack, including cocoa butter. The cocoa butter bandit was cocoa caught with nearly \$60 worth of concealed items. The suspect would realize the error in his transgression and write an apology letter to Walmart. As sweet as his letter was, he was still charged with shoplifting and released on his summons.

PUBLIC INTOXICATION

Garrison Woods, a deputy responded to a disturbance. The caller advised there were people being disorderly. When the deputy arrived, he observed a female nearly fall over due to her level of intoxication. The deputy informed the suspect, who he knew from previous incidents, that she needed to go inside her residence or she would be charged. The suspect complied and entered her residence. The deputy would then circle the block and when he returned, observed the suspect outside again, now littering. She was charged with public intoxication and littering. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.

WARRANT SERVED

Brixham Court, deputies responded to a residence in an attempt to serve a warrant. The suspect was wanted out of Stafford County for possession of controlled substances charges. Deputies were able to make contact with the suspect still in his pajamas and took him into custody without incident. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

SCAM-AWARE

Victim received an email from a realtor stating someone was attempting to sell a piece of land owned by the victim. The realtor had received a "new lead" email from Zillow. The email was from someone claiming to be the owner of the property, and it read "Hey, I have a vacant lot at 502 Jett St, Fredericksburg, VA 22405. I want to sell it, can you help out? Please give me a call when you get this. Thanks". The realtor felt it was a possible scam and contacted the victim alerting her to this situation. No loss was sustained.
