ALPHA ZONE



THREATS

Noble Court, a deputy responded to a "threats" call. The victim advised he received threatening messages through Instagram by a known party. Warrants are pending.



BRAVO ZONE

DUI

Wawa, 860 Richmond Highway, a deputy was traveling on Richmond Highway when she observed a vehicle swerving and deputies conducted a traffic stop. The driver had clear signs of intoxication, including the strong odor of an alcoholic beverage coming from his breath that could be detected from a" social-distancing" distance away. It would be discovered this was not the driver's first rodeo. The driver was charged with driving under the influence second offense within ten years, and refusal. He was held at Rappahannock Regional Jail without bond.

FRAUD

Dawson Drive, a deputy responded to a fraud. The victim advised she made plans with the suspect on Facebook to sell a play mat. The suspect arrived at the victim's residence and paid with a counterfeit bill.

TRAFFIC OFFENSE

Kings Highway, a deputy responded to a road-rage incident. The victim advised that after passing a driver, that the driver got angry and threw something at his vehicle. The deputy was able to identify the suspect and made contact with him. After a bit of back and forth, the suspect admitted to throwing a water bottle at the victim. A warrant for throwing missiles at an occupied vehicle was submitted.

ASSAULT

Foxchase Boulevard, a deputy responded to a disturbance. The victim advised his ex-girlfriend's sister entered his residence and during their verbal disagreement, the suspect displayed garden shears. She was charged with unlawful entry and assault. She was issued permitted warrants.

DUI

At the intersection of Warrenton Road and Cambridge Street, a deputy responded to an unknown problem. The caller advised there was a driver asleep behind the wheel. When the deputy arrived, he located the slumbering suspect still snoozing softly. When the suspect's beauty rest was complete, the deputy observed several signs of intoxication. He would also not have a driver's license. The suspect was charged with driving under the influence with a blood alcohol content between .15 and .2, as well as, driving without a driver's license. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.





CHARLIE ZONE

VANDALISM

Genesis Logistics, a deputy once again responded to the business, this time for vandalism. An employee advised that one (1) of his tires had been slashed.

Pohanka Nissan, a deputy responded to a vandalism. Multiple "No Parking" signs were pulled from the ground and several vehicles had been sprayed with a fire extinguisher.

WARRANT SERVED

Paradise Court, a deputy responded to trouble in paradise. The caller advised that two (2) females were verbally arguing. The deputy made contact with one of the females involved who was discovered to be wanted out of Stafford County for 3rd offense assault. She was taken into custody and was discovered to be in possession of paraphernalia. The suspect was taken out of "paradise" and placed into Rappahannock Regional Jail where she was charged with possession of paraphernalia and served on her outstanding warrant.

LARCENY

Wawa, 3099 Richmond Highway, a deputy responded to a larceny. Aquia Harbour Police Officers advised that staff informed them a suspect just walked out with a case of beer. The suspect was located with the unopened box of booze in an intoxicated state. He was charged with larceny and public intoxication. He was held at Rappahannock Regional Jail until sober.

ASSAULT

Chick-fil-A, 30 Wyche Road, a deputy responded to an angry customer report. Staff advised that a male was aggressive when he claimed his order was incorrect and threw an unknown liquid onto an employee. Using camera footage of the incident, a person of interest was identified.

BURGLARY

Trek, 2773 Richmond Highway, deputies responded to a business alarm. Upon arrival, they discovered the front door was shattered and a bike worth approximately \$5,500 was stolen.

DUI

At the intersection of Richmond Highway and Landmark Drive, deputies responded to a drunk driver complaint. The caller advised that a vehicle was traveling in the opposite direction of travel. Deputies would confirm this when they observed the Ford traveling Southbound in the Northbound lanes. A traffic stop was conducted and contact was made with the 34-year-old driver. The driver must have started his Cinco De Mayo celebration early for he had clear signs of intoxication, an open Modelo in the center console, and admitted to consuming 12 beers before driving from DC. The driver also had no driver's license. He was charged with driving under the influence, drinking while driving, failure to drive on the right side of the road, and driving without a license. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

WEAPON OFFENSE

White Pine Circle, deputies responded to a shooting. A resident advised that they located a bullet hole in their residence. Luckily, no injuries were reported. The investigation is ongoing.

DELTA ZONE

ASSAULT

Grosvenor Lane, a deputy responded to an assault. A female caller advised that she had been assaulted by her romantic partner as she slept. The deputy discovered this was not the case. It was discovered the female assaulted her partner and a roommate, poured bleach over their personal belongings, and made up her lie because it was "funny." She was not laughing when she was charged with two (2) counts of assault and battery, two (2) counts of property damages, and providing a false report to police. She was held at Rappahannock Regional Jail on a \$2,500 secured bond.

DUI

Sheetz, 1175 Garrisonville Road, deputies responded to a disturbance. Two (2) parties got into a verbal argument and the male suspect, who was reported to be intoxicated, drove from the scene. Deputies located the suspect vehicle at the business and made contact with the driver. The driver had clear signs of intoxication and this was not his first rodeo either. He was charged with driving under the influence 2nd offense within 5 to 10 years, and 2nd offense refusal. He was held at Rappahannock Regional Jail without bond.

LARCENY

Kohl's, 1220 Stafford Market Place, a deputy responded to another Kohl's shoplifting. Two (2) suspects were seen stealing nearly \$3,000 worth of items. Staff also advised the same suspects were seen shoplifting from another Kohl's in Prince William County.

PUBLIC INTOXICATION

Spring Lake Drive, a deputy responded to a suspicious person call. Multiple callers advised there was an unknown female attempting to enter multiple vehicles. The deputy made contact with the suspect who had signs of intoxication. While conversing with the deputy, the suspect attempted to enter another vehicle that did not belong to her because the deputies' "partner" told her to do so. While K-9 Ruby can do some amazing things, speaking is not one of them. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

TRESPASS

Shumate Lane, a deputy responded to a trespassing call. Despite multiple "no trespassing" signs and barbed wire fencing, a male entered onto the victim's property. The incident was captured on camera. Deputies located the suspect who advised he "could not resist" the beautiful sights of nature on the victim's property. Deputies also could not resist placing him in handcuffs when they discovered he was wanted for felony destruction of property. He was charged with trespassing and served on his outstanding warrant. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

HIT AND RUN

Buffalo Moe's, 33 Wicomico Drive, a deputy responded to a hit and run. Witnesses advised a Jeep attempted to back out of a parking space when it struck an unoccupied vehicle twice before fleeing from the scene. The Jeep and its owner were later located by deputies. The driver had a revoked license. He was charged with hit and run, as well as, driving with a revoked license. He was held at Rappahannock Regional Jail on an unsecured bond.

SCAM-AWARE

Victim, a nurse, was contacted by someone claiming they're an officer with the law enforcement branch of the Board of Nursing. This individual stated that several fentanyl pills had just been intercepted crossing into the U.S., they had the victim's name associated with them, and she needed to cooperate with the investigation or lose her license. This individual continued to advise the victim that she can't share this information with anyone, at home or work, since all of her fellow employees are being investigated as well. Likewise, her nursing license would be secretly suspended until this process was completed. The caller demanded that the victim provide a copy of her driver's license and she complied by sending her DL number as well as a photo of her license. Later that evening, the victim thought harder about the situation, realizing she had been scammed, and contacted the Sheriff's Office.
