


# Stafford County Sheriffs Office

## WEEKLY CRIME REPORT



**APRIL 7TH - APRIL 13TH, 2025** 

## **ALPHA ZONE**

#### **ASSAULT**

Domino's 840 Warrenton Road, deputy responded in "thirty minutes or less" to a saucy situation. It was discovered that a "meat lover" wasn't exactly a staff lover when he assaulted an employee after a supreme disagreement. The suspect was identified and a warrant for assault and battery was obtained.

#### WARRANT SERVED

America's Best Value Inn, 605 Warrenton Road, deputies responded to a disturbance. It was advised that unregistered guests wanted to extend their unwelcome stay. While dealing with the situation at hand, it was discovered that one of the guests was wanted out of Stafford for a capias. She was detained and transported to Rappahannock Regional Jail. She was held without bond.



## **BRAVO ZONE**

#### **WARRANT SERVED**

White Oak Road, a deputy responded to a disturbance. The caller was having an issue with his mechanic. It was discovered he would have a bigger issue to deal with when it was discovered that the caller was wanted out of Maryland for a capias. The wanted suspect was charged with fugitive from justice and held at Rappahannock Regional Jail without bond.

#### **LARCENY**

Walmart, 125 Washington Square Plaza, a deputy responded to a larceny. Staff advised a female wearing a Mountain Dew jacket was doing more than just the dew. She was in the progress of concealing items. The deputy stopped the suspect after she passed all points of sale and detained her. The mountain of stolen items totaled over \$560. She was issued a summons for larceny.

#### **ASSAULT**

Belle Plains Road, a deputy wasn't even on the clock yet when he was flagged down for an assault. The victim, an Instacart delivery driver, advised that she attempted to drop off a delivery. While doing so, the intoxicated consumer assaulted the victim and attempted to take the alcohol by force. The deputy made his way to the suspect's residence, where he located the intoxicated female in the process of getting behind the wheel. The deputy quickly stopped and detained the suspect. She was charged with assault and battery, as well as public intoxication. She was held at Rappahannock Regional Jail without bond.

#### **DUI**

Area of Warrenton Road and Cambridge Street, deputies responded to an "erratic" driver complaint. The caller advised that a Nissan nearly struck several vehicles, hit a curb, and almost ran off the road. The caller would later provide video of the poor driving behavior. Deputies located the now speeding vehicle and conducted a traffic stop. The driver had signs of being under the influence and two children in the backseat. The children were safely handed over to a responsible party as the driver was charged with driving under the influence, two counts of contributing to the delinquency of a minor, and reckless driving. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

#### TRAFFIC OFFENSE

Area of Ferry Road and Kings Highway, a deputy responded to an auto accident. A box truck and service truck had an abrupt meeting at the intersection. While investigating the crash, it was discovered that the box truck driver had a revoked license and three (3) prior driving while revoked convictions. He was charged with driving after forfeiture of his license and driving while revoked. He was held at Rappahannock Regional Jail on a \$10,000 secured bond.

## **CHARLIE ZONE**

#### **ASSAULT**

Pilot Knob Loop, deputy responded to an assault. A mother brought her juvenile children to the victim's residence to continue a fight that occurred earlier. During the altercation, the mother followed one of the juvenile victims into the residence and assaulted her. The assault was stopped by a witness. The mother was charged with assault and battery, assault by mob, unlawful entry, and contributing to the delinquency of a minor.

Man-of-War Boxing and Fitness Academy, 2769 Richmond Highway, deputy responded to an assault. The victim advised that while in the parking lot, her ex came out of nowhere and entered her vehicle. This resulted in a verbal altercation that escalated when the suspect assaulted the victim. The victim was able to fight off her attacker and drive off. Warrants for assault and battery, as well as unlawful entry of a vehicle, were obtained.

#### **FRAUD**

Wawa, 72 Austin Park Drive, deputy responded to a fraud report. The victim advised that she had left the business without her debit card. Moments later, she received notification of fraudulent charges; the victim froze her accounts. Camera footage captured two suspects using the card, and the deputy sent pictures of the suspects to his squad mates, who were able to identify the suspects. Warrants are pending.

#### **WEAPON OFFENSE**

Brooke Road, 4/9, 9:51 p.m., a deputy responded to a shooting. The victims had their television shot. Luckily, no one was injured during the 3-D John Wick experience. It was discovered that the bullet could have potentially come from the roadway.

#### **LARCENY**

Target, 1090 Stafford Market Place, a deputy responded to a larceny. Staff advised two (2) males were concealing items, including Pokémon cards. The deputy was able to catch them and recover over \$260 worth of items.

#### WARRANT SERVED

Rappahannock Regional Jail, 1745 Richmond Highway, a deputy responded to a warrant service. The male in question was wanted for a pretrial violation. He was detained, and the deputy inquired if he had anything on him that he shouldn't. the suspect advised "just my weed," however, during a strip search, much more than just a leafy substance was located. He was served on his outstanding warrant and additionally charged with two (2) counts of possession of a controlled substance, and a prisoner in possession of unlawful chemicals. He was held without bond.

## **DELTA ZONE**

#### **LARCENY**

Wawa, 105 Garrisonville Road, a deputy responded to a report of some snacking suspects. Staff advised two male suspects, who appeared to be juveniles, stole a number of tasty goods.

Walmart, 217 Garrisonville Road, a deputy responded to a larceny. While the Ninja Creami is all the rage these days, a male and female pair decided to join the craze by stealing one.

Devilwood Way, a deputy responded to a disturbance. It was advised that one of the victim's vehicles had its window broken out while the other was stolen. Luckily, a nearby home security camera captured the entire ordeal. Using the video, the deputy was able to identify the suspect. The vehicle was entered as stolen into a law enforcement database, and warrants were obtained.

#### **THREATS**


North Stafford High School, a deputy was conducting his SRO duties when he was informed of a threat report. A student received messages from another student inquiring if he wanted to buy weed. When the student declined the offer, the suspect made threats. The deputy, along with staff, made contact with the student and discovered he did have an alcoholic beverage in his possession. Criminal complaints for threats of death and underage possession of alcohol on school grounds were submitted.



## **SCAM REPORT**

**Victim** received a pop-up message on her iPad stating it had been compromised. The pop-up message provided a phone number to call. A male identified himself as "Davis" and explained he was attempting to find the individual responsible for compromising the victim's iPad. "Davis" further explained the victim would need to go to a Capital One Bank and withdraw enough money to lower her balance. The victim complied with these instructions and withdrew \$28,000 from her Capital One bank account and deposited it into a Bitcoin ATM. The victim was then instructed to go to a secondary Capital One Bank to withdraw even more cash to deposit into the Bitcoin ATM. It was during this attempt that the victim began to question "Davis" and did not withdraw any more money from her bank account and disconnected from the call, and reported the fraud to the Sheriff's Office.
