WEEKLY CRIME REPORT

ALPHA ZONE

DUI

Tires & Wheels Unlimited, 289 Warrenton Road, deputy was traveling on Warrenton Road when a vehicle in front of him drifted into another lane, nearly striking another vehicle. The deputy conducted a traffic stop as an additional deputy responded to assist. As the driver rolled down his window to chat with deputies, a large cloud of smoke came flying out. While the driver advised he was "fine," based on his driving behavior and signs of intoxication, deputies knew otherwise. He was charged with driving under the influence and held at Rappahannock Regional Jail on a \$2,000 secured bond.

Manor at England Run Apartments. Multiple deputies responded to multiple reports of vehicle break ins. The victims had a window of their vehicle broken and items including wallets and purses stolen.

DUI

IHOP, 10 Simpson Road, deputies observed a vehicle that had been reported to be connected to a disturbance, but also had an expired registration. Deputies conducted a traffic stop and made contact with the driver. While the disturbance report was unfounded, deputies did find several signs of intoxication coming from the driver. He advised he had six (6) whiskey and coke drinks at the Bearded Monkey prior to driving. The driver was charged with driving under the influence, refusal, and the expired registration. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

At the intersection of Warrenton Road and Olde Forge Drive, a deputy was in the parking lot of Mr. B's when a Dodge Charger approached the parking lot. When the driver saw the deputy, he quickly stopped, reversed, and blew by a stop sign getting back onto Warrenton Road. The deputy conducted a traffic stop and the driver not only had noticeable signs of being under the influence, but a concealed firearm. He was charged with driving under the influence, refusal, and carrying a concealed firearm. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

DRUGS

Cynthias Place, a deputy was dodging dangerous drugs. While on scene for a domestic, a deputy observed suspected controlled substances in plain view that belonged to two others within the residence. Those two were detained and the substances were collected. Both were charged with possession of controlled substances and held at Rappahannock Regional Jail without bond.

PUBLIC INTOXICATION

Sanford Drive, a deputy observed a street sleeper. A caller advised there was a male lying in the roadway. The deputy arrived to discover the suspect still lying in the street. He had clear signs of intoxication and admitted to consuming alcohol. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

WARRANT SERVED

Quarry Road, a deputy responded to serve a criminal's capias. The Fredericksburg Police Department advised a male wanted for a capias was at this location. The deputy was able to quickly locate the suspect and located suspected controlled substances on the suspect's person. The suspect was charged with possession of controlled substances, possession of paraphernalia, and served on his outstanding warrant. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

BRAVO ZONE

DUI

At the intersection of Cambridge Street and Manning Drive, a deputy was traveling on Richmond Highway when he observed a drifting driver. The deputy conducted a traffic stop and made contact with the driver. The driver had signs of intoxication and advised "I'm not going to lie to you, I had two glasses of beer." While honesty is appreciated, so is sober driving. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, and the traffic lane violation. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Wawa, 275 Butler Road, deputy stopped a lit lady. A deputy with the Spotsylvania County Sheriff's Office advised he was driving behind a vehicle that was traveling in the middle of two lanes with no lights on. The deputy made contact with the driver at Wawa who advised her lights do not work. With that being said, she somehow was able to make them work again in the deputy's presence. She had signs of intoxication and it was discovered this was not her first DUI. She was charged with driving under the influence 2nd offense within five to ten years, and the traffic lane violation. She was held at Rappahannock Regional Jail on a \$3,500 secured bond.

THREATS

Little Whim Road, a deputy responded to a threat call. It was discovered a juvenile made threats to kill her mother, uncle, and dog when they fell asleep. Due to the seriousness of the threats, the juvenile was detained at the Juvenile Detention Center. Criminal complaints for two (2) counts of threats of death were submitted.

WARRANT SERVED

Midnight Express, 47 Cool Spring Road, a deputy responded to a warrant service. A detective from Pennsylvania advised a female suspect who was wanted for felony money laundering was at the business. The deputy made contact with the suspect and detained her without incident. It was discovered she was in possession of a fake Maryland driver's license, and her vehicle at this location was bought using a fake name. She was charged with identity theft, identity theft with intent to defraud, and fugitive from justice. She was held at Rappahannock Regional Jail without bond.

Walmart, 125 Washington Square Plaza, Deputies with the Special Problems Unit discovered the whereabouts of a wanted suspect. The suspect was wanted for possession of controlled substances. Deputies conducted a traffic stop on the vehicle he was in and detained him without incident. During a search incident to arrest, suspected controlled substances were located. He was served on his outstanding warrant and additionally charged with possession with intent to distribute controlled substances. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

Kings Highway, a deputy observed a vehicle traveling 73 MPH in a 55 MPH zone. She conducted a traffic stop and made contact with the driver. It was discovered the driver was wanted out of Maryland for burglary, assault, and destruction of property. The driver was not only issued a summons for speeding, but he was charged with fugitive from justice. He was held at Rappahannock Regional Jail without bond.

CHARLIE ZONE

LARCENY

7-Eleven, 3623 Richmond Highway, a deputy responded to a larceny. The victim advised while tending to a flat tire, the suspect stole his iPhone. When the victim called his phone, the suspect answered and refused to give the phone back. The suspect would be found skating on a skateboard down Richmond Highway. He was arrested for grand larceny and held at Rappahannock Regional Jail without bond. The phone was recovered.

Target, 1090 Stafford Market Place, a deputy responded to a tactical tulip takeover. Staff advised a male suspect was currently stealing nearly \$400 worth of items. In an attempt to fool staff, the suspect would change his clothes in the store before leaving. Luckily, the bright flower bouquet he took made it easy for the deputy to locate him nearby.

ASSAULT

Stafford High School, 63 Stafford Indians lane, a deputy was conducting his SRO duties when he was informed of an assault. This victim advised he was assaulted as soon as he arrived at school. The suspect admitted to the assault due to an incident four years ago. She received a criminal complaint for assault and battery.

TRESPASS

Brent Point Road, a deputy responded to a trespassing. The victim advised an ex-romantic partner, who was already formally trespassed, unlawfully entered the residence and was refusing to leave. Due to prior incidents, the deputy knew the suspect and that knew she was wanted out of Stafford County for breaking and entering, destruction of property, as well as, assault and battery. The suspect was located still on the property and was taken into custody. She was served on her outstanding warrants and additionally charged with trespassing. She was held at Rappahannock Regional Jail without bond.

ASSAULT

Drew Middle School, 501 Cambridge Street, a deputy was conducting her SRO duties when she was informed of a bathroom brawl. It was discovered one female student assaulted another female student after allegations of name calling. The predominant aggressor was also discovered to be in possession of a THC vape. Criminal complaints are pending.

DUI

7-Eleven, 2998 Richmond Highway, a deputy located a fainted Fireball fan. Callers advised there was a male passed out behind the wheel. When the deputy made contact with the driver, she noticed signs of intoxication, as well as, a nearly completely consumed bottle of Fireball. The driver, despite admitting he lives in Maryland, advised his home was "just up the street." He was educated that this is Stafford County and not Maryland before being placed in handcuffs. He was charged with driving under the influence and refusal.

WEAPON OFFENSE

At the intersection of Richmond Highway and Hospital Center Boulevard, a deputy responded to a risky rapping rider. The caller advised while driving in the area a male driver was "waving" around what appeared to be a firearm while following along to a rap song. It was advised the Lil Wayne wannabe was driving a gray Toyota Camry.

DELTA ZONE

ASSAULT

North Stafford High School, a deputy was conducting his SRO duties when he heard a fight in progress in the gym. With the help of school staff, the deputy was able to separate the two female students. It was discovered the mutual combat was over arguments on social media. Both received a criminal complaint for assault and battery.

Democracy Circle, several deputies responded to an assault. The victim advised she was assaulted by a known male suspect during an argument. During the assault, the victim advised the suspect hit her using his firearm. The suspect was charged with assault and battery. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Target, 1090 Stafford Market Place, a deputy dealt with a powerful parking problem. The victim advised he was assaulted by a female suspect after they engaged in a verbal argument over parking issues. The suspect was located and issued a permitted warrant for assault and battery.

LARCENY

7-Eleven, 201 Garrisonville Road, a deputy responded to a report of Corona criminals. Staff advised two males stole two (2) cases of Corona before leaving in a white Toyota truck.

DUI

At the intersection of Mine Road and Cathedral Lane, a deputy responded to a single-vehicle accident. A witness advised the driver was traveling in an "erratic" manner, nearly struck another vehicle before striking the center median and getting stuck. The witness also advised the driver appeared "woozy." The deputy made contact with the driver, who displayed signs of intoxication. She would admit to consuming ten (10) different medications prior to driving. After conducting field sobriety tests, she was charged with driving under the influence and the traffic lane violation.

PUBLIC INTOXICATION

Autumn Ridge Park, 900 Eustace Road, deputies responded to a disturbance. The caller advised there was yelling at the park. When deputies arrived, they located three (3) intoxicated people, two of which were underage. All three were charged with public intoxication, and the 23-year-old who provided the alcohol was additionally charged with alcohol purchase for persons under 21.

Shoppers, 1505 Stafford Market Place, a deputy responded to a disturbance. The caller advised there was a male suspect yelling in the bathroom. The deputy discovered the yeller still yelling in an intoxicated state. While being arrested, deputies located nearly 30 suspected fentanyl pills. He was charged with public intoxication and possession of controlled substances. He was held at Rappahannock Regional Jail on a \$1,000 secured bond.

WARRANT SERVED

Evans Lane, a deputy observed a suspicious person in the area. This person was discovered to be wanted out of Stafford County for a felony capias. Despite actively resisting, the deputy was able to detain the suspect. During his free trip to see the magistrate, the suspect would consume a substance he had hidden on his person. The suspect was served on his outstanding warrant, as well as, two (2) counts of obstruction of justice. He was held at Rappahannock Regional Jail without bond.

SCAM-AWARE

Victim advised that she saw a listing for a townhouse on Facebook and engaged the seller. The seller requested money for fees and provided a lease. When the victim arrived to move in, the leasing office had no record of her, and it was discovered to be a scam.

Victim contacted a business on Facebook called "Patrick Puppy's Spot", to buy a puppy. She then provided the contact person, who identified himself as "Patrick", her phone number and they began to communicate through text. She then provided "Patrick's" phone number, 541-210-5975. Patrick advised her it would cost \$500.00 for the puppy plus an additional \$200.00 for other fees. She then transferred the money to another number using Apple Pay. After a few days, she received a text from another number advising identifying themselves as the delivery company and that she needed to provide a delivery fee of \$300.00. When they asked her this she believed she had been a victim of a scam and told them she no longer wanted the puppy and that she was going to report the incident to the police.

Victim said that one of his friends on Facebook had made a post selling a 2002 Honda Accord. He said that he was interested in purchasing the car from "his friend", and "his friend" stated he needed to pay money to "hold" the car for him because of other multiple buyers wanting to see the car. The victim paid \$300 to a CashApp account with the username "\$larondaMay".

The victim then received an email from the same friend stating his account had been hacked, and the victim realized he had been scammed.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest.
