ALPHA ZONE

PUBLIC INTOXICATION

Fitness 1440, 570 Celebrate Parkway, deputy responded to an out-of-this-world call. The caller advised there was a male in the parking lot who appeared "stressed" and acting like he was being arrested. The deputy made contact with the suspect, who advised he took cocaine that transported him to "another planet." The suspect further advised he had a hallucination earlier in which he took drugs and deputies arrested him. After being given consent to search the suspect's vehicle, deputies fulfilled that prophecy after locating suspected controlled substances. The suspect was charged with public intoxication, possession of controlled substances, and possession of paraphernalia.

LARCENY

Tobacco City, 754 Warrenton Road, deputy responded to a larceny. Staff advised a male suspect grabbed nearly \$160 worth of CBD products. He was last seen running towards England Run

PURSUIT

Warrenton Road and McLane Drive, a deputy observed a vehicle with expired registration and attempted to conduct a traffic stop. The driver instead accelerated towards Southbound I–95, kicking off a pursuit. Due to the dangerous driving behavior of the suspect, the pursuit was called off at the county line; however, Virginia State Police were notified of the transgression. They would locate, pursue, and detain the driver in King William County. Warrants for felony eluding and driving while suspended were submitted.



BRAVO ZONE

LARCENY

Windsor Ridge Court, deputy responded to a larceny. The victim advised he received notification his new cell phone was delivered; however, when he returned home, he discovered the package was stolen from his front porch.

Duff Green Park, deputy responded to multiple vehicle break-ins. Three (3) vehicles were broken into and numerous items were taken, including credit cards. We encourage residents to remove valuables from their unattended vehicles.

Pratt Park, deputy responded to a vehicle break-in. The victim had a window of her vehicle broken and her purse stolen. Later into her shift, the deputy received a call from a Sergeant in Maryland who recovered the purse.

DUI

Forbes Street, deputy responded to a single-vehicle auto accident. A vehicle struck a brick wall. The caller further advised the driver appeared intoxicated and admitted to having drugs on her person. The deputy made contact with the driver who stated she "messed up." She had signs of intoxication and suspected controlled substances were located. She was charged with driving under the influence 2nd offense within five years, possession of controlled substances, and driving while revoked. She was held at Rappahannock Regional Jail without bond.

Intersection of Kings Highway and Cool Springs Road, deputy responded to a drunk driver complaint. The deputy made contact with the driver who had signs of intoxication, admitted to consuming "three beers" before driving, and had two (2) children within the vehicle. He was charged with driving under the influence with a child present.

PUBLIC INTOXICATION

Falmouth Beach, deputy responded to a public intoxication call. Despite being a no-alcohol area, once again a suspect was discovered to be intoxicated. The suspect's White Claws earned him a charge of public intoxication.

PURSUIT

Wawa, 275 Butler Road, deputy attempted to make contact with the driver of an Acura when the driver suddenly drove off, kicking off a pursuit. The pursuit continued onto Warrenton Road, then Northbound I-95 where additional deputies joined in the pursuit. Due to the dangerous driving behavior of the suspect, the pursuit was called off in the area of Centreport Parkway. The investigation is ongoing.

VANDALISM

Duff Green Park, deputy responded to a sticky situation. It was advised an unknown male poured "a cup of pee" into the victim's vehicle. Upon investigation, the liquid was determined to be alcohol and not bodily fluids; the suspect has yet to be identified.


CHARLIE ZONE

DUI

2800 block of Richmond Highway, a deputy responded to a drunk driver complaint. The caller advised a Nissan was swerving. The deputy would observe the speeding, swerving suspect and conduct a traffic stop. The driver had signs of intoxication and advised he consumed "I bottle" of wine before driving. He would later change his answer to a smaller magnitude, claiming only "I glass." With one glass or one bottle, the suspect was still driving intoxicated. He was charged with driving under the influence and failure to maintain the lane of travel.

Wawa, 3099 Richmond Highway, deputy responded to a drunk driver complaint. The caller advised a Nissan was swerving. Either Nissan has a lot of explaining to do or this was yet another drunk driver. The deputy made contact with the driver, who had very noticeable signs of intoxication. Within her vehicle were numerous empty bottles of alcohol from a wide range of different brands. The driver was charged with driving under the influence.

Potomac Hills Fire Station, deputy observed a Toyota traveling 65 MPH in a 45 MPH zone failing to maintain the lane of travel. Deputies made contact with the driver, who's first statement was "I'm in trouble." He was correct considering the "two drinks" he had prior to driving. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, reckless driving, and failure to maintain the lane of travel.



DELTA ZONE

ASSAULT

Burning Tree Court, deputy responded to an assault. It was discovered during a sleepover an 18-year-old assaulted a juvenile after inappropriate comments were made. The suspect would then brandish a knife and demand everyone to leave the residence. The suspect was charged with strangulation, as well as, assault and battery. He was held at Rappahannock Regional Jail on a \$10,000 secured bond.

DUI

Intersection of Garrisonville Road and Dorothy Lane, deputy was traveling on Garrisonville Road when he encountered a red light. Like most citizens, he stopped at the red light; however, moments later a Chevy Tahoe passed him and went through the red light. The deputy conducted a traffic stop and the driver had signs of intoxication, admitted to consuming "a beer," and sitting right next to him was an open can of beer. The driver was charged with driving under the influence, drinking while driving, failure to obey a traffic light, and 2nd offense refusal. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

Van Horn Lane, deputy responded to a single-vehicle auto accident. A truck was off the roadway and in the woods. The driver had signs of intoxication and admitted to consuming alcohol prior to driving. He was charged with driving under the influence 2nd offense within 5-to 10- years with a blood alcohol content between .15 and .2. He was held at Rappahannock Regional Jail without bond.

LARCENY

Target, 1090 Stafford Market Place, deputy responded to a larceny. A female suspect was shoplifting with the help of her husband when staff attempted to stop her. When confronted, the female assaulted a staff member and the two suspects fled the area. Deputies would locate the suspects and their stolen vacuum at Wawa, located at 105 Garrisonville Road. The female was charged with assault and battery, as well as, shoplifting and the male suspect was issued summonses for shoplifting and a traffic violation.

ASSAULT

McDonald's, 893 Garrisonville Road, deputy responded to an assault. The juvenile victim advised he was enjoying a very happy meal when an unknown female demanded he "get up and move." Since there was no assigned seating, the victim refused and in response, the suspect assaulted him. The suspect was discovered to be intoxicated and had a small box of wine in her possession. She was charged with assault and battery, as well as, public intoxication. She was held at Rappahannock Regional Jail without bond.

WARRANT SERVED

Tacketts Mill Road, deputy responded to a warrant service. The suspect was wanted out of Stafford County for credit card theft, as well as, credit card fraud. The deputy made contact with the suspect and informed her of the charges. A family member would interject herself into not only the conversation, but would physically stand between the deputy and the suspect. The wanted suspect would attempt to retreat within the residence as the family member blocked the deputy from detaining her. Despite the interruption, the wanted suspect was detained. The wanted suspect was served on her outstanding and the family member was issued a summons for obstruction of justice.

SCAM-AWARE

Victim received a text message from what appeared to be Amazon. The text message stated the \$499 Apple MacBook that he ordered would be delivered tomorrow. The victim contacted the phone number associated with the text message, 769-223-8634, to inform them he had not placed an order. A male answered the line, who identified himself as "Austin Slyter" with the U.S. Marshalls and that his badge number was AS50021. "Austin" advised the victim that the U.S. Marshalls were investigating him in Texas for money laundering and his Social Security number and identity had been stolen and compromised. The victim received an additional phone call from 510-229-3040, where a male advised his name was "Christopher Kyrtz" with the U.S. Marshalls and that his badge number was CR795141. "Christopher" advised the victim, in order for his identity to be maintained and for a new social security card to be issued, he had to purchase Apple gift cards and send them to the two U.S. Marshall officers. "Austin and Christopher" advised the victim that he needed to clean out his bank accounts in order to keep his money safe. "Austin and Christopher" stated if the victim purchased Apple gift cards with his money, they would then transfer that money to a credit card for the victim. The "officers" also informed the victim they would be coming to his house the following day to provide him with a temporary Social Security card. The victim advised he received a call from 425-242-8018, advising him they were the credit card company that he would be dealing with. The victim then purchased a total of four (4) Apple gift cards, total of the \$4,470. The victim provided these "officers" with all of the gift card numbers belonging to the gift cards that he purchased.
