ALPHA ZONE

DISTURBANCE

Walmart, 11 Village Parkway, deputy responded to a disturbance. Staff advised a female suspect was screaming at random people inside the business and threatening employees. As soon as the deputy entered the business, his ears were assaulted by the continuing screams the suspect was hurling at employees. While attempting to detain the suspect, she would resist; however, that got her nowhere. She was charged with disorderly conduct and held on secured bond.

DUI

Jiffy Lube, 724 Warrenton Road, deputy was observing traffic on Warrenton Road when a vehicle made a U-turn during a red light. Considering the infraction occurred right in front of the deputy, he quickly conducted a traffic stop. The driver had signs of intoxication and admitted to running the red light because of "stomach issues." The driver would have bigger issues during the field sobriety tests when he refused deputies commands and attempted to get back into his vehicle. He was detained shortly after. The driver was charged with driving under the influence, failure to obey a traffic light, and obstruction of justice.

PUBLIC INTOXICATION

Bearded Monkey, 564 Warrenton Road, deputy responded to a report of some monkey business. It was advised a male, who was acting belligerent, was attempting to fight people. The deputy made contact with the suspect and quickly noticed strong signs of intoxication. The suspect was charged with public intoxication.

Walmart, 11 Village Parkway, deputies responded to a disturbance. Multiple callers advised a female was running around the parking lot preventing vehicles from continuing their travels. When deputies arrived, they had a case of déjà vu, for the suspect was the same suspect from another public intoxication call in the area the day prior. She was once again charged with public intoxication.

Great Clips, 9 Village Center Drive, deputy responded to a disturbance. The caller advised that a female was "screaming and yelling" all over the place. The deputy arrived and made contact with the female, who is known to the Sheriff's Office for multiple prior intoxication offenses. Once again, the suspect was found in an intoxicated state and once again, was charged for public intoxication.

WARRANT SERVED

Super 8, 557 Warrenton Road, deputy responded to a disruptive duo. Staff advised a problematic pair were arguing with staff over a deposit. When deputies arrived, the male party had left, but the female remained. The female was found to have warrants from Stafford, Spotsylvania, and Fredericksburg. All three (3) jurisdictions were able to cross off another wanted individual from their naughty lists, for she was served on her outstanding warrants and held at Rappahannock Regional Jail without bond.

THREATS

Geico, 1 Geico Boulevard, deputies responded to a threats report. A letter, sent by an "anonymous" person arrived at the business. This letter demanded certain claims be paid in full, or people would "be slain."



BRAVO ZONE

DUI

Hollywood Church of Brethren, 225 Ferry Road, deputy was traveling in the area when he observed a swerving Nissan with its high beams active despite opposing traffic being present. The deputy conducted a traffic stop and made contact with the driver. The driver had signs of intoxication, admitted to consuming "three beers," and did not have a driver's license. He was charged with driving under the influence, driving without a license, failure to maintain the lane of travel, and failure to dim high beams.

Ridgemore Court, deputies responded to a disturbance. While investigating the verbal disturbance, it was discovered one of the involved parties drove off in an intoxicated state. Luckily, that individual would drive back to the residence while deputies were still on scene. The driver had signs of intoxication and admitted to drinking "a couple of beers." The driver was charged with driving under the influence with a blood alcohol content above .2.

Intersection of Kings Highway and Cool Springs Road, deputies responded to a drunk driver complaint. It was advised a Jeep was driving in the middle of the roadway. When deputies arrived, they observed the Jeep displaying less than ideal driving behaviors. As deputies made contact with the driver, she would ask for directions to CVS in order to pick up her "meth." While CVS is a drug store, it is not THAT kind of drug store. After field sobriety tests, the driver was charged with driving under the influence. It wasn't all bad news, for the driver remarked multiple times that due to this, deputies "saved my life."

DISTURBANCE

Stafford High School, a deputy and fire and rescue responded to a fire alarm. No fire drill was scheduled leading them to believe someone intentionally caused the disturbance. Using camera footage, the pair were able to confirm two (2) students pulled the fire alarm despite there being no fire. When asked why, the students advised they wanted to see what happened and "curiosity killed the cat." Satisfaction did not bring the cat back, instead the juvenile student received a criminal complaint for unauthorized use of fire protection equipment while the 18-year-old student received a summons for unauthorized use of fire protection equipment.

VANDALISM

Tylerton Subdivision, deputy responded to a vehicle tampering report. It was advised that two (2) male suspects were observed attempting to gain access to the caller's vehicle. When the caller confronted the pair, they fled in their vehicle. While in the subdivision, the deputy discovered additional vehicles that were tampered with. The suspects were described as males wearing all black getting into a black sedan with tinted windows.



CHARLIE ZONE

DUI

Area of Richmond Highway and Telegraph Road, deputy responded to a drunk driver complaint. The caller advised a black Ford was having a hard time maintaining its lane. The deputy found the suspect vehicle pretty easily due to it still swerving around and he conducted a traffic stop. When the deputy made contact with the driver and asked if there was a reason why she was swerving, the driver advised it was because she was "drunk." Her honesty continued as she admitted to consuming five (5) Modelos. She was charged with driving under the influence with a blood alcohol content above .2.

Southbound I-95 Exit Ramp to Westbound Garrisonville Road, deputy responded to someone who may have had too much eggnog. The caller advised a vehicle was stopped at the intersection for "multiple light cycles," and the driver appeared asleep at the wheel. When the deputy arrived, the driver was still snoozing, but an open margarita can was located in plain view. When the driver woke up, deputies observed signs of intoxication. The driver would also state he "messed up" for driving intoxicated. He was correct. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2.

LARCENY

Town Square Circle, deputy responded to a larceny. The victim, along with most of America right now, ordered some last-minute holiday items off of Amazon. Despite her receiving the "delivered" notification, when she went to gather her goods, they were nowhere to be found.

Victory Lane Auto Service, 3201 Richmond Highway, deputy responded to a larceny. Staff advised a Dodge Ram was recently stolen. The vehicle was entered as stolen into a law enforcement database.

VANDALISM

Doria Hill Drive, deputy responded to a vandalism. The victim advised someone went through his vehicle the night prior. This nighttime visitor was not described as a jolly man with a white beard, but was described as a white heavy build female.

LARCENY

Wawa, 920 Wonder Road, deputy responded to a larceny. Staff advised a male suspect came into the business looking for booze. The suspect was momentarily halted in his great theft due to the refrigerator door being locked. His liquor larceny lived on when he observed an end cap full of Beatbox drinks. The suspect would steal the alcohol and flee in a gray Honda Civic.

Home Depot, 305 Worth Avenue, deputy responded to a larceny. Staff advised a family of three (3) was seen collecting over \$1,600 worth of Shark and Dyson products. The "family" would then quickly exit the business without any attempt to pay. The investigation is ongoing.

Target, 1090 Stafford Market Place, deputy responded to yet another larceny. Staff advised a female suspect was actively concealing items. The suspect spent so long picking the \$200 worth of items to steal that the deputy was able to arrive at the business, observe her actively stealing, and intercept her before she could leave the area. The uncooperative suspect was found to be involved in at least three (3) other Target larcenies in nearby jurisdictions. She was charged with shoplifting.

PUBLIC INTOXICATION

Area of Garrisonville Road and Shelton Shop Road, deputy responded to a public intoxication call. The caller advised a clearly intoxicated male was in the area. When the deputy arrived, he located the stumbling suspect strolling down the street. Due to the obvious signs of intoxication, he was charged with public intoxication.



Victim advised he received a call from someone posing as Navy Federal Credit Union. The fraudulent credit caller advised there was an issue with the victim's personal loan. In order to "sort out the loan issue" the caller demanded the victim transfer money into a CashApp account.
