WEEKLY CRIME REPORT

ALPHA ZONE

ASSAULT

Suburban Extended Stay. The caller advised a male was continuously yelling at a female in the lobby. It was discovered the two had been drinking when the male assaulted the female. On top of being rather intoxicated, the male was belligerent towards deputies. After being informed he was getting a one-way trip to Rappahannock Regional Jail, the suspect made multiple threats towards deputies. He was charged with assault and battery, public intoxication, as well as, obstruction of justice. He was held at Rappahannock Regional Jail on a \$3,500 secured bond.

BREAKING AND ENTERING

Heron Drive, deputies responded to a breaking-and-entering. The victims advised someone had entered their residence while they were away, and jewelry was stolen. The investigation is ongoing.

DISTURBANCE

University Boulevard, the deputy responded to a disturbance. Multiple callers advised there was a male in the roadway throwing various objects, including shoes and headphones. The deputy was able to locate the suspect who was less than cooperative. He was arrested for throwing missiles at occupied vehicles and disorderly conduct. He was held at Rappahannock Regional Jail without bond

FRAUD

Aspen Hill Drive, deputy responded to a fraud. The victim advised he was chatting with a female online when a romantic relationship blossomed. During their loving talks, the scammer would request gift cards.

LARCENY

Target, deputies were conducting their anti-shoplifting detail when they were informed of a larceny in progress. Using store cameras, deputies were able to observe the suspect conceal multiple items. When deputies attempted to confront the suspect, the suspect attempted to flee, but lost his balance and fell to the ground. The over \$400 worth of items was recovered and the suspect was issued summonses for shoplifting and obstruction of justice.

TRAFFIC OFFENSE

On ramp of I-95 Northbound from Warrenton Road, deputy was traveling on Warrenton Road when he observed a vehicle with a year-old registration. The deputy conducted a traffic stop and made contact with the driver, who had a revoked license from a prior DUI. The driver was charged with driving with a revoked license, driving after forfeiture of his license, driving a vehicle without an ignition interlock, forged license plate, and having an expired registration. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

BRAVO ZONE



ASSAULT

Willow Branch Place, a deputy responded to an assault. The victim advised he got into a verbal disagreement with his now ex-girlfriend. During the disagreement, the suspect assaulted the victim. A warrant for assault and battery was obtained.

DUI

Payton Drive, a deputy was off duty traveling on Kings Highway when she observed an erratic driver. The vehicle was traveling at a high rate of speed, nearly struck other drivers, and at one point had spun off the road before continuing on like nothing happened. The deputy informed deputies of the possible intoxicated driver and an on duty deputy responded. When the deputy made contact with the driver, he observed signs of intoxication. The driver advised he had two Miller Lites. The driver was charged with driving under the influence and was held at Rappahannock Regional Jail on a secured bond

LARCENY

NextGen Collision and Customs LLC, deputy responded to larceny. Staff advised a vehicle was stolen on Friday.

CHARLIE ZONE



WEAPON OFFENSE

Intersection of Richmond Highway and Garrisonville Road, deputy responded to a road rage incident. The victims advised an erratic driver was traveling behind them on Richmond Highway. As the vehicle passed, the victims advised the suspect brandished a firearm.

ASSAULT

Brooke Point High School, deputy was conducting his SRO duties when he observed a group of students in a shouting match. As Deputy Taylor attempted to de-escalate the situation, one student assaulted another. Criminal complaints are pending.

DRUGS

Rappahannock Regional Jail, deputy responded to drug activity. Staff advised while searching an inmate they located a suspected controlled substance. Charges may be obtained at a later time.

Intersection of Richmond Highway and Corporate Drive, deputy observed a vehicle traveling 67 MPH with the driver not wearing a seatbelt. Deputy Martin conducted a traffic stop and made contact with the driver. When asked for his identity, the driver provided the name of an individual who was deceased. Since the driver was not a ghost, it was safe to assume the driver was lying about who he was. It was discovered the driver had a suspended license. He was issued summonses for speeding, failure to wear a seatbelt, driving while suspended, and identity fraud.

DELTA ZONE

DUI

Graceview Lane, deputy responded to a muddy situation. The caller advised there was a truck stuck in a muddy ditch and the driver appeared intoxicated. When the deputy made contact with the driver he observed signs of intoxication. The driver claimed he was "good" despite admitting to consuming multiple drinks, not having a driver's license, no valid inspection sticker, and his truck being stuck. By all accounts, that was not "good". The driver was charged with driving under the influence, no driver's license, failure to maintain control of his vehicle, no inspection sticker, and refusal. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

ASSAULT

Mountain View High School, deputy was conducting his SRO duties when he was informed of an assault. One student assaulted another after a verbal altercation. The suspect was charged with unlawful bodily injury while the victim was transported to a local hospital with minor injuries.

LARCENY

North Stafford High School, deputy was conducting his SRO duties when he was informed of two (2) larcenies. During gym, student one had her shoes stolen, while student two had her backpack stolen.

WEAPON OFFENSE

North Stafford High School, deputy was conducting his SRO duties when he was informed a student was in possession of a knife. The knife was seized and a criminal complaint for weapon possession on school grounds was filed.
