# WEEKLY CRIME REPORT

# ALPHA ZONE



## **ASSAULT**

Fleet Road, 12/25, deputy responded to an assault. The victim advised a known party struck him with a cane and not the candy type. The deputy located the cane-wielding suspect and discovered him to be in an intoxicated state. The suspect was charged with assault and battery, as well as, public intoxication.

## **DUI**

Excel Inn and Suites, deputy was in the area when he observed a Jetta run a red light on Warrenton Road. The deputy conducted a traffic stop and made contact with the driver. The driver had signs of intoxication and admitted to consuming only "one shot" of vodka before driving. Despite only admitting to the one shot, a large bottle of vodka and mini-bottles of liquor were all located empty within the vehicle. The driver was charged with driving under the influence with a blood alcohol content above .2.

## **BURGLARY**

Kensington Drive, deputy responded to a previously occurred burglary. The victims arrived home to discover a window had been shattered by a rock and over \$9,000 worth of jewelry was missing. The investigation is ongoing.

## **LARCENY**

Target, 25 South Gateway Drive, deputy responded to a larceny. It appears the Stanley brand cup craze is not over, for staff advised a male suspect was observed concealing one (1) among other items. The \$150 worth of items were recovered and the suspect was issued a summons for shoplifting.

Walmart, 11 Village Parkway, deputy responded to yet another larceny. Staff advised a male suspect had stolen nearly \$400 worth of items the day before. Using the information collected by staff, and store cameras, the deputy was able to identify the suspect and obtained a warrant for shoplifting.

## **DISTURBANCE**

Giant, 550 Celebrate Virginia Parkway. Christmas Eve shoppers received a not-so-merry greeting at the business. Staff advised a female was yelling and cursing at people. The deputies responded and when they made contact with the female, she made her displeasure for law enforcement very known. She would continue to make a scene and curse until she was placed into handcuffs. The suspect was charged with disorderly conduct.

Royal Farms, 125 Royal Falls Drive, deputies responded to a disturbance. Staff advised a female was yelling inside the business. Before making her grand exit, she would grab multiple items and stuff them in her pockets. Deputies located the Florida woman, who advised "he was supposed to cover the bill." He is Donald Trump. The suspect's explanation did not trump the trouble she was in, and she was charged with disorderly conduct and shoplifting.

## **TRESPASS**

America's Best Value, 605 Warrenton Road, deputy responded to a trespassing. Staff advised a male, who was trespassed by the deputy the day before, was back and refusing to leave. The deputy made contact with the suspect again when the suspect stated he was not leaving. The suspect did in fact leave, but in handcuffs. He was charged with trespassing and held at Rappahannock Regional Jail on a secured bond.

# BRAVO ZONE

## **ASSAULT**

Cambridge Street, deputy responded to an assault. The victim advised she was assaulted by a roommate during an argument. The suspect was charged with assault and.

## **DUI**

Area of Richmond Highway and Centreport Parkway, deputy was traveling on Richmond Highway when she observed a Mitsubishi traveling 20MPH over the speed limit. The deputy conducted a traffic stop and made contact with the driver. The driver, coming from a "crazy night" at a Christmas party, advised he was more focused on his phone than his speed. While that is reckless in itself, the deputy hypothesized alcohol could be another cause due to the driver's signs of intoxication. The driver's "crazy night" would end with him receiving charges for driving under the influence 2nd offense within 10 years, 2nd offense refusal, reckless driving, and having an expired registration. He would join the Rappahannock Regional Jail's Christmas party where he was held without bond.

## **LARCENY**

Earl's True Value Hardware, deputy responded to a larceny. Staff advised a female suspect had stolen Yeti products the day prior. The Yeti lover was caught on camera, which the deputy used to identify her. Warrants were obtained.





# CHARLIE ZONE



## **LARCENY**

Barrett Court, deputy responded to a previously occurred larceny. The victim advised over \$100 worth of Amazon packages were stolen off her porch. The good part about living in this generation is the availability of porch cameras, which captured the larceny. Footage showed a female stealing the packages with the help of a child before fleeing in a dark-colored Ford Escape.

## **ASSAULT**

Appletree Lane, deputy responded to an assault. A female got into a verbal altercation with her roommate's girlfriend. This Christmas confrontation escalated when both females began assaulting each other. Both were charged with assault and battery.

## **PUBLIC INTOXICATION**

Dollar General, 1348 Courthouse Road, deputies responded to a disturbance. The caller advised he was being chased as he ran along Richmond Highway. Deputies located the caller, who did not have anyone chasing him and was found to be in an intoxicated state. He was charged with public intoxication.

# DELTA ZONE

## **DUI**

Hardee's 20 Prosperity Lane, a deputy was off-duty and was traveling Southbound on I-95 after finishing up some Christmas shopping. While doing so, he observed a Ford Ranger failing to maintain their lane of travel. The deputy continued to observe the vehicle as he informed on-duty deputies of the possible DUI driver and a traffic stop was conducted when the vehicle exited I-95. The driver had signs of intoxication, a make-shift smoking device in his hand, and admitted to consuming "three Tic-tac's" worth of fentanyl. He was charged with driving under the influence 2nd offense in 5 years, possession of controlled substances, and an expired inspection. He was held at Rappahannock Regional Jail without bond.

Cliff Circle, deputy responded to an auto accident. The caller advised their parked Toyota was struck by a driver who seemed intoxicated. The deputy arrived and discovered the suspect driver was still on the scene. The driver had signs of intoxication and admitted to consuming 12 drinks, 10 Coronas, and 2 tequila shots to be exact. While investigating the DUI report, the deputy responded to a hit-and-run just down the street. Camera footage showed the same suspect driver striking the Ford before continuing on. The driver was charged with driving under the influence, refusal, as well as, hit and run.

Area of Garrisonville Road and Tech Parkway, deputy responded to a drunk driver complaint. The caller advised an intoxicated male attempted to buy alcohol at Sheetz. When staff denied him, he left the area driving a Toyota. When the deputy arrived, he located the suspect vehicle just across the street at Wawa. A traffic stop was conducted and the deputy made contact with the driver. The driver had signs of intoxication, an open alcoholic beverage, and a revoked license due to a prior DUI incident. He was charged with driving under the influence with a blood alcohol content above .2, drinking while driving, and driving while revoked. He was held at Rappahannock Regional Jail until sober.

## **PUBLIC INTOXICATION**

Dollar General, deputy responded to a disturbance. Staff advised a male was throwing a fit and profanities after not being able to buy alcohol. The deputy made contact with the suspect, who not only had signs of intoxication but outright admitted to being "drunk." He was charged with public intoxication.

Renee Road, deputy responded to a public intoxication call. The caller advised there was a stumbling male who decided walking was too hard and decided to lie down on the ground. The deputy located the dirt-covered suspect and found him to be intoxicated, and wanted for a probation violation. The suspect was served on his outstanding warrant and a new warrant for public intoxication. He was held at Rappahannock Regional Jail without bond.
