## WEEKLY CRIME REPORT

### **ALPHA ZONE**



#### LARCENY

Walmart, deputy responded to a larceny. Staff advised they observed a female stealing. It was discovered the less-than-cooperative suspect was a juvenile and attempted to walk out with over \$320 worth of items. A criminal complaint for larceny was filed.

Target, deputy responded to a larceny in progress. Staff advised they were watching two females concealing items. Prior to the deputy's arrival, one of the suspects fled in an SUV, leaving behind the stolen items and her accomplice. The left-behind suspect was issued a summons for shoplifting. The other suspect was identified and warrants were obtained.

#### TRAFFIC OFFENSE

Royal Farms, deputy responded to a hit and run. The victim advised while traveling on Warrenton Road her vehicle was stuck. The victim was able to take pictures of the suspect vehicle's license plate and driver prior to them fleeing the scene. The deputy was able to identify the driver and discovered he did not have a valid driver's license. Warrants for hit and run, as well as, driving after forfeiture of license were obtained.

### **BRAVO ZONE**



#### **FRAUD**

Deacon Road, deputy responded to a fraud. The victim advised he received a call from someone claiming to be with the Stafford County Sheriff's Office. The scammer advised there was a warrant out for the victim's arrest and the only way to avoid it was to pay in Bitcoin. The real Stafford County Sheriff's Office will never demand money over the phone, if you are unsure if you are wanted or not, visit the Sheriff's Office directly.

## **CHARLIE ZONE**



#### **LARCENY**

FasMart, deputy responded to a larceny. An employee advised someone stole his phone while he was working the day prior. Using camera footage, a suspect was identified.

#### **ASSAULT**

Rappahannock Regional Jail, deputy responded to an assault. It was discovered one inmate assaulted another over a disagreement on "the rules of the cell." A warrant for assault and battery was obtained.

#### **BREAKING AND ENTERING**

Andrew Chapel United Methodist Church, deputy responded to a break in. It was discovered the church was forcefully broken into, but nothing was taken.

#### **PUBLIC INTOXICATION**

Sheetz, deputy responded to an unknown problem. The caller advised there was a passed-out male in the parking lot. The deputy made contact with the suspect who advised he consumed alcohol prior to heading to a Christmas party. He would be late to the party; he was arrested for public intoxication. While at Rappahannock Regional Jail, it was discovered he was in possession of suspected controlled substances. He was additionally charged with possession of controlled substances and was held without bond.

## **DELTA ZONE**

#### **DISORDERLY CONDUCT**

Rock Hill District, deputy responded to a suspicious person call. The juvenile victim advised a delivery driver came to the residence multiple times and offered to do things of a sexual nature. The suspect, a stranger to the victim, was arrested for stalking and attempted consensual acts with a minor.

Paris Lane, deputy responded to a disturbance. The victim advised an ex-romantic partner forced his way into the residence, destroyed property, and stole a phone. Warrants for unlawful entry, larceny, and destruction of property were obtained.

#### **LARCENY**

Giant, deputy responded to a larceny. Staff advised they had a video of a woman stealing multiple items. The deputy was able to identify the suspect.

Target, deputy responded to a larceny. Staff advised a female just walked out with nearly \$300 worth of items. The deputy located the suspect with the stolen items.


#### DUI

Bertram Boulevard, deputy responded to a single-vehicle auto accident. The driver had reversed out of a driveway and directly into a ditch. While the driver stated it was because she backed out too far, the deputy hypothesized the real reason for the crash was due to the two mixed drinks she admitted to consuming. After conducting field sobriety tests, the driver was placed into handcuffs. She was charged with driving under the influence with a blood alcohol content between .15 and .2, as well as, failure to maintain control of her vehicle.

#### **WARRANT SERVED**

Providence Street, deputy responded to an information call. It was advised a male wanted out of Stafford County for larceny and domestic assault was sleeping in his vehicle. Deputies were able to locate him and took him into custody without incident. He was discovered to be in possession of a firearm. He was served on his outstanding warrants, as well as, charged with weapon possession by a felon. He was held at Rappahannock Regional Jail without bond.
