




# WEEKLY CRIME REPORT

# ALPHA ZONE



## **DISTURBANCE**

IHOP, 10 Simpson Road, deputy responded to the house of pancakes for a disturbance. It was advised an employee did not take the news of his termination well. Moments after being fired, he would return to the business, now wearing a mask, in a fired-up state and yelling at staff. Warrants for disorderly conduct and wearing a mask in public were submitted.

## **DUI**

Wawa, 9 South Gateway Drive, deputies responded to a disturbance. Staff advised four (4) individuals were in the business and appeared to be intoxicated. As deputies responded, they were advised the driver was about to leave. Deputies quickly located the suspect vehicle, due to it being partially parked on the curb, and made contact with the involved parties. Inside the vehicle were numerous open Twisted Tea cans and a “mostly empty” vodka bottle. The 18-year-old driver admitted to drinking before getting behind the wheel. He was charged with underage driving under the influence, as well as, drinking while driving. He was held at Rappahannock Regional Jail on a secured bond. Due to the other individuals being intoxicated within the business, they all were charged with public intoxication.

Taco Bell, 730 Warrenton Road, a deputy was traveling on Plantation Drive when she observed a Honda cut off another vehicle to turn into the shopping center. While doing so, the Honda would ride on the wrong side of a divided median. Before the driver could leave, the deputy conducted a traffic stop. The driver had signs of being under the influence and it was also discovered the driver had brass knuckles concealed on his person. He was charged with driving under the influence, carrying a concealed weapon, and the traffic lane violation.

## **LARCENY**

Dunkin Donuts, 551 Warrenton Road, deputy responded to a cookie crime. Staff advised a male took cookies off the counter and consumed them without consent. When confronted, the suspect advised he “needed to take a call” and quickly fled the area. The deputy was able to identify the suspect due to previous encounters and was able to locate him. He was charged with larceny and held at Rappahannock Regional Jail without bond.

Target, 25 South Gateway Drive, deputy responded to a larceny. Staff advised a female suspect attempted to leave the business with nearly \$150 worth of unpaid goods. The deputy made contact with the suspect and discovered she was wanted for fraud involving a firearms purchase. The suspect was served on her outstanding warrant and additionally charged with shoplifting.

## **WARRANT SERVED**

Truslow Road, deputies responded to a warrant service. The suspect was wanted for traffic offenses. When deputies arrived, the suspect was not on scene; however, after a bit of waiting the suspect would drive by. As soon as he saw deputies instead of parking, he quickly changed his mind and continued driving. The minimum effort escape ended when deputies conducted a traffic stop. Considering the suspect was driving with a revoked license, he was additionally charged with that on top of his outstanding warrants.

# BRAVO ZONE

## **DUI**

Area of Centreport Parkway and Aviation Way, deputies responded to a drunk driver complaint. The caller advised a bearded male behind the wheel of a Ford appeared intoxicated. Deputies located the vehicle and conducted a traffic stop. The driver had signs of intoxication, admitted to consuming approximately "five pints" of alcohol, and had an open alcoholic bottle with a large portion missing within arm's reach. The driver was charged with driving under the influence with a blood alcohol content above .2, as well as, drinking while driving. He was held at Rappahannock Regional Jail without bond.

Cool Spring Road. A 53-year-old driver was swerving down the roadway not knowing a deputy was behind her watching the traffic violations. The deputy conducted a traffic stop and made contact with the driver. The driver blamed her wibbly wobbly driving on the "slippery" road; however, the deputy believed it could have something to do with the three (3) shots she admitted to consuming. After field sobriety tests, the driver was charged with driving under the influence and failing to maintain the lane of travel.

## **PUBLIC INTOXICATION**

Area of Kings Highway and Washington Square Plaza, deputy responded to a public intoxication call. It was advised a possibly intoxicated female was sitting in a ditch. The deputy made contact with the suspect and was quickly able to determine she was intoxicated and was charged with public intoxication.

100 block of Cambridge Street. At the start of the year, a deputy was in the area when he observed a male stumble into the road and nearly get struck by a vehicle. The deputy made contact with the male who had sings of intoxication, and when asked how much he had to drink, the suspect advised "It doesn't matter." It did, and he was charged with public intoxication. Despite being arrested, the suspect advised he was "happy" to be able to sleep off the intoxication at the comfy Rappahannock Regional Jail. He was held until sober.

James Madison Circle, deputy responded to a disturbance. The caller advised a known party turned on the gas stove in an attempt to "blow the house up." Luckily, the Hollywood-like explosion did not occur and the deputy located the suspect wandering across the street. The suspect had signs of intoxication and was charged with public intoxication.

Winterberry Drive, deputy responded to a disturbance. The victim advised a known party showed up unannounced at her residence in an intoxicated state. Considering this was his 2nd time today showing up unannounced, the victim had enough. The deputy made contact with the suspect, who had clear signs of intoxication and detained him. The suspect was charged with public intoxication and trespassing.

# CHARLIE ZONE

## **ALCOHOL OFFENSE**

Belcroft Drive, deputy responded to a suspicious vehicle report. The caller advised an unknown vehicle was sitting outside his residence. When the deputy arrived, the vehicle was found to be occupied by a juvenile who was "picking up a friend." Said friend never revealed themselves; however, a bottle of Pink Whitney was located on the dashboard of the vehicle. A criminal complaint for underage possession of alcohol was submitted.

## **BREAKING AND ENTERING**

Bells Hill Road, deputy responded to a residential alarm. It was discovered a male suspect entered the residence through a window. After being caught on camera, and setting off the alarm, the suspect fled a minute after entering.

## **DUI**

1900 Block of Richmond Highway, deputy responded to a drunk driver complaint. The Toyota driver was having less than ideal driving behaviors as it traveled Northbound. The deputy would observe the suspect vehicle not only driving in two lanes at the same time but tailgating a Fredericksburg Police cruiser. A traffic stop was conducted and the deputy made contact with the driver. The driver had heavy signs of intoxication, a revoked license due to a previous DUI offense, and was wanted out of Fairfax. The driver was charged with driving under the influence, 2nd offense refusal, and driving while revoked. He was also served on his outstanding warrant and held at Rappahannock Regional Jail without bond.

Area of Richmond Highway and Austin Run Boulevard, deputy responded to an auto accident. A Pacifica plowed into a ditch and a witness advised the driver seemed intoxicated. The deputy made contact with the driver, who not only had signs of intoxication, but admitted to drinking a few Michelob Ultras while at work. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2.

## **THREATS**

Glacier Way, deputy responded to a threats report. The victim advised a former lover made threats of "cutting" him after their recent separation. A warrant for threats of body harm was submitted but has not yet been served.

## **ASSAULT**

Hidden Lake Drive, deputy responded to an assault. It was discovered the victim was assaulted by the intoxicated suspect over "loud music." The suspect was charged with assault and battery.

## **PUBLIC INTOXICATION**

Area of Richmond Highway and Jason Lane, deputy was in the area for an abandoned vehicle when she was approached by a female. The female had signs of intoxication and was charged with public intoxication.

# DELTA ZONE

## **ROBBERY**

Wawa, 105 Garrisonville Road, deputy responded to a past-occurred robbery. The victim advised he met a girl on social media named "Lala." "Lala" would drive the victim to a nearby neighborhood when four (4) males approached the vehicle. The victim stated the males pulled him out of the car and stole multiple personal belongings before the victim was able to flee. The investigation is ongoing.

## **LARCENY**

Home Depot, 305 Worth Avenue, deputy responded to a larceny. Staff advised a duo, who stole from the business the day before, returned to steal once again. This time, staff confronted the male. The male would quickly flee with his female partner in a white Mercedes.

Walmart, 217 Garrisonville Road, deputy responded to a larceny. Staff advised a known shoplifter entered the business with three (3) additional friends. The foursome stole multiple items before fleeing the area in a gray Honda Accord.

## **PUBLIC INTOXICATION**

McDonald's, 190 Garrisonville Road, deputy responded to a public intoxication call. The caller advised a male who appeared "under the influence of something" was cursing at staff. When the deputy arrived, everyone in the business quickly pointed out the suspect. The suspect attempted to spread his geopolitical views with the deputy however, it was difficult to understand due to his apparent signs of intoxication. The suspect was charged with public intoxication.



# SCAM-AWARE

**Victim** received an email from an unknown person. The email was received from "Barret Tian" with an email of "ryndedielf@outlook.com". The email contained an attachment which the victim opened up and read. The attachment contained a Word document with her name, phone number, and address. The unknown person requested \$1,950 worth of Bitcoin and told her "You've no idea what I'm capable of in Fredericksburg". The Word document further told her there was malware on a porn website she visited, which granted access to her smartphone. The unknown person threatened to send explicit videos/screenshots of the victim to all of her contacts and neighbors and the victim had one day to pay by Bitcoin to an address of "be1q2xvcj3p2zzt0drc66jtfcg84uzt2pa35jzpz4". The victim paid no money and contacted the Sheriff's Office knowing this was a scam.

**Victim** received a phone call from an unknown number. The person on the other line claimed to be a Sergeant with Stafford County Sheriff's Office and advised the victim that he had missed Jury Duty today and had to pay a fine or he would be arrested. The victim immediately went to a Sheetz gas station, while he stayed on the phone with the suspect, never disconnecting, and purchased \$900 worth of gift cards, giving the numbers to the person on the phone. When the victim provided the unknown subject with the numbers, the suspect immediately disconnected. The victim then drove to the courthouse to find that the courts were closed and he had been scammed.
