

WEEKLY CRIME REPORT

ALPHA ZONE

DISTURBANCE

Red Roof Inn, 386 Warrenton Road, a deputy responded to a disturbance. A male suspect, who was recently featured in a different disturbance at the same location, had returned. The suspect was yelling at the staff about a refund. While dealing with the situation, the deputy discovered the suspect was in violation of a protective order obtained during the last disturbance. The suspect was charged with violation of a protective order.

LARCENY

Target, 25 South Gateway Drive, a deputy responded to yet another failed larceny at Target. Staff observed a female suspect skip-scanning over \$100 worth of items and issued a summons for shoplifting.

Walmart, 11 Village Parkway, a deputy responded to a larceny. A male and female attempted to leave the store with over \$430 worth of items before staff confronted them. Both suspects would quickly flee the scene in a Mercedes.

Royal Farms, 4 Commerce Parkway, a deputy responded to a larceny. Staff advised a male suspect filled his backpack with alcoholic beverages and left without paying.

DUI

Wawa, 9 South Gateway Drive. A deputy observed an irresponsible driver. The driver would conduct a traffic lane violation and nearly strike another vehicle. The deputy would conduct a traffic stop and notice that the driver had signs of intoxication and even admitted that she "won't pass the test," referring to the field sobriety tests. It was discovered this wasn't her first rodeo, for she had a previous DUI offense. The driver was charged with driving under the influence 2nd offense within 5 to 10 years, 2nd offense refusal, and the traffic lane violation. She was held at Rappahannock Regional Jail without bond.

PUBLIC INTOXICATION

Anvil Road, a deputy responded to a disturbance. It was advised a male party was involved in a verbal disagreement after consuming tequila. Deputies would locate the suspect in the road in an intoxicated state. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

BRAVO ZONE

HIT AND RUN

Caisson Road, a deputy responded to a call that was not your run of the mill hit and run call. The victim advised a black truck driving recklessly went off the roadway. When it overcorrected, a spare tire from the back of the pickup struck the victim's vehicle. While investigating it was discovered the truck obliterated two mailboxes as well. The suspect vehicle was described as a black pick-up truck with "purple lights under it."

DUI

Forest Lane Road, a deputy responded to an auto accident. A driver was stuck on the side of the road. The caller further advised the driver appeared intoxicated. The deputy located the stuck driver and discovered him to be displaying signs of intoxication. The driver would admit to consuming two (2) Bud Lights and was in possession of a concealed firearm. He was charged with driving under the influence, reckless driving, carrying a concealed weapon while intoxicated, and refusal. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

PUBLIC INTOXICATION

Lafayette Street, deputies responded to a public intoxication call. It was advised a known female was intoxicated in the area. Deputies arrived to locate the female they had been searching for. They discovered her in an intoxicated state in view of the public. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Edwards Drive, a deputy responded to a disturbance. It was discovered the caller took the keys from a female suspect to prevent her from driving while intoxicated. The female suspect would not respond well to this and began throwing personal items of the callers all over the driveway. The deputy would make contact with the intoxicated suspect as she threw water at the front door. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

VANDALISM

Swan Drive, a deputy responded to a vandalism. The day after Valentine's Day, the suspect wasn't feeling the love and took it out on the vehicles at a residence. Four (4) vehicles had their tires slashed. The investigation is ongoing.

CHARLIE ZONE

ASSAULT

Ottinger Lane, a deputy responded to an assault. It was advised a male suspect escalated a verbal argument by getting physical and using a taser on the victim. The suspect would leave prior to deputies' arrival. A deputy was able to locate the suspect in an intoxicated state who would resist being detained; however, that was short lived. The suspect would not wish to talk about the incident other than "take me to Rappahannock." Deputies complied. The suspect was charged with simple assault, public intoxication, littering, and obstruction of justice.

PUBLIC INTOXICATION

McDonald's, 190 Garrisonville Road, a deputy responded to a suspicious person call. Staff advised they wanted a male who was "acting weird" to be trespassed. The deputy made contact with the suspect and discovered he wasn't a Big Mac fan, but a "Mc-alcoholic" beverage fan. The suspect was detained when he began making threats towards deputies on scene. His spree did not end there, for whence in the back of a cruiser, he would kick the window frame enough to bend it. The suspect was charged with public intoxication, destruction of property, and obstruction of justice. He was held at Rappahannock Regional Jail on a secured bond.

DUI

Area of Richmond Highway and Little Forrest Church Road, a deputy observed a vehicle drifting over the double yellow line and conducted a traffic stop. The driver with no driver's license admitted to consuming some Modelo prior to getting behind the wheel. After observing signs of intoxication and conducting field sobriety tests, the deputy detained the driver. He was charged with driving under the influence and driving without a license. He was held at Rappahannock Regional Jail on a secured bond.



DELTA ZONE

DUI

Brookdale Court, a deputy responded to a suspicious vehicle report. The caller advised an unfamiliar vehicle had been in the area for the past four hours, occasionally leaving only to return to the exact spot. The deputy made contact with the slumbering driver, who had signs of intoxication. The driver, who advised he was "going through a lot," admitted to consuming four (4) shots of tequila. A half-empty, or half-full for the optimists, bottle of tequila was located within the vehicle. The driver was charged with driving under the influence and drinking while driving.

LARCENY

Walmart, 217 Garrisonville Road, a deputy was on scene of a solicitor report when staff made contact with him. This observant staff member advised they observed a male suspect concealing items into his backpack. The deputy located the suspect attempting to leave with a filled bag of unpaid merchandise. The over \$100 worth of items was returned to the business and the suspect was issued a summons for shoplifting.

Wawa, 105 Garrisonville Road, a deputy responded to a repeat shoplifter. Staff advised a male known to steal Modelo on three (3) previous occasions came back to do it again. The suspect walked out with two (2) more cases of Modelos.

Walmart, 14 North Stafford Complex, a deputy responded to a disturbance. It was advised a male suspect, who appeared "out of his head," was throwing things. The deputy located the suspect and discovered he was a DC Comics fan, as he would speak using his "Joker" voice. Batman was not needed for the incident as the deputy easily detained this "joker" due to his signs of intoxication. He was charged with public intoxication.

PUBLIC INTOXICATION

Lowes, 1330 Stafford Market Place, a deputy responded to a disturbance. Despite the traffic concerns, it was advised a female was walking into the roadway. The deputy would make contact with the female in question, who is no stranger to public intoxication arrests. She was discovered to be publicly intoxicated again and was arrested.
