WEEKLY CRIME REPORT

ALPHA ZONE

DUI

Northbound I-95 at mile marker 138, a deputy was traveling up I95 when he observed a swerving Acura driving at an excessive speed. The deputy would conduct a traffic stop and made contact with the driver. The driver had signs of intoxication and admitted to consuming five (5) Bud Lights before deciding to take a trip to a local casino. His gamble wouldn't pay off as he was charged with driving under the influence with a blood alcohol content between .15 and .2, reckless driving, and the traffic lane violation. In this game of Rappahannock Hold 'Em, the driver was held on a \$2,500 secured bond.

Musselman Road, a deputy was in the area when he observed a Volkswagen stopped in the middle of the roadway. The deputy activated his emergency equipment and got out of his cruiser to make contact with the driver, that is when the driver decided to drive off. The deputy would give chase as the driver decided he needed to make a quick stop at a local business at 375 Warrenton Road. His late-night trip would have to wait for he was quickly detained. The 33-year-old had signs of intoxication and admitted to consuming beer earlier in the night. He was charged with driving under the influence with a blood alcohol content above .2, eluding police, and stopping on the highway. He was held at Rappahannock Regional Jail without bond.

WARRANT SERVED

Mr. B's, 375 Warrenton Road, a deputy was assisting with a traffic stop when he observed a wanted suspect enter the business. The suspect was wanted for a vandalism that the deputy was investigating. The deputy detained the suspect and discovered he was in possession of suspected controlled substances. The suspect was served on his outstanding warrant and additionally charged with possession of controlled substances.

Super 8, 557 Warrenton Road, a deputy responded to a disturbance. The caller advised a female was displaying behaviors related to drug activity. When the deputy made contact with the suspect, she was attempting to hide paraphernalia under the floor mat in a vehicle. She was also discovered to be wanted out of Prince William County for felony hit and run. She was served on her outstanding warrant and held at Rappahannock Regional Jail without bond. Possession of controlled substances charges are pending.

WEAPON OFFENSE

Stafford Lakes Parkway, a deputy responded to a road rage incident. The victim advised he got into a verbal argument with the driver of a silver Toyota Camry. While they exchanged insults, the suspect brandished a firearm. The suspect was described as a black male between the ages of 18 and 20 with dreadlocks and "a football shaped head."

BRAVO ZONE

FRAUD

Greenway Street, a deputy responded to a fraud. The victim advised her boyfriend unlawfully used her bank account to transfer money to himself. Warrants were obtained and, at approximately 9:50 p.m., a deputy attempted to serve them on the now ex-boyfriend. Despite commands to surrender to deputies, the suspect would not comply and was located hiding under a beanbag chair. He was charged with larceny, identity fraud, and obstruction of justice. He was held at Rappahannock Regional Jail without bond.

LARCENY

ABC, 43 Town and Country Drive, a deputy responded to Jim Beam being kidnapped. Staff advised a male suspect suited up with a Michael Kors jacket had stolen a bottle of Jim Beam.

ASSAULT

Area of Washington Square Plaza, a deputy responded to an assault. The victim advised while traveling in the area, he got entangled in a road-rage incident. During this "rager", the other driver threw an unknown item at his vehicle. When the victim got out of his vehicle to confront the suspect, she threw a bottle of perfume at him. The suspect was described as a white female in her twenties driving a blue Ford.

ALCOHOL OFFENSE

Chatham Heights Road, a deputy observed an Accord traveling 51MPH in a 35 MPH zone and conducted a traffic stop. Both occupants, who were juveniles, were discovered to be in possession of rum. The "rum-riders" received criminal complaints for unlawful possession of alcohol.

DUI

Town and Country Drive, a deputy responded to a disturbance. The caller advised a driver was either having a medical emergency or "extremely intoxicated." When the deputy arrived, she discovered it was the latter. The male driver had signs of intoxication and admitted to consuming some beer while at a local wing place. He was charged with driving under the influence.

Butler Road, a deputy responded to an unknown problem. It was advised a female was unconscious on the side of the road. The deputy located the suspect, who was in possession of a bottle of alcohol. As the suspect complained about her toothache, the deputy observed signs of intoxication. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

CHARLIE ZONE

ASSAULT

Rappahannock Regional Jail, 1745 Richmond Highway, a deputy responded to an assault. Staff advised an inmate assaulted another inmate. The victim was transported to a nearby hospital with minor injuries and a warrant for unlawful wounding was obtained for the predominant aggressor.

LARCENY

Sheetz, 15 Wyche Road, a deputy responded to a larceny. Staff advised three (3) suspects left the business carrying "loads" of unpaid items. The \$155 load consisted of the unusual combination of alcohol and candy.

PUBLIC INTOXICATION

Courthouse Road, a deputy responded to a public intoxication call. Multiple callers advised there was a stumbling suspect walking into traffic. The deputy located the male and observed him to have several signs of intoxication. While the suspect advised he hadn't been drinking anything today that statement wasn't convincing considering the bottle of alcohol seen in his coat pocket. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Rappahannock Regional Jail, 1745 Richmond Highway, a deputy responded to a warrant service. The suspect of a hit and run the deputy was investigating was turning herself in; however, not before having a bit to drink beforehand. She was served on her outstanding warrant and due to her being intoxicated in view of the public, was additionally charged with public intoxication. She didn't have to go far, for she was held at Rappahannock Regional Jail without bond.

Olympic Drive. While investigating a Steelers fan pursuit, a deputy was rapidly approached by a female. The deputy responded and the female was detained. The 18-year-old had signs of intoxication and admitted to consuming more alcohol than an 18-year-old should. She was charged with public intoxication and unlawful consumption of alcohol. She was held at Rappahannock Regional Jail until sober.

Sheetz, 15 Wyche Road, a deputy responded to a bathroom party of one. Staff advised an intoxicated female was taking her time in one of the stalls. When the deputy arrived, he located the suspect asleep in the stall with three (3) containers of alcohol. When she woke up from her nap, the deputy observed several signs of intoxication. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

FRAUD

Rappahannock Regional Jail, 1745 Richmond Highway, a deputy responded to a warrant service. While serving the 55-year-old on his outstanding warrant, it was discovered he was in possession of multiple counterfeit bills. The fake "Franklins" were seized and the investigation on their origin is ongoing.

BREAKING AND ENTERING

Holy Pipe Tobacco, 2163 Richmond Highway. Deputies responded to a business alarm. The Holy Pipe had an unholy break in, as the front glass door had been shattered. The business was searched and no suspects were located. The investigation is ongoing.

DELTA ZONE

TRESPASS

Wawa, 105 Garrisonville Road, a deputy responded to a trespasser. The caller advised a known party, who had been previously trespassed, was back on the property. The deputy made contact with the suspect, who advised he knew he was trespassed, but was there to get "some fresh air." While the smell of hoagies in the air might be tempting, that was not a valid excuse. The suspect was charged with trespassing and held at Rappahannock Regional Jail on a \$2,000 secured bond.

LARCENY

Walmart, 217 Garrisonville Road, a deputy responded to a larceny. Staff advised a male walked out of the store with unpaid merchandise after his card was denied. The suspect, a white male wearing a black jacket and red hat, got away with over \$200 worth of items.

Pin Oak Court, a deputy responded to a missing Mercedes. The victim advised his Mercedes was there when he went to bed; however, it was now missing. Luckily, for the victim, the deputy located the stolen vehicle on Embrey Mill Road later into his shift. Nothing was taken and the victim reclaimed his property.

PUBLIC INTOXICATION

Woodstream Boulevard. Knock, knock, deputies responded to a late-night visitor. The caller advised an unknown male was knocking on her door asking for a ride to Wawa. Considering the unusual request at the unusual hour, she did not comply and called police. Deputies made contact with the suspect, who was holding a bong he advised was used to smoke "oregano." The master chef's lie didn't fool deputies and his signs of intoxication led them to believe he was cooking something else up. The seasoning suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

DUI

Longview Drive, a deputy responded to some off-road driving. The caller advised a Corolla was driving in their yard and the driver appeared intoxicated. When the deputy arrived, he located the stuck Corolla, but not the driver. It was advised the female driver had wandered off. The deputy would locate the driver nearby, who admitted to drinking and driving. She also had signs of intoxication. She was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

Paisano's, 1515 Stafford Market Place, a deputy responded to yet another drunk driver complaint. It was advised a known party was highly intoxicated and about to drive off. The deputy arrived as the driver was riding around the parking lot and made contact with him. The driver had signs of intoxication and a nearly completely consumed bottle of New Amsterdam vodka. He was charged with driving under the influence with a blood alcohol content above .2. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.



SCAM-AWARE



Victim received a call from someone posing as a Sergeant with the Stafford County Sheriff's Office. The fake "Sergeant" advised the victim had missed jury duty that day and needed to pay using gift cards or be arrested. After providing the gift card information over the phone the victim drove to the courthouse to discover the courts were closed due to the snow.

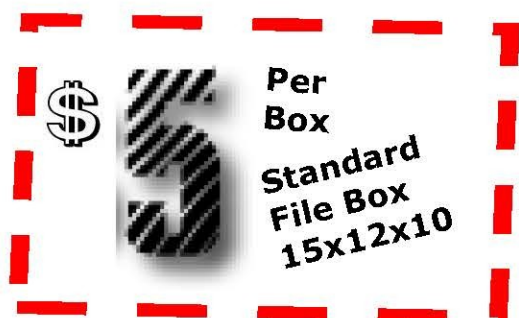
