


# Stafford County Sheriffs Office

# WEEKLY CRIME REPORT



FEBRUARY 3RD - FEBRUARY 9TH, 2025

### **ALPHA ZONE**



#### **FRAUD**

Walmart, 11 Village Parkway, a deputy responded to a past occurred fraud. Staff advised a known male had been making fraudulent returns along the East Coast, including this location. Using camera footage, the deputy confirmed the suspect returned "gutted" external hard drives for a refund.

Truslow Road, a deputy responded to a failed fraud. The victim advised he received a call from "Simon." Simon falsely claimed he worked for Microsoft's Security Department and the victim's account had been hacked. To fix the problem, the victim would need to deposit money into a different bank account. When the victim explained the situation to his bank teller, they informed him of the scam and to not comply.

#### **DRUGS**

I-95 Southbound on ramp from Warrenton Road, a deputy observed a Nissan fail to come to a complete stop and conducted a traffic stop. During their conversation, it was discovered the driver had a suspended license. The deputy conducted an inventory search of the vehicle. Suspected controlled substances were located and the driver was detained. He was charged with possession of controlled substances and driving while suspended. He was held at Rappahannock Regional Jail on a \$1,000 secured bond.

### **BRAVO ZONE**



#### **SWATTING**

Julian Drive, deputies responded to a call of a shooting. The caller advised he shot his juvenile brother and wanted to harm himself. While there were inconsistencies with the caller's statements, out of an abundance of caution, deputies responded to the residence in question. Deputies made contact with the residents and confirmed there was no emergency. The incident was determined to be a swatting call.

#### **HIT AND RUN**

Intersection of Butler Road and Richmond Highway. While dealing with the overturned vehicle in the area, a fire truck was stuck and damaged by a passing vehicle. A deputy responded to assist in the hit and run investigation and discovered the suspect vehicle was a four-door Ford.

#### DUI

Forbes Street. A deputy responded to an auto accident. The driver advised he hit something "likely expensive" but was unsure as to what it was. The "expensive" item was discovered to be a mailbox that was not worth much of anything now considering the damages to it. The driver was discovered to have a revoked license, signs of intoxication, and admitted to consuming "a few" Modelos. He was charged with driving under the influence with a blood alcohol content above .2, driving while revoked, and reckless driving. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

## **CHARLIE ZONE**

#### **ASSAULT**

Dominos, 2606 Richmond Highway, a deputy responded to a real pizza work during a Dominos disturbance. The juvenile victim advised he was assaulted by a now "former" friend. This slice of action was caught on camera and resulted in property damages to the business that would cost some serious dough. Luckily, bystanders intervened to separate the two (2) juveniles. The deputy located the juvenile suspect and submitted criminal complaints for assault and battery, as well as, destruction of property.

#### **FRAUD**

Whitsons Run, a deputy responded to a fraud. The victim advised "Albert" with her bank's Fraud Department gave her a call. "Albert" claimed the victim's account had been hacked and in order to protect the victim from further harm, "Albert" instructed her to transfer money into an account he had access to.

Potomac Drive, a deputy responded to a fraud. The victim advised she received notification about potentially fraudulent charges. After confirming the suspected charges were not hers, she received a call from "Jason" from her bank's Fraud Department. The lying "Jason" would request important information regarding her account. When the victim realized the scam, she hung up and properly informed her real Fraud Department.

#### **BREAKING AND ENTERING**

Jousting Court, deputies responded to a breaking and entering. The victim's advised they arrived home and noticed signs of a forced entry. After conducting a safety sweep of the residence, it was discovered multiple personal items were stolen. The next night, the victims were home when someone attempted to forcefully enter the residence. The investigation is ongoing.

#### **DISTURBANCE**

Breakers Edge Court. Deputies received a call of a shooting. The caller advised her boyfriend just shot her. Deputies responded to the address the caller provided only to discover she provided the wrong address. Deputies made contact with the boyfriend and the correct address and discovered no such shooting occurred. A deputy located the caller, who advised she made the false claim "out of anger." The caller was issued a permitted warrant for providing a false police report.

#### DUI

Chick-Fil-A, 30 Wyche Road, a deputy was at the intersection of Courthouse Road and Wyche Road. While traveling through the intersection with the green light, another vehicle with no headlights on ran the red light and drove directly towards his vehicle. The deputy avoided a crash and conducted a traffic stop. The driver had overwhelming signs of intoxication and a graveyard of White Claws within the vehicle. During the field sobriety tests, the driver would attempt to flee on foot. That behavior was quickly corrected. She was charged with driving under the influence, obstruction of justice, and refusal. She was held at Rappahannock Regional Jail without bond.

#### **LARCENY**

Campers Inn RV, 1132 Richmond Highway, a deputy responded to a larceny. Staff advised seven (7) catalytic converters had disappeared from seven (7) different RVs.

## **DELTA ZONE**

#### **ASSAULT**

Monarch Court, a deputy responded to an assault. The victim advised while playing "chuck it" with his dog in the park an unknown male approached him. The "aggressive" male would assault the victim and attempt to kick his dog. The victim was able to fight the attacker off using a dog toy. The suspect would then walk away without further incident.

#### **LARCENY**

Walmart, 217 Garrisonville Road, a deputy responded to a larceny. The victim advised she left her purse in her vehicle during her shopping spree. When she returned to her vehicle, the purse was gone.

Home Depot, 305 Worth Avenue, a deputy responded to a larceny. Staff reported two (2) hooded hooligans stole a saw, valued at nearly \$450.

Wawa, 920 Wonder Road, a deputy responded to a "loko" larceny. Staff advised a male suspect stole several Four Lokos before fleeing in a white BMW.

Wawa, 920 Wonder Road. While reviewing camera footage of the previous larceny, the deputy uncovered another larceny. This cookie monster was observed stealing chocolate chip cookies before fleeing in a Nissan Xterra.

#### **VANDALISM**

Boxelder Drive, deputies responded to a vandalism. The victim advised a family member was upset that his green leafy items had been thrown out. In response, the suspect threw a rock through her window. He was charged with felony destruction of property.

#### **THREATS**

Cutstone Drive. Deputies responded to a possible bomb threat. The reporting parties advised a known juvenile made statement about "planting a bomb." Deputies made contact with the juvenile who advised it was "a stupid joke." This so-called joke had no one laughing and a criminal complaint for threats to bomb was submitted.
