## WEEKLY CRIME REPORT

# ALPHA ZONE

## **DUI**

The intersection of Warrenton Road & International Parkway, deputy was traveling on Warrenton Road when he observed a vehicle having a tough time maintaining the lane of travel. The deputy conducted a traffic stop and an additional deputy responded to assist. The driver advised that he had one (1) beer while bowling. Nearby drivers were spared he didn't strike them in his intoxicated state. He was charged with driving under the influence and a traffic lane violation. He was held at Rappahannock Regional Jail on a \$5,000 secured bond.

## **THREATS**

Stafford Lakes Village Subdivision, deputy responded to a threat. An employee with the FBI National Threat Line received information of a bomb threat posted on social media. A deputy made contact with the juvenile who made the threat towards a school. A criminal complaint for felony threat to bomb a school was filed and she was detained at the Juvenile Detention Center.

## **DUI**

Wawa, 9 South Gateway Drive, deputy was traveling in the area when he observed a vehicle make a traffic lane violation. The deputy conducted a traffic stop as an additional deputy responded to assist. The driver had clear signs of intoxication, admitted to consuming alcohol prior to driving, and had an open can of beer sitting next to him. The driver was charged with driving under the influence, drinking and driving, and obstruction of justice. He was held at Rappahannock Regional Jail.

## **WEAPON OFFENSE**

Truslow Road, deputy conducted a traffic stop on a vehicle for failing to obey a stop sign. During the traffic stop, the deputy discovered two (2) of the occupants were carrying firearms in a concealed fashion. One of the occupants was also discovered to be in possession of marijuana. Both received a summons for carrying a concealed weapon. Possession with intent to distribute marijuana charges are pending.

## **ASSAULT**

Kendrick Court, deputy responded to an assault. It was discovered the victim had a guest at his residence when that guest left for the liquor store. The suspect came back after consuming something stronger than Ben Affleck's favorite Dunkin' Donuts coffee and began being aggressive. During a disagreement, the suspect bit the victim multiple times. She was charged with public intoxication, as well as, assault and battery.

## **DRUGS**

I-95 Southbound at mile marker 132, deputy conducted a traffic stop on a vehicle as a second deputy responded to assist. The driver was discovered to be impaired while the passenger was discovered to be wanted out of Stafford County for multiple capiases. Just like Usher's halftime performance, the surprises kept coming as both were found to be in possession of controlled substances. The driver was charged with DUI, and two counts of possession of controlled substances. The passenger was charged with possession of controlled substances, as well as, served on his outstanding warrants. He was held without bond.



# BRAVO ZONE

## **BREAKING & ENTERING**

Perry Drive, deputies responded to a breaking and entering. The victims advised they came home and discovered the residence rummaged through. Cash and jewelry were taken.

## **LARCENY**

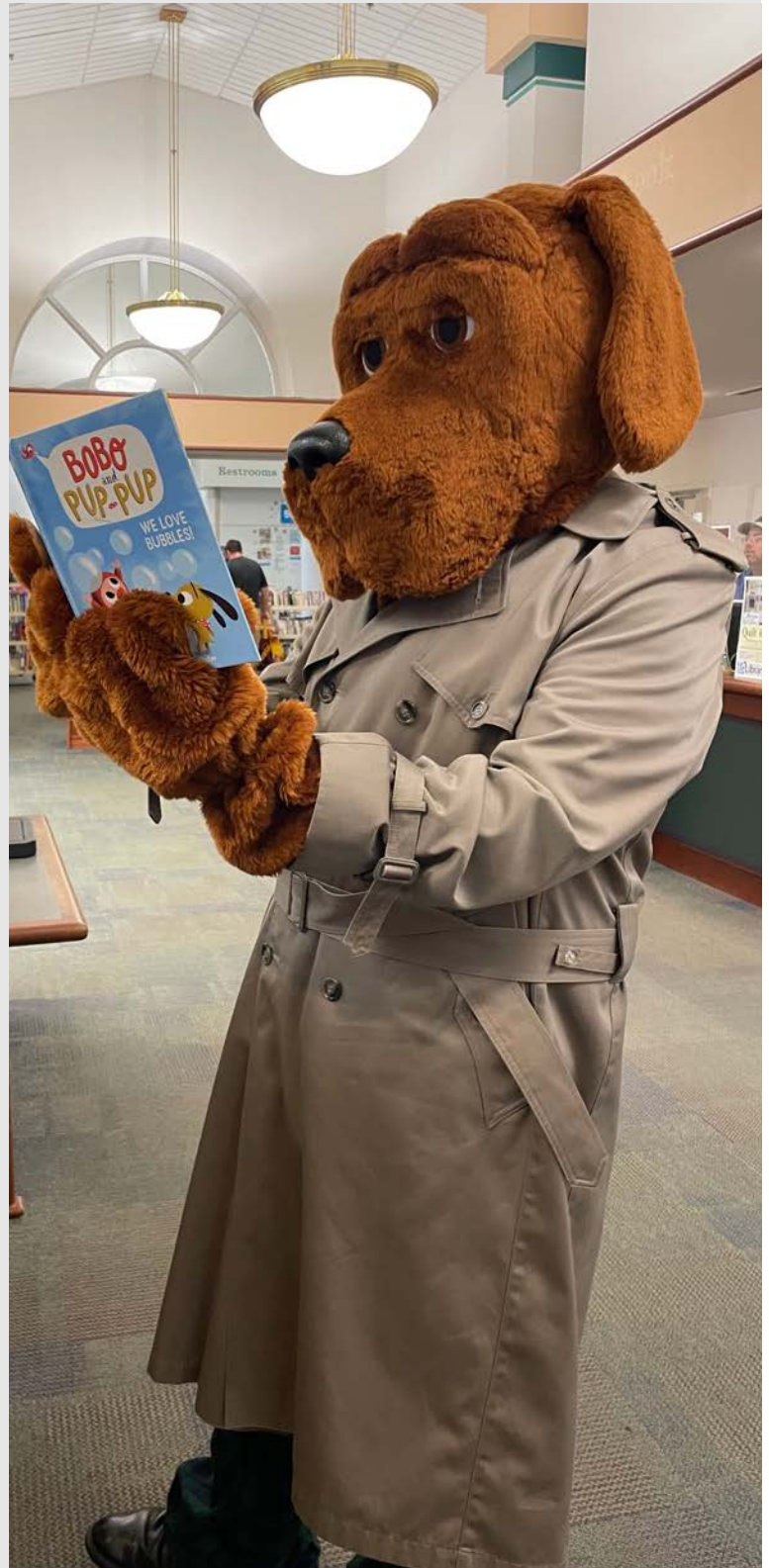
Walmart, deputy responded to a larceny. The victim advised their son accidentally left an iPad in the business. Quicker than a Patrick Mahomes throw, a female suspect took the iPad and fled the area.

## **HIT AND RUN**

Wawa, deputy responded to a hit and run. The victim advised their vehicle was hit harder than a 49ers linebacker. The suspect vehicle, a gray Toyota 4 Runner, then fled the scene.

## **TRESPASS**

Amazon, deputies responded to a disturbance. Staff advised they wanted an employee trespassed for refusing to leave and being hostile towards others. Deputies made contact with the suspect and informed him he needed to leave. Instead of calling a friend like State Farm Agent Schwarzenegger for a ride, the suspect continued to refuse to leave. Deputies attempted to detain him when he began resisting. The 18-year-old was also discovered to be in possession of tobacco products. He was charged with trespassing, obstruction of justice, and unlawful possession of tobacco.



# CHARLIE ZONE

## **ASSAULT**

Brooke Point High School, deputy was conducting his SRO duties when he was informed of a fight. Three (3) male students got into a fight and needed to be separated by staff. Criminal complaints for assault and battery were filed for two (2) of the juveniles involved, a warrant for assault and battery is pending for the 18-year-old involved.

Rappahannock Regional Jail, deputy responded to an assault. While many cameras were pointed at Taylor Swift, jail cameras captured an inmate assaulting another inmate over a disagreement about food. Charges are pending.

## **LARCENY**

Wind Ridge Drive, deputy responded to an attempted larceny. The victim advised her vehicle was unlawfully entered and her ignition was tampered with in an attempt to steal the vehicle.

## **WARRANT SERVED**

Wawa, deputy was in the area for a disturbance when he made contact with a woman. When he discovered she was wanted, he attempted to detain her. While she resisted, eventually she was placed into handcuffs. She was served on her outstanding warrant and was held at Rappahannock Regional Jail on bond.

## **LARCENY**

Black Optix Tint, deputy responded to an attempted larceny. The victim advised a known party tampered with his vehicle and tried to steal one of his tires. The suspect quickly fled when the victim noticed. The investigation is ongoing.

Mega Auto Outlet, deputy responded to a vehicle larceny. Staff advised a suspect got into a BMW and drove through the line of scrimmage to exit onto Richmond Highway. Before reaching the end zone, the suspect struck another BMW. The stolen vehicle has been entered into a national database and the case is under investigation.

## **VANDALISM**

Bass Drive, deputy responded to a report of vandalism. The victim advised the window of his vehicle had been smashed.

## **PUBLIC INTOXICATION**

Jay's Sports Lounge, deputy responded to an intoxicated person call. Staff advised a heavily intoxicated customer was currently lying outside the business. Deputy made contact with the suspect who was more intoxicated than Kansas City fans last night. When asked for his name, the suspect stated his name was "yup." It was discovered to not be. He was arrested for public intoxication; however, this play would go into overtime. At Rappahannock Regional Jail, the suspect was discovered to be in possession of suspected controlled substances. He was additionally charged with felony by prisoner and held pending his ability to participate in a bond hearing.

# DELTA ZONE

## **TRESPASS**

7-Eleven, deputy responded to a trespass call. Staff advised a known male who had been previously trespassed returned. When asked to leave, the suspect said some not-nice things to staff. Deputy obtained a warrant for trespassing.

## **VANDALISM**

North Stafford High School, deputy was conducting his SRO duties when he was informed of a vandalism. Staff advised a restroom had been vandalized with graffiti.

Stefaniga Road, deputy responded to vandalism. The victim advised her mailbox was destroyed. The deputy was able to determine the mailbox murder was done by a vehicle moving at a high rate of speed.

## **LARCENY**

Circle K, deputy responded to a larceny. Instead of betting on the big game, an employee decided to test her luck by stealing nearly \$400 worth of lottery tickets. Charges are pending.

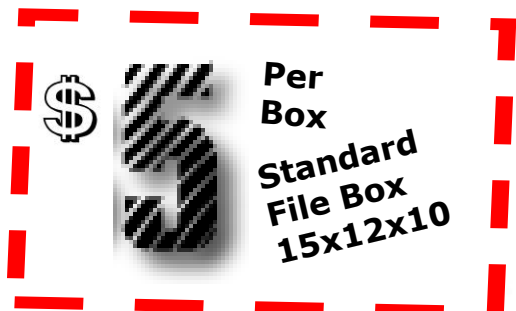

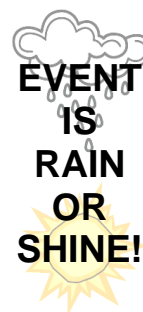
