# ALPHA ZONE

## **DUI**

Wawa, 9 South Gateway Drive, deputies responded to a driver disturbance. The caller advised a female was slumped over the wheel in the parking lot. Deputies arrived on-scene and observed the slumbering suspect still in her running vehicle. When the driver woke up, deputies observed signs of intoxication. The driver would admit to consuming two (2) drinks while working behind the bar. From working behind the bar to being placed behind bars, she was charged with driving under the influence 2nd offense within 10 years. She was held at Rappahannock Regional Jail on a secured bond.

## **PUBLIC INTOXICATION**

Basalt Drive, deputy responded to wrestle mania. Dispatch receiving a call from a residence where yelling could be heard shortly before the call ended, a deputy arrived on-scene of the unknown problem to uncover what occurred. It was discovered the suspect, in an intoxicated state, "accidentally" called 911 while wrestling with another family member. The match was decided when the suspect was arrested for public intoxication and held at Rappahannock Regional Jail until sober.

Mr. Tire, 50 Sebring Drive, deputies responded to a disturbance. The female caller advised she had been "smoking crack" and was assaulted. Deputies made contact with the female, who had signs of intoxication, and admitted to have been "partying tonight." While there were no grounds for assault there were grounds for the crack allegation, for she was found in possession of suspected controlled substances. She was charged with public intoxication and possession of controlled substances. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.

## **VANDALISM**

Malvern Lakes Circle, a deputy responded to a damaged Dodge. The victim reported her vehicle had its windshield broken.

Berea Fire Station, 20 Sebring Drive, deputy responded to a vandalism. Two (2) vehicles were unlawfully entered. Luckily, nothing was stolen.

## **HIT AND RUN**

Quality Inn, 543 Warrenton Road, a deputy responded to a hit and run. A semi-truck driving recklessly on Southbound Warrenton Road caused an accident between two (2) other vehicles



# BRAVO ZONE

## LARCENY

Ficklen Road, a deputy responded to a larceny. The victim advised the keys to his vehicle were accidentally left in the vehicle and subsequently stolen. The Stafford County Sheriff's Office wants to remind everyone to take it, hide it, lock it, or lose it.

Ferry Road, a deputy responded to another larceny. The victim advised she couldn't find her wallet. While retracing her steps, the victim received a call from her bank regarding the fraudulent use of her credit cards.

YMCA, 212 Butler Road, a deputy responded to a larceny. The victim advised when she returned to her vehicle she discovered a broken window. She would further discover her purse was stolen.



# CHARLIE ZONE

## **PUBLIC INTOXICATION**

Brooke Road, a deputy responded to yet another unfortunate Uber situation. The Uber driver advised his passenger was on the hood of his vehicle and refused to get off. The deputy made contact with the suspect, who advised he was “definitely still drunk,” though that was pretty apparent by the signs of intoxication and his shirt being inside out. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **DUI**

Truslow Road, a deputy responded to a ditch driver. The caller advised a vehicle was in a ditch and multiple people were attempting to push it out. The deputy arrived and made contact with the driver, who had signs of intoxication. It was discovered the driver overshot his path while attempting to back the vehicle out of the driveway. It was also discovered the driver had no driver’s license and consumed “five to ten” Modelos. Whether it was “5” or “10”, it was still way too many. The driver was charged with driving under the influence and driving without a license. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

Masters Drive, a deputy was on an unrelated call when a vehicle rolled by. The driver and the deputy engaged in a light conversation when the driver advised she was “decompressing” after work. After field sobriety tests, the driver was charged with driving under the influence.

Area of Richmond Highway and Sage Lane, a deputy was traveling Southbound on Richmond Highway when a Toyota caught his attention. It would catch his attention due to it traveling Northbound in the Southbound lanes. While the Toyota corrected that before the deputy could conduct a traffic stop, the vehicle was observed swerving. Despite the deputy explaining the reason for the stop and noticing signs of intoxication, the driver advised “I’m good sir.” He was not in fact “good.” The driver was charged with driving under the influence, driving on the wrong side of the road, and refusal.

## **LARCENY**

Sykes Warehouse, deputy responded to a fueled-up fuel larceny. Camera footage showed a male suspect stealing a fuel pump from a 500-gallon fuel tank.

Sheetz, 15 Wyche Road, deputies responded to a larceny. Staff advised a group of males wanted to do “the Dew” and stole some Mountain Dew before fleeing in a vehicle. Thanks to the unique rear damage on the suspect vehicle, deputies were able to locate the getaway vehicle and conducted a traffic stop. The stolen Dew was still in the vehicle and all three (3) were charged with shoplifting.

## **ASSAULT**

Rappahannock Regional Jail, a deputy responded to an assault. An inmate was assaulted by another inmate after a disagreement on “jail stuff.” The predominant aggressor would receive additional “jail stuff” when he was issued a warrant for malicious wounding. The victim was treated for his minor injuries at a nearby hospital.



# DELTA ZONE

## **BREAKING AND ENTERING**

Advance Auto Parts, 444 Garrisonville Road, deputies responded to a business alarm. When deputies arrived, they observed obvious signs of a break-in. Staff was contacted and the investigation is ongoing.

## **LARCENY**

ABC, 1630 Publix Way, a deputy responded to the case of the missing tequila. Staff advised they noticed a Don Julio bottle missing and checked their camera footage. Camera footage unveiled a male suspect who stolen the bottle two hours prior to discovery.

Kohl's, 1220 Stafford Market Place, a deputy responded to a shoplifting duet report. Staff advised two (2) female suspects stole over 100 makeup items. The beauty school drop-outs were caught on camera.

Hedgeapple Court, a deputy responded to a larceny. To fight the extreme cold, the victim turned on her vehicle to get it warm and placed her belongings inside. She would then go back into her residence to finish getting ready. When she returned to her vehicle, one of her bags was gone.

7-Eleven, 378 Garrisonville Road, a deputy was at the business when he discovered a larceny that recently occurred. A male suspect, hoping for a fun and safe night, stole a box of condoms.

Petco, 309 Worth Avenue, a deputy responded to a "ruff" larceny. Staff advised a male and female duo stole over \$220 worth of dog food.

## **WEAPON OFFENSE**

1400 block of Garrisonville Road, a deputy responded to a raging rider report. The victim advised while traveling Eastbound, a Kia attempted to pull in front of him. When he voiced his concern by honking the horn, he observed the suspect driver "cock a gun." The investigation is ongoing.





# SCAM-AWARE



**VICTIM** arrived at the Sheriff's Office to turn herself in for missing court. The victim had received a call from "Sergeant Staples" advising she missed court and the fake Sergeant demanded the victim pay a fee using Zelle. When the payment didn't go through, she came to turn herself in. The deputy informed the victim that "Sergeant Staples" was not a real Sergeant with the Stafford County Sheriff's Office and she had almost been a victim of a scam.

Our mission is to build trust, build better relationships and breakdown barriers as we all strive to make our community of Stafford County a community of one.





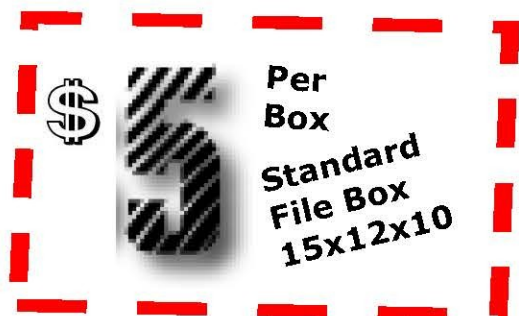
