ALPHA ZONE

LARCENY

Walmart, deputy responded to a larceny. Staff advised they stopped a male who attempted to steal 37 football cards. Just like the Washington Commanders, the suspect was not successful, and was issued a summons for shoplifting.

UNLAWFUL ENTRY

Goldcup Drive, deputy responded to an unlawful entry call. The victim advised they had video of a male entering their vehicles and stealing items.

Goldcup Drive, deputy also responded to an unlawful entry call. The victim also had video of a male entering their vehicles, but nothing was taken. Both video footage shows the same suspect

DRUGS

Warrenton Road Commuter Lot, deputy observed a vehicle run a stop sign and conducted a traffic stop. During the traffic stop, Deputy Pearce discovered one of the passengers was in possession of suspected controlled substances. The suspect admitted he was on his way to sell the controlled substances. The suspected controlled substances were seized and the suspect was charged with possession of controlled substances, as well as, possession with intent to distribute controlled substances. He was held at Rappahannock Regional Jail without bond.

PUBLIC INTOXICATION

Walmart, 2:09 a.m. Deputy responded to a disturbance. Staff advised there was a female yelling and refusing to leave. The deputy made contact with the suspect, who in an intoxicated state, advised she was there to get a ponytail. Her hairstyle choice would have to wait for she was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Days Inn, deputy responded to a disturbance. The caller advised there was a female yelling while in the parking lot. The deputy made contact with the suspect, who advised there was a male in the sewer. While Pennywise was not observed, the deputy did observe several signs of intoxication. While being placed into custody, the suspect began acting belligerently and suspected controlled substances were located. She was charged with public intoxication and possession of controlled substances. She was held at Rappahannock Regional Jail without bond.

BRAVO ZONE



WARRANT SERVED

Ferry Road, deputy attempted to locate a wanted female. She was wanted out of Stafford County for two capiases. When the deputy arrived, the suspect attempted to hide, but was unsuccessful. She was also located with suspected controlled substances on her person. She was served on her outstanding warrants and was held at Rappahannock Regional Jail without bond. Charges for the suspected controlled substances are pending.

VANDALISM

Pendleton Road, deputy responded to a vandalism. The victim advised a known party damaged her Mercedes after a discussion about money. Due to the total damages, the deputy obtained a warrant for felony vandalism.

CHARLIE ZONE



DRUGS

Rappahannock Regional Jail, deputy responded to a drug activity call. Jail staff advised a female was brought in by a neighboring jurisdiction for a probation violation. Upon searching the suspect, staff discovered suspected controlled substances. She was charged with possession of controlled substances, and felony by a prisoner. She was held without bond.

TRAFFIC OFFENSE

Brooke Road, deputy observed a vehicle with no inspection sticker. The deputy conducted a traffic stop and made contact with the driver. It was discovered the driver had no insurance, had a suspended license, and was in possession of a concealed firearm. He was issued summonses for driving without insurance, driving while suspended, no inspection, and carrying a concealed weapon.

LARCENY

Coral Reef Court, deputy responded to a larceny. The victim advised his vehicle was stolen. Later on into the deputy's shift, the unoccupied vehicle was located.

7-Eleven, deputy responded to a larceny. Staff advised a female wearing a "God is dope" hoodie stole from the business before leaving in a Toyota Corolla. Using video footage of the larceny, the deputy was able to identify the suspect and made contact with her. She was issued a summons for shoplifting.

VANDALISM

Wind Ridge Drive, deputy responded to a vandalism. The victim had a window of his vehicle shattered.

Wind Ridge Drive, deputy also responded to a second vandalism. The victim also had a window of his vehicle shattered. In both cases on Wind Ridge Drive the vehicle targeted was Hyundai.

DELTA ZONE

DISTURBANCE

Park Ridge Subdivision, deputy responded to a disturbance. A neighbor advised he believed a juvenile party was occurring. When the deputy arrived and looked through the open door, he observed a party much like a scene from the movie Sixteen Candles, complete with beer pong, marijuana, and juveniles. Criminal complaints for unlawful possession of alcohol and underage possession of marijuana were filed for the juvenile hosting the party at his residence. The other 12 partygoers were turned over to a responsible guardian.

EMBEZZLEMENT

Best Buy, deputy responded to an embezzlement report. Staff advised an employee stole over \$3,500 worth of items over the course of three months. The juvenile suspect admitted to the embezzlement and returned all the stolen items. A criminal complaint for embezzlement was filed.



SCAM-AWARE


A well-known scam involving individuals impersonating law enforcement over the phone is on the rise in Stafford County.

Recently, deputies have responded to multiple reports involving the suspects obtaining money by false pretenses. The suspects identify themselves as deputies with the Stafford County Sheriff's Office and inform the victim they missed jury duty. In order to avoid being arrested, the suspect gives directions to the victim to transfer money into Bitcoin and send it to them. Many times, the suspects spoof their number in order to make it look like our non-emergency number.

Scams like these play on the victim's emotions and demand they be quick or face legal action. As a reminder, no law enforcement agency, including the Stafford County Sheriff's Office, will demand money over the phone. We also do not accept Bitcoin as any kind of payment in any matters. If you are ever unsure about the sincerity of a call from someone posing as a deputy, hang up and call us directly. We will be able to properly inform you if you are wanted.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest.
