

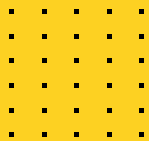

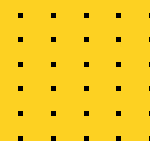
WEEKLY CRIME REPORT

ALPHA ZONE



PUBLIC INTOXICATION

Stephanies Way, deputy responded to a disturbance. It was advised a female was yelling in the street. The deputy was able to quickly locate the suspect and made contact with her. The suspect, in an intoxicated and irate state, blamed everything on a male who wasn't on the scene and in frustration, began assaulting the deputy's cruiser. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

ASSAULT

Malvern Lakes Circle, a deputy responded to a disturbance. It was discovered a male suspect broke the victim's cellphone. This resulted in a verbal disagreement that escalated when the suspect assaulted the female. He would also brandish a firearm towards friends of the victim during the ordeal. The suspect was detained by deputies and charged with malicious wounding, two (2) counts of assault and battery, destruction of property, and brandishing a firearm. He was held at Rappahannock Regional Jail without bond.

HIT AND RUN

Taylors Hill Way, a deputy responded to a "murdered" mailbox. The victim advised she was working in her residence when she heard a clatter. When she sprung up to see what was the matter, she observed her mailbox had been shattered. What a disaster. The thrasher, a black Jeep, would then take off in a less-than-professional manner.

DUI

Liberty Hall Drive. Dispatch received a dangerous drunk driver report. The caller advised an Audi had verged off the roadway into the grass during its travel. The Audi became even more dangerous when it swerved into oncoming traffic. The caller provided live updates as deputies arrived to make contact with the suspect. The driver, who was "running regular errands" had some regular signs of intoxication, like the odor of an alcoholic beverage coming from her breath. She would further advise she "supposedly" had some wine prior to starting her errands. The next item on the to-do list was to charge her with driving under the influence and refusal. She was held at Rappahannock Regional Jail until sober.

THREATS

Amazon, 181 Centreport Parkway, a deputy responded to a threats report. Deep in the Amazon, two (2) staff members received threatening messages from a recently fired employee. Because of these texts, a warrant for threats of death and threats to bomb was obtained. Unfortunately, the suspect wasn't done. At approximately 1:04 p.m., the deputy would respond to another threat report. Using a different phone now, the suspect continued to threaten an employee. An additional warrant for threats of death was obtained.

BRAVO ZONE

ASSAULT

Chatham Heights Road, a deputy responded to an assault. It was discovered the victim was assaulted by a known male after a difference in opinion. The suspect would flee the scene before the deputies' response. Luckily, a stranger witnessed the assault and also reported it to the deputy, and he was able to locate the suspect later on and charged him with assault and battery.

LARCENY

Duff McDuff Green Memorial Park, a deputy responded to a vehicle break-in. The victim advised she was walking her dog in the park. When she returned to her vehicle, a window was broken and her purse was stolen.

DUI

Kings Highway, a deputy responded to yet another drunk driver complaint. During rush hour, a Honda was "all over the road" and even having a hard time staying on the road. The deputy located the all-terrain driver and made contact with him. Based on his signs of intoxication, admission to consuming alcoholic beverages, and the open case of beer in his vehicle, it was clear he shouldn't be driving on any terrain. He was charged with driving under the influence with a blood alcohol content above .2. He was held at Rappahannock Regional Jail without bond.

Anderson Drive, a deputy was traveling in the area when he observed a mud-covered truck stopped in the roadway. Deputies made contact with the driver. The driver advised he was working on his truck and it was having "problems." The only problem noticed was the 20-year-old driver had signs of intoxication. He would admit to consuming beer before testing out his truck. He was charged with driving after illegally consuming alcohol and stopping on the highway. He was held at Rappahannock Regional Jail until sober.



CHARLIE ZONE

LARCENY

ABC, 2757 Richmond Highway, a deputy responded to a liquor loss. Staff advised they observed two (2) males steal several "top-shelf" bottles. A witness advised the two got into an older model black F-150 "with trash in the bed."

Wawa, 860 Richmond Highway, a deputy responded to a larceny. Staff advised they noticed two (2) suspects stuffing their pockets with goods. With pockets full of goodies, the suspects quickly fled in a blue Nissan Sedan.

7-Eleven, 3623 Richmond Highway, a deputy responded to a larceny. Staff advised a male suspect stuffed merchandise in his pants. When staff informed the suspect that they would call the cops, the suspect hustled back to his Mazda and fled.

Sheetz, 15 Wyche Road, deputies would also respond to an unlawful alcohol fan. From Buzz Balls to Fireballs, staff advised a female suspect had the makings of a wild night as she passed all points of sale with the stolen drinks.

Sheetz, 15 Wyche Road, a deputy would also respond to Sheetz for a larceny. Staff advised a cell phone belonging to the business was stolen. Using camera footage the deputy was able to identify the cellular criminal and obtained a warrant for larceny.

TRAFFIC OFFENSE

2800 block of Richmond Highway, a deputy was in the area when he conducted a traffic stop on a vehicle for an expired inspection. The driver, coming back from the dentist, turned out to have a revoked license due to a previous DUI. While having a pearly white smile is important, so is obeying the law. The driver advised he knew he should not be driving, but thought he wouldn't get caught. Turns out he was wrong. The driver was charged with driving while revoked and having an expired inspection.

ASSAULT

Rappahannock Regional Jail, a deputy responded to a fight. It was discovered that Inmate 1 picked a fight with Inmate 2. Unfortunately for inmate 1, inmate 2 used to box and was able to defend himself until jail staff separated both parties. Inmate 1 was treated for his minor injuries and received a warrant for assault and battery.

Potomac Crest Circle, a deputy responded to an assault. It was advised the victim and suspect were engaged in a conversation while drinking. The conversation escalated when the suspect assaulted the victim. The assault was witnessed and captured on camera. The suspect was charged with assault and battery, as well as, strangulation. He was held at Rappahannock Regional Jail without bond.

DELTA ZONE

ASSAULT

North Stafford High School. First thing in the morning, the deputy was conducting his SRO duties when he observed a fight. With the help of staff, both parties were separated. It was discovered the two agreed to fight each other the night before. A criminal complaint for assault and battery was filed for both of them.

BREAKING AND ENTERING

Ripley Road, a deputy responded to an unlawful entry. The victim advised he was watching camera footage of his residence when he observed his ex-girlfriend make her way inside. Once inside, she would make herself at home and go through his stuff. A releasable warrant for unlawful entry was obtained and served on the suspect.

LARCENY

Wawa, 920 Wonder Road, a deputy responded to a "truly" hard larceny. Staff advised a female suspect stole a case of Truly Hard Selzer. This early morning wild berry fan would eventually be identified by a deputy with the help of business cameras. A warrant for larceny was obtained.

Buffalo Wild Wings, 1050 Stafford Market Place, a deputy responded to a dine-and-dash. Staff advised a male suspect, trying the limited-time-only Maple Chipotle wings, left without paying his \$80 tab. The suspect may have left with a full belly, but not a full pocket for he left his hotel key at the business. With this clue, the deputy was able to locate the suspect at a nearby hotel. A releasable warrant for defrauding a restaurant was obtained and served.

Walmart, 217 Garrisonville Road, a deputy responded to a Lego larceny. Staff advised a male suspect stole nearly \$100 worth of Legos. Brick by Lego brick, a case is being built.

PUBLIC INTOXICATION

Hulvey Drive, a deputy responded to an early morning visit. The caller advised three (3) unknown males were on their doorstep. The deputy made contact with these three musketeers and discovered all of them were intoxicated. All were charged with public intoxication and held at Rappahannock Regional Jail until sober.

VANDALISM

One Life Fitness, 315 Garrisonville Road, a deputy responded to a vandalism. While the victim was going "buff" and beyond with his bicep curls, his vehicle was keyed.

Our mission is to build trust, build better relationships and breakdown barriers as we all strive to make our community of Stafford County a community of one.



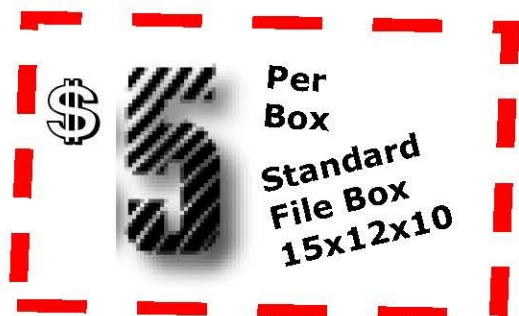
