WEEKLY CRIME REPORT

ALPHA ZONE

LARCENY

Wawa, deputy responded to a larceny. Staff advised a male who had been stealing every day for the past few months stole once again today, and they wanted to report it. Using camera footage, deputies were able to identify the suspect and obtain a warrant for shoplifting.

DUI

Simmons Tire Center, deputy was traveling the speed limit on Warrenton Road when an Infinity passed him at a high rate of speed. The deputy conducted a traffic stop on the vehicle and made contact with the driver. The driver blamed his vehicle for his speeds, stating "I can't help how fast it goes." The driver further advised he didn't even notice the deputy's marked vehicle and he had consumed "two beers" prior to driving. The driver was charged with driving under the influence second (2nd) offense in five (5) years. He was held at Rappahannock Regional Jail without bond.

LARCENY

Walmart, deputy responded to a larceny. Staff advised two (2) male suspects stole nearly \$660 worth of electronics. They would then flee in a white Hyundai SUV displaying a stolen license plate.



BRAVO ZONE

DUI

Intersection of Richmond Highway & Centreport Parkway, deputy was traveling on Richmond Highway when he observed a vehicle having a difficult time maintaining the lane of travel. The deputy conducted a traffic stop on the vehicle and a second deputy responded to assist. The driver was confused about whether he was traveling to or from his house. There were clear signs of intoxication witnessed by deputies. The driver was charged with driving under the influence.

LARCENY

YMCA, deputy responded to a larceny. The victim advised her vehicle was broken into and her purse was stolen from it.

PUBLIC INTOXICATION

Old Landing Court, deputy responded to a disturbance. The caller advised a known party was intoxicated during an argument and had left the area. When the deputy arrived, he located the suspect in an intoxicated state in public view. He was arrested for public intoxication. During his free ride to jail, the suspect began smashing the inside of the deputy's vehicle, resulting in damages to the vehicle. He was charged with public intoxication and destruction of property. He was released by the magistrate on personal recognizance.

WARRANT SERVED

Potomac Run Road, deputy conducted a traffic stop on a vehicle. The driver was discovered to have five (5) outstanding warrants out of both Stafford and King George. While detaining the suspect, the deputy observed a concealed firearm. The driver was served on his outstanding paperwork, as well as, charged with carrying a concealed weapon 2nd offense. He was held at Rappahannock Regional Jail without bond.

ASSAULT

Ink Cave, deputies responded to the business for a disturbance with a weapon call. One (1) employee assaulted the victim and brandished a firearm with the help of another employee. The 1st suspect was arrested for assault and battery, as well as, brandishing a firearm. The 2nd suspect was charged with possession of a firearm by a felon. There would be no jailhouse tattoos for the 1st suspect, as he was released by the magistrate. Suspect 2 was held at Rappahannock Regional Jail on a \$1,000 secured bond.

Ink Cave, deputy responded to an assault. The victim advised family and friends were reuniting with someone who had just been released from the magistrate. During the reunion, the victim got in a verbal argument with a female suspect. The suspect would assault the victim in the presence of the victim's juvenile relative. Deputy was able to locate the suspect on Cool Springs Road and detain her. She was charged with simple assault, assault and battery, as well as, contributing to the delinquency of a minor



CHARLIE ZONE

ASSAULT

Cavalier Roller Rink, deputy responded to an assault. Two (2) juvenile females engaged in a verbal argument that escalated into a fight until security could separate both parties. A criminal complaint for assault and battery was filed for both suspects.

BREAKING AND ENTERING

Marathon Gas Station, deputy responded to an attempted breaking and entering. Using camera footage, it was discovered the day prior a white pickup truck arrived at the business after hours. The suspect used multiple tools in an attempt to break into the business, but after numerous fails, left empty-handed.

DUI

Falmouth Car Wash, deputy was traveling in the area when he observed an Acura traveling 54 MPH in a 45 MPH zone with its high beams on dangerously close to another vehicle. The deputy conducted a traffic stop and made contact with the driver and passenger. The driver had clear signs of intoxication, an open container of alcohol, and a revoked driver's license due to a previous alcohol-related incident. The passenger was discovered to be wanted out of Maryland. The driver was charged with driving under the influence 2nd offense within five (5) years, drinking while driving, driving after forfeiture of license, speeding, driving with a revoked license, and failure to dim headlights. He was held at Rappahannock Regional Jail without bond. The passenger was charged with fugitive from justice.

ASSAULT

Stafford High School, deputy was conducting his SRO duties when he was informed of a fight. It was discovered one (1) student was assaulted by four (4) others. The altercation ended when numerous staff members separated the involved parties. All four (4) assaulting students received a criminal complaint for assault by mob.

Stafford High School, deputy was investigating the previous fight when he was informed of yet another. It was discovered student #1 began assaulting student #2. During the incident, student #3 joined in on assaulting student #2. Student #1 received criminal complaints for assault and battery, as well as, assault by mob, while student #3 received a criminal complaint for assault by mob.

Stafford County Courthouse, deputy was conducting his court duties when he heard a disturbance in a holding cell. One inmate assaulted another, resulting in the victim falling back on the metal bench. The victim was transported to a local hospital, while the suspect was charged with malicious wounding.

BOMB THREAT

Ford T. Humphrey Public Safety Building. Communication Officers received a call where the suspect advised she had placed bombs at the Sheriff's Office and Courthouse. Out of an abundance of caution, deputies searched the area yielding negative results. Deputies were able to identify the suspect and placed her under arrest. She was charged with threats to bomb.

DELTA ZONE



DUI

Mountain View Road, deputy responded to a drunk driver complaint. The caller advised a Hyundai was swerving, drove in and out of a ditch, and nearly struck another vehicle. The deputy made contact with the driver after the vehicle parked outside a residence. The driver advised she drank "a lot" and was unable to walk. She was charged with driving under the influence second offense within five (5) years, driving without a license, and driving an unregistered vehicle.

LARCENY

Oakridge Drive, deputies responded to several calls regarding various unsecured vehicles in the neighborhood that had been rummaged through and personal items stolen.

Austin Drive, deputy responded to a larceny. The victim advised at some point in the night, someone entered his vehicle and stole both a compound bow and a 12-gauge shotgun.

ABC Store, deputy responded to a larceny. Two (2) females must have been planning for a fun night, for they stole nearly \$250 worth of tequila. They would then leave the area in a white Volkswagen sedan.

Goodwill, deputy responded to two (2) larcenies conducted by the same two (2) suspects. A male and female stole items from the store, and in the process, were verbally trespassed. They would then return to steal again before leaving finally in a dark SUV.



SCAM-AWARE

Victim stated that he had money stolen from him via an online scam when attempting to purchase a dog. Victim made a payment to "hold the dog". Victim was then requested to pay an additional \$100 to "get the AKC certification for the dog". Victim asked the seller several questions only to determine this had been a scam.
