

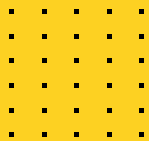

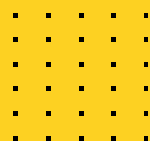
WEEKLY CRIME REPORT

ALPHA ZONE



LARCENY

Royal Farms, 125 Royal Falls Drive, a deputy responded to a larceny. The victim advised he was picked up by a friend and accidentally left his Rick and Morty bag near one of the pumps. After realizing his mistake, he returned to the business to find it was nowhere to be found.

TRESPASS

Royal Farms, 4 Commerce Parkway, a deputy responded to a trespassing. Staff advised a male suspect, who had been previously trespassed, was back. The deputy made contact with the suspect, who advised he was just released from jail on a different trespassing charge. He would be transported back to jail to once again be charged with trespassing.

VANDALISM

Coakley Lane. A deputy responded to a vandalism. The victim had one of his tires slashed. The tire slasher is still unknown.

WARRANT SERVED

Target, 25 South Gateway Drive, Deputies were patrolling the area when they observed an individual they were familiar with. He was currently wanted out of Fredericksburg for a capias. The suspect was detained and discovered to be in possession of suspected controlled substances. He would admit the substance was "a little coke." A little or a lot, he was charged with possession of controlled substances on top of his outstanding warrant. He was held at Rappahannock Regional Jail without bond.

PUBLIC INTOXICATION

Plantation Drive, a deputy responded to an unknown problem. The caller advised there was a male laying under some trees. The deputy located the "bush being" and noticed he had signs of intoxication. Considering he could not recall how he ended up there, deputies charged him with public intoxication and transported him to Rappahannock Regional Jail. He was held until sober.

Cynthias Place, a deputy responded to a loud disturbance. It was advised a male was "arguing loudly" with a female outside. Deputies made contact with both parties and discovered the male was intoxicated. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

BRAVO ZONE

DUI

Kings Highway, a deputy was stopped at the Washington Square Plaza intersection. When the light turned green, the Kia next to him got the sudden need for speed and floored it. On this highway to the danger zone, the Kia reached speeds of 70 MPH and the deputy conducted a traffic stop. The driver had signs of intoxication and advised she consumed "barely anything." Apparently, "barely anything" consisted of beer and an espresso martini. After field sobriety tests, the driver was "espresso-ly" transported to Rappahannock Regional Jail where she was charged with driving under the influence and speeding.

Perth Drive, a deputy responded to an auto accident. The caller advised a possibly intoxicated driver plowed into his parked and unoccupied vehicle. The deputy arrived to locate the vehicles and the wobbly driver. The driver had signs of intoxication and was found to be in possession of a suspected controlled substance. She was charged with driving under the influence, possession of a controlled substance, and reckless driving. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.



CHARLIE ZONE

VANDALISM

Brooke Point High School, a deputy was conducting her SRO duties when she was informed of a vandalism. Staff discovered graffiti on the rooftop. It would seem the culprit needs to pay more attention in class considering the word "education" was misspelled. The investigation is ongoing.

PUBLIC INTOXICATION

Motel 6, 2868 Richmond Highway, a deputy responded to a disturbance. It was advised a male suspect was refusing to leave the lobby. The deputy made contact with the suspect, who not only had obvious signs of intoxication, but was discovered to have an outstanding capias. While he may not have had a room at the Motel 6, he had one at Rappahannock Regional Jail. The suspect was charged with public intoxication and served on his outstanding warrant. He was held without bond.

Sunny Hill Court, a deputy responded to a disturbance. The caller advised he was very upset that a tow truck driver would not remove a certain vehicle from a certain spot. This was because the vehicle had a permit to be there. The deputy made contact with the self-admitted "drunk" caller, who was in view of the public. Due to his signs of intoxication and aggravated state, he was charged with public intoxication and held at Rappahannock Regional Jail until sober.

DUI

Intersection of Richmond Highway and Garrisonville Road, a deputy responded to assist in a traffic stop. The Nissan in question was observed traveling 62 MPH in a 35 MPH zone. The driver had signs of intoxication and admitted to having "a couple of drinks at work." She was charged with driving under the influence and reckless driving. She was held at Rappahannock Regional Jail until sober.

DELTA ZONE

DRUGS

Garrison Woods. Anyone missing their drugs? An unattended bag of suspected controlled substances was located and turned over to the Sheriff's Office. If you lost your drugs in the area, the Sheriff's Office would be interested in having a chat with you.

LARCENY

Walmart, 217 Garrisonville Road, a deputy responded to a larceny. Staff advised a male suspect was concealing items on his person. Deputies were able to locate the suspect pretty easily considering the suspicious outfit of a large winter jacket and ski mask he was wearing. The suspect, who thought the incident was "no big deal," was charged with shoplifting. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

Whitsons Run, a deputy responded to a larceny. The victim advised a package was delivered with the item they ordered removed. After reporting the circumstance, a replacement was sent out, only to be removed again.

Walmart, 217 Garrisonville Road, a deputy responded to a larceny. Despite wearing camouflage, staff observed a female suspect skip-scan multiple items. A warrant for shoplifting was obtained and served on the suspect.

DUI

7-Eleven, 910 Garrisonville Road. Deputies responded to an auto accident. The caller advised they were involved in a minor collision and the other driver was "acting strange." The "strange" and at-fault driver had signs of intoxication and admitted to consuming two (2) shots of vodka prior to getting behind the wheel. He was charged with driving under the influence with a blood alcohol content above .2 and held at Rappahannock Regional Jail without bond.

VANDALISM

Old Mineral Road, a deputy responded to a vandalism. The victim had the rear window of their vehicle smashed out overnight.

SCAM-AWARE

Victim recently started a new contracting job with a small company. The victim would receive an email from email address "ANDRESGYDSMAN@GMAIL.COM" posing as his boss, an Alyce Fernebok. This email had a general introduction and asked for the victim's phone number. The victim provided and received a text from 732-340-8105. The victim and this other individual would text back and forth, with the suspect asking the victim to go to Target and purchase three (3) gift cards for \$200 each. Victim complied as well as continue to updated the suspect on each step in the process, ultimately giving the suspect the card numbers off the back of each card. The suspect would then ask the victim to purchase three (3) additional cards, which the victim was willing to do. However, between getting the first set of cards, valued at a total of \$600, and getting another set, the victim would realize that the person who he was contacting was not his boss and disconnected from the call.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest. Our mission is to build trust, build better relationships and breakdown barriers as we all strive to make our community of Stafford County a community of one.



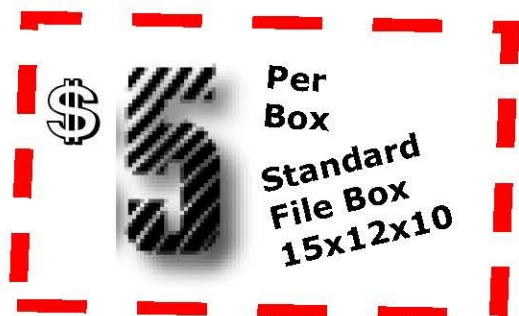
