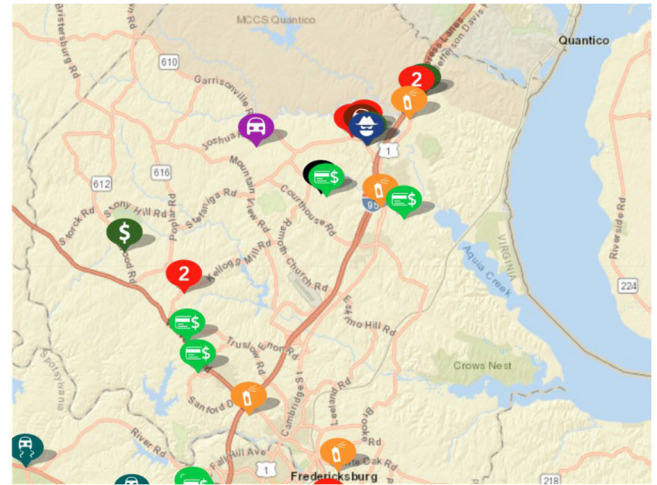

| Fraud: <b>SCAM:</b> Employee received a call from "Lt. James Johnson" with the Stafford County Sheriff's Office, badge number 308103. "Lt. Johnson" proceeded to tell the employee that counterfeit money was being pushed through the business, and to prevent the employee from going to jail they would need to remove all the cash from the register, and deposit it into the account "Lt. Johnson" provided to the employee. Employee proceeded to leave the business, drive to 7-11 and deposit the money. Unfortunately, there was less money in the register than the employee thought, and when "Lt. Johnson" received the deposited funds, called the employee back and yelled at them insisting they make up the difference; employee then deposited \$120 of their own. Once the deposit went through, the employee attempted to call "Lt. Johnson" back, only to find the number had been disconnected. Monetary loss \$537. |                        |          |

| Fraud: <b>SCAM: RENTAL PROPERTY:</b> Victim found a rental for a townhome on Facebook. Victim contacted the point of contact, "Josh Conner", and expressed interest. "Mr. Conner," said he would leave the backdoor of the townhouse open for the victim to see the property; victim completed their walkthrough and decided to rent the townhouse. "Mr. Conner" sent an application to the victim, which was approved, and forwarded to the victim with a request for a deposit of \$2,850; victim sent the deposit through Zelle. When the victim asked for the keys, "Mr. Conner" stated an additional \$400 one-time fee would have to be paid first, victim complied. Victim, again, asked for the keys, and "Mr. Conner" offered special pricing for the 2nd month's rent if the victim were to send an additional \$500. The victim became suspicious and requested the return of all funds, at which time "Mr. Conner" ceased any contact with the victim. The victim found the townhouse listing on a different site and contacted the real estate company directly to find out that "Mr. Conner" does not work for them and the victim had been scammed. Monetary loss of \$3,250. |                          |          |
