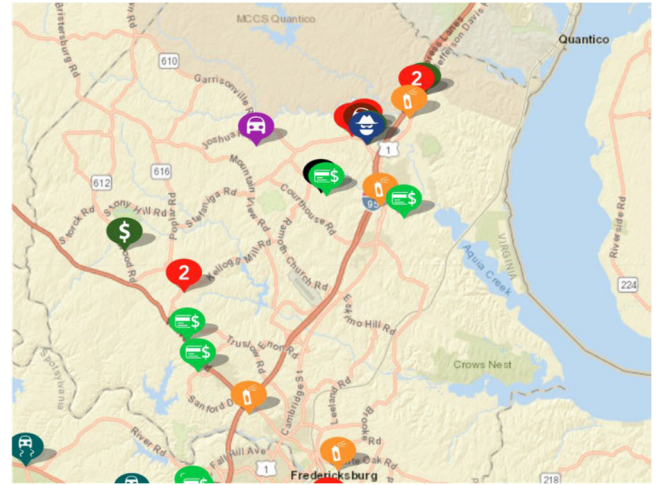

Fraud: Victim's identity was compromised. Unknown suspect attempted to utilize several accounts, but victim had security measures in place to prevent fraudulent charges.

Fraud: <b>SCAM: TEXT:</b> Victim received a text regarding fraudulent activity on their bank account; victim disregarded it as a scam text. Shortly later, victim received a call from an individual identifying themselves as a "representative" of the victim's financial institution. The "representative" stated they had detected fraudulent activity and wanted to lock the victim's account. However, in order to do so, the "representative" required the victim's one-time PIN that she sent via text to the victim's phone. Victim felt this was legitimate and provided the PIN. A few hours later, victim attempted to log onto their account and found they no longer had access to their account. Victim contacted their bank and found they had sustained three (3) fraudulent transfers. Monetary loss of \$12,500.

Fraud: Victim's personal information was compromised and an unknown suspect was attempting to open additional credit card accounts as well as ordering movies on victim's Comcast account. Victim was able to "freeze" their credit before suffering any substantial monetary loss.
