# ALPHA ZONE

## **LARCENY**

Stafford Nursery, 544 Truslow Road, deputy responded to a charged-up larceny. A member of AAA replaced the battery of a vehicle for the suspect. When the conversation of payment came up, the suspect fled in his newly charged vehicle. Deputy was able to identify the suspect who advised he did not have the money "right now." Charges may be sought at a later date.

2900 block of Warrenton Road, deputy responded to a larceny and fraud offense. A company was asked to deliver \$2,700 worth of gravel to this location, and was paid on scene via credit card. The company would receive notification that the payment was unsuccessful due to the credit card being reported stolen.

## **PUBLIC INTOXICATION**

Target, 25 South Gateway Drive, deputy responded to an intoxicated person call. It was discovered a staff member was asked to leave due to his intoxicated state and began yelling at citizens in the parking lot. The deputy located the suspect who advised while he did not consume any alcohol, his ID "might" have some on it. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Worst Deli, 1120 International Parkway, deputy responded to the "worst" call. The caller advised a male was intoxicated and trying to drive. Luckily, the caller took the suspect's keys away. The deputy made contact with the suspect who had signs of intoxication. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **DUI**

Motel 6, 401 Warrenton Road, deputies responded to an unknown problem. The caller advised that the driver of a truck looked "wrong" and his vehicle was off the roadway. When deputies arrived, they located the driver stuck in the mud, both physically and mentally. The 40-year-old would have signs of intoxication, an open container of alcohol, and admitted to consuming roughly three (3) beers before driving. He was charged with driving under the influence and drinking while driving. He was held at Rappahannock Regional Jail without bond.

## **DRUGS**

Warrenton Road in the area of the Southbound I-95 exit ramp, deputy was traveling on Warrenton Road when he observed a vehicle with an expired inspection sticker. The deputy conducted a traffic stop and found that the driver had a suspended license and suspected controlled substances she advised she got from a "client." She was charged with possession of controlled substances and driving while suspended. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.

# BRAVO ZONE

## **PUBLIC INTOXICATION**

Falmouth Post Office, 16 Linchfield Boulevard, deputy responded to an intoxicated-person call. Fire and Rescue staff advised they located an intoxicated male at the business. When the deputy arrived, he observed the intoxicated suspect shove his Four Loko beverages down a storm drain in an attempt to hide them. His sewer scheme was foiled. The suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Bright Beginnings Child Care, 85 Cleremont Drive, deputy responded to an individual not having a "bright beginning." The caller advised there was a female behind the business too intoxicated to stand. When the deputy arrived, he located the suspect amidst a sea of empty alcohol containers. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **LARCENY**

Dominion Power, 1485 Forbes Street, deputy responded to a larceny. Staff advised a padlock, container of copper, and keys to a forklift were stolen sometime overnight.

Amherst Avenue, 7/25, deputy responded to a larceny. The victim advised his catalytic converter was stolen from his vehicle.

Walgreens, 50 White Oak Road, deputy responded to a larceny. Staff advised a female suspect exited the store with unpaid hair dye and a four-pack of premixed margaritas. When the suspect realized that the hair dye wasn't her style, she would return it to the store before consuming all four (4) drinks in the parking lot.





# CHARLIE ZONE

## **DUI**

610 Mart and Tobacco, 395 Garrisonville Road, deputies responded to a drunk driver complaint. The caller advised he observed a male drive to the business in an intoxicated state and begin to urinate in the parking lot. When deputies arrived, the suspect was fast asleep behind the wheel cuddling a bottle of Grey Goose. After his nap, deputies observed signs of intoxication. The suspect would also advise "Yeah I am intoxicated" and demanded to know what deputies would do about it. That question was answered when he was put into handcuffs. He was charged with driving under the influence, driving without a license, refusal, and indecent exposure. He was held at Rappahannock Regional Jail without bond.

Abberly Drive, deputy responded to a suspicious vehicle. The caller advised she saw a running vehicle, which had been in the area for an extended period. When the deputy arrived, he observed the driver asleep behind the wheel with a bottle of Miller High Life in plain view. When the driver woke up, he had signs of intoxication. He was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

## **ASSAULT**

Southern View Drive, deputy responded to an assault. It was discovered there was a disagreement over payment between the victim and two (2) individuals hired for tree stump removal. The victim advised both suspects assaulted him prior to leaving. The victim was transported to a nearby hospital to be treated for his injuries. The investigation is ongoing.

## **PUBLIC INTOXICATION**

7-Eleven, 3623 Richmond Highway, deputy responded to a "trashy" call. An employee advised there was a passed-out male next to the trash can. The deputy made contact with the suspect who advised he drank "a lot." With the assistance of deputies, the suspect got up and was placed into handcuffs. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **DRUGS**

Genesis Logistics, 705 Bradburn Place. If anyone left their controlled substances at Genesis Logistics, the Sheriff's Office is now in possession of them. A deputy made contact with an employee who advised suspected controlled substances were located on the ground. The items were seized for destruction.

Rappahannock Regional Jail, 1745 Richmond Highway, deputy responded to drug activity. Jail staff advised while doing a body scan on a recently transferred inmate, they located a foreign object inside him. The bag was properly removed and discovered to contain suspected controlled substances. The dirty drugs were seized and a warrant for felony by a prisoner was obtained.

## **BREAKING AND ENTERING**

Castlebury Court, deputy responded to an unwelcome guest. The victim advised while doing laundry she discovered an unknown male within her residence. While fleeing, the suspect would push the victim out of the way. The suspect was described as a thin black male, approximately 50 years in age wearing a black hoodie and jeans. There were no signs of forced entry and the suspect was not located.

# DELTA ZONE

## **LARCENY**

Ebenezer Methodist Church, 161 Embrey Mill Road, deputy responded to a sinful act. The commandment "thou shalt not steal" was lost on a suspect who stole a victim's mountain bike while he was inside the church.

Knollwood Court, deputy responded to a stolen vehicle report. The victim advised he woke up to discover his Hyundai Elantra was gone. The deputy entered it as stolen through a law enforcement database and later into his shift was contacted by the Leesburg Police Department who advised they found it.

## **PUBLIC INTOXICATION**

Lakewood Drive, deputy responded to a simple request. A male suspect called dispatch and asked for deputies to "come get him." The deputy would locate the suspect in an intoxicated state. He knew he was intoxicated due to numerous observed signs, as well as, the suspect stated that fact multiple times. The suspect requested to be arrested and deputy did not refuse. The suspect was charged with public intoxication. Due to a pending adjudication in reference to a recent DUI case, the magistrate ordered him to be held at Rappahannock Regional Jail without bond.

Red Roof Inn, 153 Garrisonville Road, deputy responded to an intoxicated person. The caller advised a male was in front of the business under the influence.

## **DISTURBANCE**

Woodland Drive, deputy responded to a noise complaint. The caller advised a pick-up was blasting loud music. When the deputy arrived, he discovered the truck was occupied by a male and an intoxicated juvenile. The male was charged with contributing to the delinquency of a minor and was held at Rappahannock Regional Jail without bond.

## **DUI**

Stafford Wings, 432 Garrisonville Road, deputy responded to a single-vehicle auto accident. While the business is not a drive-thru, one driver drove through a chain link fence. He had signs of intoxication and admitted to consuming whiskey before driving. He was charged with driving under the influence and held at Rappahannock Regional Jail on a \$2,000 secured bond.



# SCAM-AWARE



**The victim** advised she received a call from a “Jeremy Brown” who stated that he worked for the Stafford County Sheriff’s Office. The suspect had advised the victim that she had missed jury duty and needed to pay in Bitcoin so she would not be arrested. “Jeremy Brown” is not an employee with the Sheriff’s Office and the Sheriff’s Office will never request any form of payment over the phone.

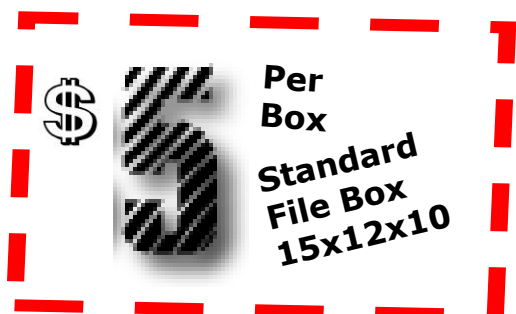
