# WEEKLY CRIME REPORT

### **JUNE 17TH - JUNE 23RD, 2024**

### **ALPHA ZONE**

#### PUBLIC INTOXICATION

Target, 25 South Gateway Drive, deputies responded to an unknown problem. The caller advised that he needed the Sheriff's Office's help locating a Greyhound bus. Deputies contacted the caller, who was singing at the customer service desk. The Nebraska traveler was in an intoxicated state. When deputies attempted to detain him, he resisted. He was charged with public intoxication and obstruction of justice. He was held at Rappahannock Regional Jail without bond.

#### DISTURBANCE

Giant, 550 Celebrate Virginia Parkway, deputies responded to a disturbance. It was advised that a customer was arguing with staff and refusing to leave. Deputies made contact with the suspect who provided a false identity. His real identity was uncovered and deputies learned he was wanted out of Fredericksburg. The suspect attempted to flee from being detained but failed. He was charged with providing a false identity to law enforcement and obstruction of justice. He was also served on his outstanding warrants. He was held at Rappahannock Regional Jail on a \$500 secured bond.

#### DUI

Chestnut Hill Drive, deputies responded to a reckless driver complaint. The caller advised that a white Jeep with a Connecticut license plate had been driving into the curb. Deputies located the vehicle swerving and conducted a traffic stop. The driver, who was on his way to Florida, advised that he had been drinking for the past 10 days. The driver had signs of intoxication and there were two (2) children in the vehicle. He was charged with driving under the influence and two (2) counts of child neglect. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

Mountain View Road, the deputy responded to a single-vehicle auto accident. The caller advised she had gone off the roadway, struck a mailbox, and ended her ride into a pole. Luckily, the driver only sustained minor injuries. The 18-year-old driver had signs of intoxication and admitted to being "probably a little intoxicated." Within the vehicle were multiple open containers of beer and suspected controlled substances were located in her purse. After being released from the hospital, the driver was charged with driving under the influence, driving after illegally consuming alcohol, and possession of controlled substances. She was held at Rappahannock Regional Jail on a \$2,000 secured bond.

#### LARCENY

Amazon, 220 Centreport Parkway, deputy responded to a larceny. The victim advised that a firearm left in his vehicle was no longer there.

#### WEAPON OFFENSE

Dollar General, 20 Plantation Road, deputy responded to a road rage incident. It was discovered that both parties were traveling on Northbound I-95 when words were exchanged. The suspect brandished a firearm towards the victim and, out of fear of his life, the victim attempted to flee and, in the process, struck another vehicle. The suspect was charged with brandishing a firearm and reckless driving. He was held at Rappahannock Regional Jail without bond.

Walmart, 11 Village Parkway, deputy responded to a knife-slinging slasher incident. The victim advised a male suspect, wearing SpongeBob underwear, swung a knife towards him while advising "move out of my way partner." The victim complied and called police. Deputies located the suspect near Royal Farms, located at 125 Royal Falls Drive, still in possession of the knife. He was charged with assault and held at Rappahannock Regional Jail without bond.

#### DISTURBANCE

Kings Highway, deputy responded to a disturbance. It was discovered that a male suspect walking near the highway observed a truck with someone he knew inside. He threw a rock toward the truck, missing and striking a King George County deputy's cruiser. The suspect was charged with throwing a missile at a moving vehicle and was released by the magistrate on personal recognizance.

#### LARCENY

Walmart, 11 Village Parkway, deputy responded to a larceny. Staff advised that they observed a female suspect concealing items in her purse. After a quick review of the store's cameras, it was discovered that the suspect had been at the business since 9:00 a.m. making multiple trips to her vehicle with stolen items each time. She was charged with shoplifting and held at Rappahannock Regional Jail on a \$1,500 secured bond.

Sheetz, 10 Washington Square Plaza, deputy responded to a larceny. Staff advised that a thirsty male suspect stole over \$30 worth of booze.

#### **PUBLIC INTOXICATION**

200 block of Cambridge Street, a deputy was in the area when he observed a male suspect next to the road waving his arms in the air. The deputy then observed the suspect stumbling in the roadway. The suspect had signs of intoxication and the odor of an alcoholic beverage coming from his breath. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

#### ASSAULT

Falmouth Beach, 401 River Road, deputy responded to an assault. It was discovered that the victim had made a comment to a family member and the two (2) nearby suspects believed it was regarding them. The suspects, who are sisters, proceeded to assault the victim before swimming across the river in an attempt to flee. Deputies were able to locate and detain them. One sister was charged with assault and battery and held at Rappahannock Regional Jail on a \$1,000 secured bond while the other, who is a juvenile, received a criminal complaint for assault and battery.

#### DUI

Forbes Street, the deputy responded to a reckless driver complaint. The caller advised that a Chevrolet was having a difficult time maintaining its lane. The deputy located the vehicle as it crossed the double yellow line and the driver flipped the bird to a nearby gas station. A traffic stop was conducted and deputies made contact with the driver, who was in the mood for dancing. The dancing driver had signs of intoxication and admitted to consuming "four sips" of alcohol. He was charged with driving under the influence, refusal, and the traffic lane violation. He was held at Rappahannock Regional Jail until sober.






#### LARCENY

#### LARCENY

AT&T, 1495 Stafford Market place, deputy responded to a larceny. Staff advised three (3) individuals stole phones.

Blacksmith Court, deputy responded to a larceny. The victim advised a known party was refusing to return their vehicle. The vehicle was entered as stolen.

Sheetz, 1175 Garrisonville Road, deputy responded to a larceny. Staff advised two (2) male suspects asked to have items for free. Staff obviously said no and when they did, the two (2) males stole the items. Deputies were able to identify the suspects and made contact with them at a residence in Stafford. Both were issued a summons for larceny.

#### **PUBLIC INTOXICATION**

Shields Road, 6/17, deputy responded to an altercation. The caller advised his family was refusing to give him his car keys. It was discovered they were doing this due to the caller's level of intoxication. When deputies arrived, they located the suspect intoxicated in view of the public. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

#### **SWATTING**

Madison Court. Deputies responded to a disturbance with a weapon. The caller advised there was a little kid with a gun outside the residence. Deputies responded to the area, talked with neighbors, and discovered no signs of a disturbance. It was determined to be a possible swatting attempt.

#### WARRANT SERVED

Wawa, 105 Garrisonville Road, deputy was in the area when he observed a male outside the business. The deputy recognized the male and knew he had an active capias warrant. The suspect would attempt to fool the deputy by providing a false identity, but it did not work. The suspect was charged with falsely identifying himself to law enforcement, identity theft to avoid arrest, as well as served on his outstanding warrant. He was held at Rappahannock Regional Jail without bond.

## **SCAM-AWARE**

**Victim** advised that she and her husband had been on Facebook Marketplace and had found an advertisement for a Honda CRV that was for sale. She used her husband's Facebook and began speaking with a subject who identified herself as Brianna A. Wade from Gary, West Virginia. According to the victim, "Brianna" had gone to the same school in West Virginia with the victim's husband, so they felt they knew each other a little bit. The victim said she and "Brianna" started speaking on Facebook on June 11th, and "Brianna" advised that there were a lot of people wanting the Honda CRV so she would need the victim to make a deposit of \$1500.00 on the vehicle for in order to hold the vehicle for the victim. The victim was provided 2 different phone numbers for her to place the down payment. The First phone number was 480-697-0103, which came back with a name of Mrina Yoladnez Duran, and the second phone number was 217-413-5700, which returned to a Karen Jefferies. The victim had asked for the title of the vehicle to verify that "Brianna" was the owner of the vehicle, but "Brianna" kept making excuses and trying to get more money from the victim. "Brianna" even became somewhat hostile and advised that she would have the victim deported if she did not pay more money and that she needed \$200.00 more in order to send her a refund. The victim began to research about this advertisement on Facebook and found other individuals had discovered that this was a scam.
