


Weekly Crime Report

ALPHA ZONE:

Journeys Way Rivergate 06/19/23

Fraud: SCAM: Victim received a call from an individual stating the victim had won \$2.5 million and a Mercedes Benz. However, victim would need to pay the taxes before delivery of the money and car. Victim was instructed to purchase gift cards valued at \$1,000 and to provide the gift card information to the caller; victim complied. Once disconnected from the call the victim realized it had been a scam and sustained a monetary loss of \$1,000.

King Arthurs Way Manor of England Run 06/19/23

Fraud: Theft of personal items from an unsecured vehicle.

Bluefield Lane England Run 06/19/23

Larceny: Theft of architectural stones from a retaining wall.

541 Warrenton Road Comfort Suites 06/21/23

Larceny: Vending machine broken into and money stolen. Monetary loss of \$784.

541 Warrenton Road Comfort Suites 06/22/23

Larceny: Theft of tools from the victim's truck bed.

2385 Mountain View Road 06/22/23

Fraud: SCAM: PUBLISHER'S CLEARINGHOUSE: Victim received a call informing them of winning a Mercedes Benz, however, taxes would need to be paid prior to receipt. Victim paid over \$10,000 in gift cards before realizing they had been a victim of a scam.

Charter Gate Drive Stafford Lakes Village 06/22/23

Fraud: Victim's business account was compromised and sustained fraudulent charges. Monetary loss of \$737.99.

Norfolk Street Cardinal Forrest 06/22/23

Fraud: Victim's credit card account was compromised and sustained fraudulent charges of \$2,500.

656 Warrenton Road Country Inn and Suites 06/25/23

Larceny: Victim checked out of the hotel, unaware they had left items in their room. Upon their return to retrieve items, they were no longer locatable.

9 South Gateway Drive Wawa 06/25/23

Larceny: Shoplifting.

20 Dunn Drive Umi Japanese Cuisine 06/25/23

Larceny: Theft of victim's wallet when it was accidentally left at the restaurant. Suspect proceeded to use victim's credit cards, and the victim sustained a \$6,005 monetary loss.

Larceny: Theft of a delivered package from victim's front porch.

Fraud: Victim's credit card stolen and sustained several fraudulent charges.

Fraud: SCAM: EBAY: Victim was shopping on eBay for a golf cart and contacted a seller expressing interest in purchasing the golf cart they listed for sale. The seller, 'Rachelle Williams' responded back and said she would expedite the shipping if the victim were to purchase a gift card and provide her with the card information. Victim complied, but each time the victim purchased a gift card, 'Rachelle' would claim it did not go through and the victim would purchase a new card. By the time the victim purchased the fifth card, they realized this had been a scam and each card had actually been activated and the funds transferred. Monetary loss of \$1,000.

Manning Drive Jefferson Place 06/22/23

Fraud: Filing of false police report.

Fraud: Victim's identity was compromised and several fraudulent accounts were established. Monetary loss of \$1,292.41.

Larceny: Theft of trailer from the parking lot.
