WEEKLY CRIME REPORT



JUNE 24TH – JUNE 30TH, 2024

ALPHA ZONE

LARCENY

Walmart, 11 Village Parkway, deputy responded to a larceny. Staff advised that a female suspect, who was very well known to staff, consumed a bottle of wine before paying for it. When deputies informed her that she would be charged and could not simply pay for her mistake, she began to resist arrest. After being detained, suspected controlled substances were located in her possession. She was charged with shoplifting, obstruction of justice, possession of controlled substances, and public intoxication. She was held at Rappahannock Regional Jail without bond.

Carriage Hill Drive, deputy responded to a larceny. The victim advised his speaker and firearm disappeared while a moving company was at his residence. One of the workers was discovered to be the culprit. He was also found to be intoxicated after consuming six (6) beers. He was charged with grand larceny, petit larceny, and public intoxication. He was held at Rappahannock Regional Jail on a \$1,500 secured bond.

Weis, 252 Deacon Road, deputy responded to a larceny. Staff advised they observed a male suspect, who not only is a known shoplifter but had been trespassed previously. While in the store he would conceal Four Loko drinks in his pants. Warrants for trespassing and shoplifting were obtained.

Target, 25 South Gateway Drive, deputy responded to a larceny. Staff advised they observed a female suspect concealing the items. The suspect was stopped and the nearly \$315 worth of items was recovered. She was issued a summons for shoplifting.

VANDALISM

Margaret Brent Elementary School, deputy responded to a report of vandalism. Staff advised they had camera footage of two (2) juveniles destroying potted plants. Both juveniles were identified by prior interactions and criminal complaints for vandalism are pending.

ASSAULT

7-Eleven, 25 Solomon Drive, deputy responded to an assault. The victim advised that her husband's ex-girlfriend had been stalking her since March. The harassment escalated today when the suspect hit the victim with her vehicle. The victim was treated for her injuries and warrants for stalking, hit and run, as well as, attempted felonious assault were obtained.

300 block of Warrenton Road, deputy responded to a weapons offense. Multiple callers advised that they observed two (2) males arguing when one of them brandished a machete. The deputy made contact with the victim who advised the suspect was upset he was in his panhandling spot. The argument escalated when the suspect assaulted the victim and threatened him with his machete. Deputies located the suspect and charged him with brandishing a machete, as well as, assault and battery.

DUI

Excel Inn and Suites, a deputy observed a vehicle make a U-turn at a solid red light and conducted a traffic stop. The driver had signs of intoxication and a revoked license due to a prior DUI conviction. He was charged with driving under the influence while revoked, 2nd offense refusal, and failure to obey a traffic light. He was held at Rappahannock Regional Jail without bond.

BRAVO ZONE

PUBLIC INTOXICATION

Area of Cambridge Street and Manning Drive, deputy responded to a disturbance. A male, who was under the influence, left his vehicle in Louisa and wanted a ride to retrieve it. In an attempt to get a ride, he jumped in front of a vehicle, which happened to be a marked police vehicle driven by a deputy from Spotsylvania. The suspect was given a ride, but not where he requested. He was charged with public intoxication and was held at Rappahannock Regional Jail until sober.

Cherry Laurel Drive, deputy responded to an unknown problem. The caller advised that he observed a passed-out male. The deputy made contact with the suspect who did not know where he was. He would have signs of intoxication and was charged with public intoxication. He was held at Rappahannock Regional Jail until sober.

Brooks Park, 130 Butler Road, deputy responded to a suspicious person call. The deputies made contact with the suspect who had signs of intoxication and provided a false identity. He was arrested for public intoxication and providing a false identity for law enforcement. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

LARCENY

Walmart, 125 Washington Square Plaza, deputy responded to a larceny. Staff advised that a female suspect walked out with approximately \$1,700 worth of items. While the suspect did take multiple items, she did leave behind her suspected controlled substances.



CHARLIE ZONE

DUI

Wawa, 3099 Richmond Highway, deputy responded to a loud altercation. The caller advised two (2) females and a male were having a loud disagreement in a Nissan Altima. The deputy made contact with the parties and observed signs of intoxication from the driver. She would admit to consuming tequila before driving, but could not remember how much. It was discovered that not only did she have a suspended license, but she had a previous DUI charge from 2019. She was charged with driving under the influence 2nd offense within 5 years with a blood alcohol content above .2 and driving with a suspended license. She was held at Rappahannock Regional Jail without bond.

Fas Mart, 2142 Richmond Highway, deputies responded to a drunk driver complaint. The caller advised that there was a female driver "nodding off" behind the wheel. The driver, who advised she just got out of court, had signs of intoxication. The deputy deployed his K-9 partner who alerted on the vehicle and suspected controlled substances were located. The driver was charged with driving under the influence, possession of controlled substances, and driving with a suspended license. She was held at Rappahannock Regional Jail on a \$1,000 secured bond.

Intersection of Richmond Highway and Washington Drive, deputy responded to an unknown problem. The caller advised there was a female asleep behind the wheel. When the deputy arrived, he located the suspect still asleep behind the wheel of a vehicle still in drive with a one-year-old in the backseat. When the driver woke up, she advised she was going to her sister's house after just leaving her sister's house. She further advised she consumed "a beer or two." She was charged with driving under the influence second offense within five (5) years with a blood alcohol content between .15 and .2 with a child present, child neglect, and driving while revoked. She was held at Rappahannock Regional Jail on a \$3,000 secured bond.

LARCENY

Wawa, 72 Austin Park Drive, deputy responded to the second Wawa larceny of the day. Staff advised three (3) suspects attempted to pay for snacks. When their card was declined, instead of putting the snacks back or paying a different way, the group decided to walk out with the items.



DELTA ZONE

PUBLIC INTOXICATION

Flatford Road, deputy responded to a suspicious person call. The caller advised an unknown male was running around their yard. The deputy made contact with the swaying suspect who advised he drank "too much." He was correct. The suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Wawa, 920 Wonder Road, deputy responded to an intoxicated person call. There was a female suspect within the business who had signs of intoxication. It was further discovered the intoxicated female concealed alcoholic beverages, and proceeded to consume them within the bathroom. She was charged with public intoxication and larceny. She was held at Rappahannock Regional Jail on a \$1,500 secured bond.

LARCENY

Publix, 1640 Publix Way, deputy responded to a larceny. The victim advised while shopping for sushi, she noticed her wallet missing from her cart. While taking the report, the victim received notice of unauthorized transactions to her credit cards

Wawa, 15 Eustace Road, deputy responded to a larceny. Staff advised a female suspect just walked out with stolen items. The deputy happened to be in the area, and quickly located the suspect slurping her stolen drink as she walked down Garrisonville Road. The suspect was detained and provided a false identity. She was not in fact the doctor she was claiming to be and it was discovered she was wanted out of Stafford County for a different shoplifting offense. She was served on her outstanding warrant, and additionally charged with shoplifting and providing a false identity to law enforcement. She was held at Rappahannock Regional Jail on a \$500 secured bond.

DUI

Wawa, 1172 Garrisonville Road, deputy responded to a hit and run. The caller advised a vehicle struck a light pole. An off-duty deputy in the area observed the suspect vehicle drive into the Wawa parking lot and the deputy made contact with the driver, who despite having signs of intoxication, advised he consumed "not much" beer. "Not much" was still too much and the driver was charged with driving under the influence and reckless driving. He was held at Rappahannock Regional Jail until sober.

Choptank Road, deputy responded to a disturbance. A Jeep was stopped in the roadway and multiple parties were involved in a verbal argument. It was discovered the driver was driving her friends' home after a day at the beach. As courteous as that is, she was intoxicated and ran out of gas. This resulted in a verbal argument that escalated when the driver assaulted one of the parties. She was charged with driving under the influence, refusal, as well as, assault and battery. She was held at Rappahannock Regional Jail until sober.

VANDALISM

Creek Bank Drive, deputy responded to a nightmare neighbor. The victim advised they hired contractors to fix a partition when a neighbor loudly voiced his disapproval. He would take apart the fence and continuously yell inappropriate things towards the victim and his family, advising they didn't know who they were messing with. The suspect was charged with destruction of property and disorderly conduct.



SCAM-AWARE



Victim received a phone call from 808-425-2209 claiming to be the fraud department with Walmart. The victim was advised that there was an attempted purchase for \$483.50 on his Walmart debit card. They then advised the victim that they would send him a text with a number and he would have to provide the number to confirm his identity. The victim received the text and provided the number. He was then advised that they would conduct a fraud investigation. Shortly after the phone call, the victim received a text message stating that his Walmart account had been changed and to contact them if it was not him. He used the phone number on the back of his debit card and contacted the actual Walmart fraud division. They discovered that there was an attempt to purchase for \$483.50, unsuccessful, but there was an electronic transfer of \$500 that was successful. He told them he did not make the transfer and they froze his account.

Victim received an email stating it was from the computer security company McAfee and they had taken \$500 from his checking account for the annual service fee. The victim called the phone number attached to the email to inform them he did not use their service and he wants his money back. The victim spoke to "Daryl White" who offered to assist with the return of the victim's money, but instead accidentally transferred \$15,000 to the victim's account. "Daryl" stated he needed the money back today and directed the victim to purchase Apple cards to pay the money back. Until the money was returned, "Daryl" had locked the victim out of his computer with a virus. The victim purchased \$4,000 worth of Apple cards and sent them to "Daryl". Luckily, with the assistance of a family member, the victim stopped communicating with "Daryl" and put a "freeze" on all financial accounts.
