ALPHA ZONE


DUI

Kellogg Mill Road, deputy responded to a single-vehicle auto accident; a Ford made contact with a tree. The driver had clear signs of intoxication and admitted to consuming a Four Loko before driving. The driver was charged with driving under the influence and is still being treated at a local hospital.

LARCENY

Advance Auto Parts, 598 Warrenton Road, deputy responded to a larceny. Staff advised a company vehicle had its catalytic converter stolen. Camera footage showed two (2) men committing the theft.

Walmart, 11 Village Parkway, deputy responded to a larceny. Staff advised a male suspect walked out with multiple unpaid items, including a Sonic the Hedgehog blanket. The suspect would then attempt "to go fast while fleeing", but was discovered by the deputy. He was issued a summons for shoplifting.



BRAVO ZONE

ASSAULT

Historic Port of Falmouth, 401 River Road, deputy responded to an assault. Multiple callers advised a female in a red bikini threw a rock at a child not known to her. The depuity made contact with the lady in red and discovered she was intoxicated. The child was taken to a nearby hospital for his injuries while the suspect was transported to Rappahannock Regional Jail. She was charged with assault and battery, as well as, public intoxication. She was held without bond.

Walmart, 125 Washington Square Plaza, deputy responded to an assault. It was discovered a male and female got into a verbal argument when the male struck the female. In an attempt to help the female, another male jumped in to stop the assault, but ended up being assaulted himself. The suspect was located in an intoxicated state. He was charged with two (2) counts of assault and battery, as well as, public intoxication.

PUBLIC INTOXICATION

Ferry Road, deputy responded to a disturbance. The caller had a rude and early wake-up call when someone began banging on her door. The banging was from a woman the caller did not know. The deputy made contact with the suspect who was intoxicated. She was arrested for public intoxication and held at Rappahannock Regional Jail until sober.

CHILD NEGLECT

Cumberland Road, deputy responded to a found child. The caller advised they located a disheveled 7-year-old girl wandering the street. The deputy ensured the child's safety and investigated to identify her parents. After locating and informing the father of the situation he would arrive an hour later. He was issued a summons for child neglect.

DUI

CVS, 450 Chatham Heights Road, deputies responded to a suspicious person call. Staff advised there was a male asleep in his vehicle outside the business. Deputies located the driver asleep behind the still-running vehicle. When the driver awoke, deputies observed several signs of intoxication, including pinpoint pupils. It was also discovered the driver had a revoked license due to a previous DUI. The driver was charged with driving under the influence 2nd offense in five years, as well as, driving while suspended. He was held at Rappahannock Regional Jail without bond.

Pratt Park, 120 River Road, deputy responded to an unknown problem. An intoxicated caller advised there was a disturbance. When the deputy arrived, he observed a Ford F250 parked outside the park gates. The driver advised he didn't know how to get home and his car keys were broken. It was discovered the keys were not broken, it was just a push-to-start vehicle. The driver had signs of intoxication and admitted to consuming Bud Light. Not so coincidentally, there was an empty Bud Light can feet from the vehicle. The driver was charged with driving under the influence and was held at Rappahannock Regional Jail until sober.

CHARLIE ZONE

LARCENY

Richmond Highway, deputy responded to a larceny. The victim advised she was in an accident on Richmond Highway in March. After the crash, her E-ZPass was stolen. The victim discovered unauthorized charges on her E-ZPass.

PUBLIC INTOXICATION

Wild Oak Lane, deputy responded to a verbal argument. The male party involved was highly intoxicated in public and would continue yelling at the female. The deputy detained the suspect in hopes of deescalating the incident; however, the suspect did not want to be de-escalated. He was charged with public intoxication and obstruction of justice. He was held at Rappahannock Regional Jail until sober.

2700 block of Richmond Highway, deputy responded to a suspicious person call. The caller advised that there was a male stumbling around the roadway. When the deputy arrived, he located the suspect napping on the ground. When the napper awoke, the deputy observed signs of intoxication. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

TRAFFIC OFFENSE

Intersection of Richmond Highway and Eskimo Hill Road, deputy was in the area when a driver decided to drive 64 MPH past the deputy despite the posted speed limit of 50MPH. A traffic stop was conducted and it was discovered the driver had a revoked license due to a previous DUI offense. There were also numerous infractions discovered to include no registration, no inspection, and no insurance. The driver was charged with driving after forfeiture of his license, fictitious registration, failure to obey a highway sign, no inspection, no registration, and no insurance.

WARRANT SERVED

Town Center Boulevard. Detectives had information that a wanted suspect was in the area. The suspect was wanted out of Tennessee for probation violations on charges originally from robbery, reckless endangerment, aggravated assault, and aggravated burglary. Detectives and deputies responded to the area and took the suspect into custody without incident. He is being held at Rappahannock Regional Jail awaiting extradition.



DELTA ZONE

ASSAULT

Susan Street, deputy responded to an assault. The victim advised he was leaving his girlfriend's place when a male suspect unknown to him began assaulting him. The suspect was later identified as the girlfriend's ex-boyfriend. A warrant for assault and battery was obtained.

Edgemere Court, deputy responded to an assault. The victim advised she was with her boyfriend when a verbal argument started. In response to the argument, the suspect took the victim's phone. The victim attempted to get it back when the suspect assaulted her. The victim's mother would hear the ruckus and try to intervene. The now ex-boyfriend would assault the mother before throwing the victim's phone to the ground, completely destroying it. Warrants for assault and battery, as well as, destruction of property was obtained.

PUBLIC INTOXICATION

Charles Street, deputy responded to a lover's quarrel. A boyfriend and girlfriend were having a verbal disagreement. The deputy made contact with the male who was in an intoxicated state. During a search incident to arrest, the deputy located suspected controlled substances in the suspect's possession. He was charged with public intoxication and possession of controlled substances. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

DRUGS

Fredericksburg Orthopedics, 90 Greenspring Drive, deputy was in the area when he observed two (2) people within a vehicle. Considering the time of night, it was unlikely they were there for musculoskeletal issues, so the deputy made contact with them. While conversing with the pair, suspected controlled substances were located in plain view. The pair advised the white powder was only carpet cleaner; however, after understanding that the lie wouldn't work, admitted to what it truly was. Both were charged with possession of controlled substances.

LARCENY

Walmart, 217 Garrisonville Road, deputy responded to a larceny. The victim advised he made contact with a male suspect in order to sell an iPhone. When the two of them met in the parking lot, the suspect asked to take the phone to Verizon to make sure it was "real." The suspect would leave and not return.

Lakewood Drive, deputy responded to a larceny. The victim advised at 3:34 p.m. he received a Ring notification that his Amazon package was delivered. At 4:14 p.m. he received another notification when an unknown male stole his package.

DISTURBANCE

7-Eleven, 201 Garrisonville Road, deputy responded to a disturbance. The caller advised a male suspect parked behind his vehicle, blocking him from leaving. The suspect would refuse to allow the caller to leave. After a bit of back-and-forth, the suspect fled to Walmart, located at 217 Garrisonville Road. It was discovered the suspect was trespassed from Walmart. He was charged with trespassing and disorderly conduct.

SCAM-AWARE


Victim advised she received a phone call today from someone claiming to be "Sgt. Chris Staples", badge #3776, with the Fredericksburg Sheriff's Office from the number 540-807-4448. This person told the victim that she missed court on June 3rd and got a failure to appear on April 2nd of this year. The victim was told she would need to pay a fine of \$12,000 or she would never be able to step foot on government property again. Additionally, the victim was told she would be detained and then arrested. They told her in order to pay this fine she needed to withdraw \$9,000 and then another \$3,000 from her bank. Once she did that she needed to send the caller the money through a coin star machine at Giant and the victim complied. The victim eventually shared her experience with a friend and they explained to her this was a common scam, at which time the caller reported the fraudulent crime.

Victim's received a phone call from a female pretending to be their granddaughter and a man calling himself "Richard Egan", who stated that he was an attorney for their granddaughter. The female, pretending to be their granddaughter, stated she had been arrested for reckless driving and that she had hired an attorney, aka Mr. Egan. When the victim asked the woman why she didn't sound like herself, the woman stated that she had been sick. The granddaughter then explained that "Mr. Egan" was going to need \$20,000 in cash to get her out of jail, and that he would send a courier to her home to retrieve the money. The victim then went to the bank and retrieved \$20,000 in cash to give to the courier to get their granddaughter out of jail.

The victims noticed a grey SUV-looking vehicle with a bright yellow license plate, sitting outside of their home. The victims quickly called their granddaughter's cell phone and she answered the phone. It was at this point the victims realized this was a scan and they disconnected with the caller. Once disconnected, they noticed the SUV in front of their home drove off.
