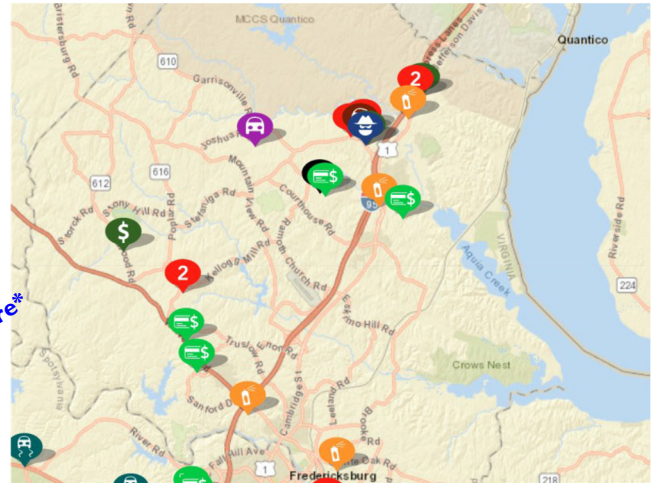

When victim explains she had not ordered a new phone, the caller directed her to get on laptop to open her account so they could walk her through the process. The laptop stopped working oddly and she received a virus alert, at which time she realized this was all part of the scam.

Larceny: Catalytic convertors stolen from trucks

Fraud: SCAM: U.S. Marshal Subject claimed to be a US Marshal and a warrant was going to be obtained for the victim unless he was paid off through gift cards		
Steeplechase	Woodlawn	03/07/21
Vandalism: Chainlink fence was cut away from poles.

Vandalism: Motorized shopping carts damaged.

Fraud: SCAM: LAW ENFORCEMENT OFFICER (X2) - Subject claimed to be a local law enforcement officer claiming victim had missed jury duty, and would have to pay \$1,835 in fines. NOTE: Caller claimed the "kiosks" were down and payment could only be made by using MoneyPak cards. After payment, victim realized he had never been notified of jury duty and this was a scam.

Burglary: Food stolen from a storage unit behind restaurant.
