WEEKLY CRIME REPORT

ALPHA ZONE

DUI

3400 block of Mountain View Road, a deputy responded to an automatic crash notification. When he arrived, he discovered a F-150 had crossed into the opposing lane of travel and through a telephone pole before stopping with the help of some trees and a fence. The juvenile driver admitted to consuming roughly 4- to 5-shots of vodka. He was transported to a nearby hospital to be treated for his minor injuries. DUI related criminal complaints are pending.

LARCENY

Target, 25 South Gateway Drive, a deputy responded to a larceny. Staff noticed a male suspect attempting to leave the store wearing a stylish unpaid jacket. He was stopped and identified as a juvenile. While a family member described the suspect as "a good kid," staff recognized him as a repeat offender. A juvenile summons for shoplifting was submitted.

Truslow Road, a deputy responded to a larceny. The victim advised her Nissan, last seen at approximately 7:00 p.m., was now missing. The vehicle was entered as stolen into a law enforcement database.

ABC, 9 Village Center Drive, 3/13, 4:50 p.m. Deputy C.M. Sterne responded to tequila time. Just like in yesterday's report, a male suspect stole a bottle of expensive tequila.

Anytime Fitness, 27 South Gateway Drive, a deputy responded to the gym for a larceny report. It was discovered that while the victim was pumping some iron, a male suspect would steal his vehicle keys.

WARRANT SERVED

Sleep Inn, 595 Warrenton Road, a deputy responded to a warrant service. She had received an anonymous tip that a male suspect who was wanted out of Stafford was sleeping in at the Sleep Inn. The deputy attempted to make contact with the suspect, who would refuse deputies commands to exit the room and instead locked it. After realizing deputies weren't just going to walk away, the suspect did some deep thinking and decided to surrender. He was served on his outstanding warrant, as well as, charged with obstruction of justice. He was held at Rappahannock Regional Jail without bond.



BRAVO ZONE

DUI

Caisson Road, deputies responded to a reckless driver complaint. The caller advised a speeding Chevy was swerving while traveling on Kings Highway. The caller would provide live updates until the suspect vehicle turned onto Caisson Road, where deputies made contact with the driver. The driver had signs of intoxication and a suspended license. The driver was charged with driving under the influence and driving while suspended.

New Hope Church Road, deputies responded to a call in which "things got weird." The caller advised "things got weird" as he was driving and people were following him. Deputies made contact with the driver and did not discover any followers. The driver admitted to consuming controlled substances prior to driving and deputies noticed his inspection sticker expired 11 years ago. The driver was charged with driving under the influence and having an expired inspection.

Area of Deacon Road and Brooke Road, a deputy responded to a drunk driver complaint. The caller advised an orange Jeep was speeding, swerving, and nearly struck another vehicle. Luckily, the bright Jeep was easy to locate even with the sun setting. The deputy made contact with the driver who showed signs of intoxication and admitted to consuming "too much." Despite knowing she consumed way too much, she still decided to drive. The driver was charged with driving under the influence.

Cool Springs Road, a deputy was patrolling the area when he observed a Toyota swerving. A traffic stop was conducted and the deputy made contact with the driver, who had signs of intoxication. Within the vehicle was a graveyard of empty beer containers, ten to be exact. The driver was charged with driving under the influence, drinking while driving, and the traffic lane violation.

PUBLIC INTOXICATION

Walmart, 125 Washington Square Plaza, deputy responded to a disturbance. It was advised two (2) intoxicated individuals were causing a scene by knocking items off shelves and ramming shopping carts. The deputy made contact with the highly intoxicated pair, who admitted to "horsing around" in the store. Both were charged with public intoxication and disorderly conduct. The 21-year-old received an additional charge for vandalism due to the destruction of some of the shelves.

VANDALISM

James Madison Circle, a deputy responded to a vandalism. The victim had the door frame of their residence broken. Security cameras would reveal a juvenile suspect donkey-kick the door before quickly fleeing. After a bit of canvassing the area, the deputy was able to identify the suspect, who advised he was playing "ding-dong ditch." A criminal complaint for destruction of property was submitted and the juvenile was resealed to his less-than-pleased mother.

CHARLIE ZONE

LARCENY

Valero Fast Mart, 2142 Richmond Highway, a deputy responded to a not-so-incognito larceny. Staff observed two (2) juvenile females "acting suspicious." Shortly after their suspicious walk around the store, staff noticed several vapes missing from inventory. The juveniles were located on Courthouse Road and admitted to the larceny. Both suspects received criminal complaints for shoplifting and underage possession of tobacco.

ASSAULT

Bridgewood Court, a deputy responded to a disturbance. It was discovered the victim was visiting a female when the suspect unexpectedly arrived home early. The suspect would threaten the victim and chase him down the block while wielding a knife. A warrant for simple assault was obtained for the suspect.

Staybridge Suites, 2996 Richmond Highway, a deputy responded to an assault. It was discovered the victim was assaulted by two (2) individuals after an argument about not taking the trash out. While the female party was located onsite and was detained, the male suspect was no longer on scene. Luckily, his "Parental Advisory" hoodie made it easy for the deputy to locate him just across the street. Both were charged with assault and battery, as well as, assault by mob.

DUI

Area of Courthouse Road and Austin Ridge Road, a deputy was in the area when he observed a vehicle enter the construction site. Given the lateness of the hour, it was unlikely the driver was there for drywalling and the deputy decided to make contact with him. During their conversation, the deputy noticed not only that the driver had signs of intoxication, but open and partially consumed White Claws were present. The driver was charged with driving under the influence.

PUBLIC INTOXICATION

Hampton Inn, 2965 Richmond Highway, a deputy responded to an intoxicated person call. It was advised an intoxicated male suspect had shown up at the caller's hotel room. The deputy located the suspect in the parking lot in an intoxicated state.



DELTA ZONE

FRAUD

Walmart, 217 Garrisonville Road, a deputy responded to a defrauding report. Staff advised after an oil change, a male suspect left the business without paying for their services. The suspect advised he "maybe" would pay after running some errands. The deputy made contact with the suspect and informed him warrants could be sought against him. The suspect stated to the deputy "go get your warrants then," and the deputy did so. The suspect was served on a defrauding warrant.

PUBLIC INTOXICATION

Jeff Rouse Swim and Sport Center, 1600 Mine Road, a deputy responded to a public intoxication call. It was advised a "heavily" intoxicated male was in the area. The deputy made contact with the suspect who had signs of intoxication. The suspect wanted to perform a breath test to prove he was not intoxicated; however, that did not go as planned for the test showed he was three (3) times over the legal limit. The suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

WARRANT SERVED

Ruffian Drive, a deputy responded to a disturbance. Despite the late hour, it was advised a female was at the front door of a residence causing a scene. The deputy made contact with the suspect, who provided a false identification. This was quickly uncovered and the deputy discovered the suspect was wanted out of Fairfax. The late-night visitor was charged with providing a false identification to law enforcement, unlawful name change, and was served on her outstanding warrant. She was held at Rappahannock Regional Jail without bond.

LARCENY

Home Depot, 305 Worth Avenue, a deputy responded to a trashy larceny. Staff advised a male suspect filled two (2) garbage cans with "high-end" smoke detectors. He would wheel the over \$7,000 worth of merchandise out of the business before fleeing in a red Buick. It was further advised the same suspect stole from additional Home Depots in neighboring jurisdictions. The investigation is ongoing.

Paisanos, 1515 Stafford Market place, a deputy responded to a larceny. Staff advised a former employee stopped by, but not for lunch. The suspect would steal a laptop and paperwork. A warrant for larceny is pending.
