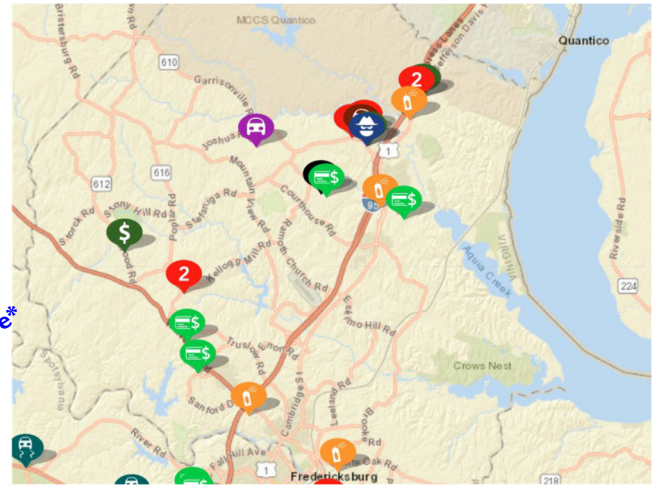

Fraud: Fraudulent cable account opened in victim's name.

CHARLIE ZONE:

Hope Road 03/15/21
Fraud: Fraudulent on-line charges using victim's unemployment credit card.

Eskimo Hill Road 03/15/21
Fraud: Victim "googled" phone number to activate her CashApp card. Representative who answered, called victim back from a different line and proceeded to ask for account number and a copy of victim's driver license. Shortly after activation, victim had \$1,700 fraudulently withdrawn from her account.

White Pine Circle Village of Aquia 03/15/21
Larceny: Theft of side mirrors from freight liner.

Southern View Drive Granville Estates 03/16/21
Larceny: Theft of decking materials from the garage of a new home under construction.

Fraud: **SCAM: GEICO: Subject contacted victim through Indeed Inc. with a job offer with GEICO. Victim provided various personal information as well as bank information. Subject instructed victim to send him money through CashApp. Victim became suspicious and contacted SCSSO.**

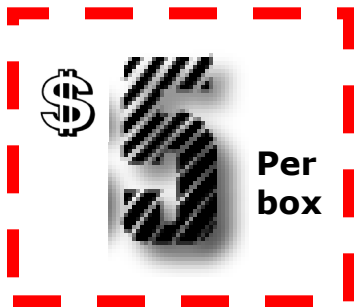
