

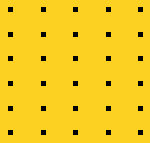

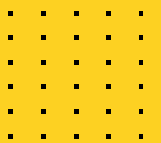
## WEEKLY CRIME REPORT

# ALPHA ZONE



## **LARCENY**

Bitez, 375 Warrenton Road, a deputy responded to a larceny. Staff advised that at approximately 4:45 pm, a male suspect walked out with a 12-pack of Twisted Tea. After getting away with the larceny, the suspect decided to play double or nothing. At approximately 9:04 pm, the same suspect returned, this time to steal two (2) 12 packs.

## **PUBLIC INTOXICATION**

Holly Corner Road, a deputy responded to an intoxicated person call. It was advised that a known party was heavily intoxicated and was excessively knocking on the caller's door. The deputy arrived to locate the suspect still in public in an intoxicated state. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Clarion Inn, a deputy responded to an intoxicated person call. It was advised that a male with silver spray paint across his face was lying on the sidewalk. The deputy located the intoxicated male still with his "decorations" on his face and detained him. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **ASSAULT**

America's Best Value Inn, 605 Warrenton Road, deputies responded to a fight in progress. It was discovered that a verbal altercation over music escalated into a fight. Luckily, the incident was captured on surveillance camera. As a result, three (3) suspects were charged with assault by mob. The 45-year-old male suspect was held at Rappahannock Regional Jail on a \$2,000 secured bond; the 41-year-old female suspect was held on a \$1,000 secured bond; and the 20-year-old male suspect was released by the magistrate on personal recognizance.

Best Buy Auto Group, 355 Warrenton Road, a deputy responded to an assault. It was discovered that a customer assaulted a staff member after a discrepancy regarding paperwork. The customer was charged with assault and battery and was released by the magistrate on personal recognizance.

Walmart, 11 Village Parkway, a deputy responded to a disturbance. Staff advised that a female suspect was causing a scene at the pharmacy drive-through. When confronted by staff, the suspect would throw a glass bottle at staff members. Luckily, she had missed and the bottle shattered on the ground. Considering she was well known to the staff, the deputy had no problem identifying her and obtained permitted warrants for simple assault and disposing of trash on private property.

## **TRAFFIC OFFENSE**

Area of Warrenton Road and South Gateway Drive, a deputy was traveling in the area when the Dodge pick-up in front of her made an illegal U-turn. The deputy conducted a traffic stop and discovered the driver had a suspended license due to a prior DUI incident. The driver was issued summonses for driving after the forfeiture of his license, as well as, failure to obey a highway sign. His vehicle was impounded as a result.

# BRAVO ZONE

## **TRAFFIC OFFENSE**

Area of Cambridge Street and Southgate Avenue, a deputy was traveling Northbound on Cambridge Street when he observed an Impala traveling 57 MPH in a 45 MPH zone. The deputy conducted a traffic stop and made contact with the driver. It was discovered that the driver had a suspended license due to a prior DUI-related incident. While she was released on summonses for speeding and driving after forfeiture of her license, she would not be getting back behind the wheel; her vehicle was impounded.

## **VANDALISM**

Leeland Road, a deputy responded to a vandalism. A utility box and stoplight had been defaced. The deputy would clean up the streets by cleaning up the vandalism.

## **LARCENY**

Weis, 282 Deacon Road, a deputy responded to multiple past-occurred larcenies. Staff advised a female suspect had been altering price tags since the beginning of January. The total loss to the business was over \$130. The deputy was able to identify the suspect, and warrants for shoplifting are pending.

YMCA, 212 Butler Road, a deputy responded to a larceny. The victim advised that while working out the day prior, his credit cards were stolen. After noticing the theft, the victim quickly contacted his bank to cancel the cards and discovered fraudulent activity.

## **PUBLIC INTOXICATION**

Elizabeth Drive, a deputy responded to a disturbance. It was advised that an intoxicated male was involved in a verbal argument. The deputy made contact with the suspect and observed several signs of intoxication. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

Holly Corner Road, a deputy responded to a late-night visitor. The caller advised that a "heavily intoxicated" female was knocking on her door. The deputy located the suspect walking along the roadway in an intoxicated state. The suspect was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **DUI**

Hollywood Farm Road, a deputy responded to an automatic crash notification. It was advised that a vehicle was in a ditch. The deputy made contact with the driver, who had signs of intoxication. Open containers would also be located within the vehicle. The driver was charged with driving under the influence and drinking while driving. She was held at Rappahannock Regional Jail on a \$3,000 secured bond.

# CHARLIE ZONE

## **DUI**

Hope Road, a deputy responded to an auto accident. It was advised that a Chevy Cruz had cruised into a mailbox. When the deputy arrived, the vehicle was still there, but the driver was not. After a quick search of the area, the driver was located on Little Rocky Run Lane. The driver had signs of intoxication and admitted to consuming a Long Island iced tea prior to the crash. The driver was discovered to have a previous DUI-related offense back in 2022. The driver was charged with driving under the influence 2<sup>nd</sup> offense within 5 years, reckless driving, hit and run, as well as, refusal. She was held at Rappahannock Regional Jail without bond.

Area of Richmond Highway and Coachman Circle, a deputy was traveling Northbound on Richmond Highway. While doing so, a Honda pulled in front of him and was driving well above the speed limit and having a difficult time maintaining the lane of travel. The deputy conducted a traffic stop, and the driver had signs of intoxication, no driver's license, and admitted to consuming two (2) shots of tequila with a mix drink for a chaser. The driver was charged with driving under the influence, reckless driving, driving without a license, and failure to maintain the lane of travel. He was held at Rappahannock Regional Jail on a \$2,500 secured bond.

Flippo Road, a deputy responded to an auto accident. A Cadillac had a collision with a ditch. Before the deputy could make contact with the driver, witnesses informed him that the driver requested they help her "hide the alcohol." They would deny the request. The driver had signs of intoxication and admitted to driving "side to side." The driver was charged with driving under the influence and reckless driving. She was held at Rappahannock Regional Jail until sober.

## **FRAUD**

Greenhaven Court, a deputy responded to a fraud. The victim stated he was contacted by a bank in Texas advising him someone attempted to cash a check in his name. Considering the victim was still in Stafford and he wasn't able to be in two places at once, it was discovered to be an identity fraud. Luckily, the suspect was unable to cash the fake check.

## **ASSUALT**

Short Branch Road, a deputy responded to an assault. The victim advised that two (2) female suspects entered her residence, assaulted her, and stole her cell phone. The cell phone was later recovered, damaged. Warrants for malicious wounding, breaking and entering with intent to assault, assault by mob, larceny, and vandalism were obtained for both suspects. Luckily, the suspects were apprehended in another Virginia jurisdiction.

# DELTA ZONE

## **DISORDERLY CONDUCT**

Dollar General, 263 Garrisonville Road, a deputy responded to a disturbance. It was discovered that a frequent flyer had a verbal altercation with staff. During the exchange of words, the suspect advised she had a gun and "wasn't afraid to use it." The deputy made contact with the suspect, who admitted the claims were true and that she said it just to teach the staff "a lesson." No gun was located. A permitted warrant for disorderly conduct was obtained and served.

## **DUI**

Mine Road, a deputy responded to an auto accident. It was advised that a Dodge failed to dodge a fire hydrant. When the deputy arrived, he located the fire hydrant in the middle of the road, and the driver was in an intoxicated state. Keeping with the tequila theme, the driver admitted to consuming four (4) tequila drinks prior to his travels. He was charged with driving under the influence and held at Rappahannock Regional Jail until sober.

Brooke Road, a deputy responded to an auto accident. It was advised that a truck crashed into a tree. The deputy made contact with the driver, who had minor injuries, signs of intoxication, and admitted to consuming beer before driving. Due to the driver being admitted to a local hospital, a summons for driving under the influence was obtained and served.

## **VANDALISM**

Staffordboro Commuter Lot, a deputy responded to a laundry-sized vandalism. The victim advised someone had poured laundry detergent into his gas tank, causing it to have automotive issues. The Tide troublemaker is still unknown.

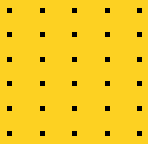
## **LARCENY**

Vista Wood Road, a deputy responded to a vehicle larceny. It was advised that a known male took the victim's keys without permission and used her vehicle to obtain alcohol. While the suspect denied the incident, camera footage proved otherwise. While people can lie, camera footage can't. The suspect was charged with unauthorized use of a vehicle and underage possession of alcohol. He was held at Rappahannock Regional Jail pending his ability to participate in a bond hearing.

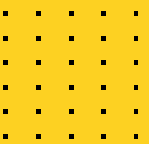
Walmart, 217 Garrisonville Road, a deputy responded to a larceny. Staff advised that a male suspect walked out with an unpaid speaker. The suspect would flee in a tan Cadillac SUV. Additionally, staff advised that a female suspect was currently concealing items within her bag. The deputy located the suspect after she passed all points of sale and detained her. The nearly \$290 worth of beauty items was recovered, and the suspect was issued a summons for shoplifting. And a 3<sup>rd</sup> larceny of the day involved two (2) juveniles who started their spring break by stealing over \$50 worth of items. Both juveniles received a criminal complaint for shoplifting and were turned over to their very upset parents.

## **PUBLIC INTOXICATION**

Shoppers, 1505 Stafford Market Place, a deputy responded to a disturbance. It was advised that an intoxicated male was yelling and flipping shopping carts in the parking lot. The shopping cart flipper was located in an intoxicated state and was charged with public intoxication. He was held at Rappahannock Regional Jail until sober.

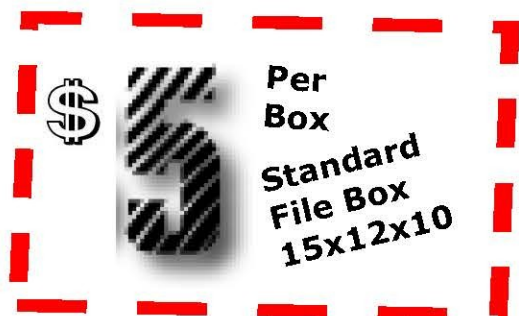

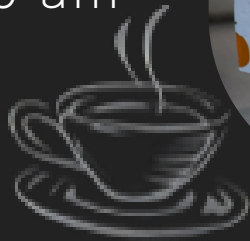

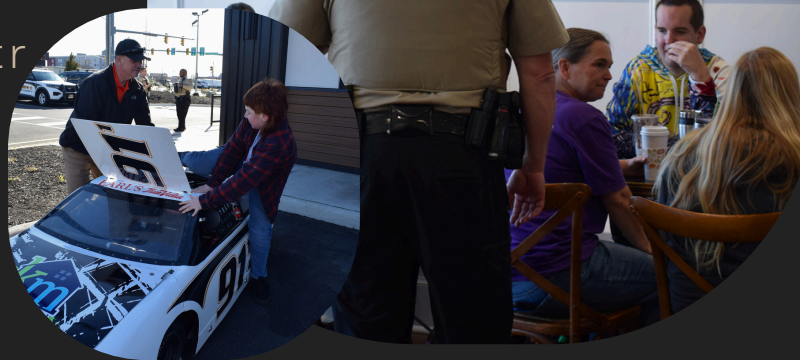
