

Basalt Drive Stafford Lakes Village 03/23/21

Fraud: PAYCHECK SCAM: Victim was contacted through Instagram referencing receiving a weekly pay check. Victim deposited two (2) [counterfeit] checks into their personal account, only to be contacted by suspect requesting a portion of the funds to be sent to another associate via Apple Pay. Victim was later contacted by bank informing them the checks were fraudulent.

Vandalism: Damage to muffler after attempted theft off of company van.

Lerose Drive Warrenton Road 03/25/21

Fraud: FACEBOOK RABBIT SCAM: Victim purchased a rabbit off Facebook Market Place; suspects demanded payment via CashApp before they would meet victim with rabbit. Once payment was made, suspect closed down Facebook account, victim never received rabbit.

Fraud: Victim's identity fraudulently used to open unemployment claim.

Larceny: Theft of two (2) dishwashers from new home construction sites.

Larceny: Skip-scanning; (X4) - subjects scan one item, but bags several additional items without scanning.

Larceny: Skip-scanning; (X4) - subjects scan one item, but bags several additional items without scanning.

Forgery: Counterfeit money passed for purchases.

Larceny: Skip-scanning; (X2) - subjects scan one item, but bags several additional items without scanning.

Motor Vehicle: Theft of vehicle from parking lot; later used in theft of ATM.

Fraud: CHECK SCAM: Victim was paid with a check to complete an interior paint job. After deposit of check, customer cancelled and instructed victim to return funds in three (3) separate transactions using CashApp. After paying, victim was informed by his bank the check bounced; victim lost \$2.800.

Fraud: Victim's credit card fraudulently used for online purchases.

Fraud: Victim's identity was compromised and used in Florida to gain employment.

Larceny: Theft of money from tip jar. Criminal later identified and arrest warrant issued.

Larceny: Theft of inventory scanner.

Fraud: Victim's identity fraudulently used to receive unemployment benefits.

101 Juliad Court Lawn Doctor 03/24/21

Larceny: Theft of license plate from two (2) company vehicles.

Thornberry Lane Devon Green 03/24/21

Fraud: Victim's identity fraudulently used to open unemployment claim.

Kinross Drive Stowe of Amyclae 03/24/21

Fraud: Victim's identity fraudulently used to open unemployment claim.

Minuteman Circle Stonegate Apartments 03/28/21

Vandalism: Victim was attempting to park car and notice a group of people causing a disturbance. Victim attempted to leave, but person from group approached victim's car and smashed the windshield.

Montpelier Drive Roseville Plantation 03/28/21

Fraud: IPHONE SCAM: Victim received fraudulent email regarding an iPhone order. Victim called number included in email and was instructed to log-on to his bank account. Victim complied and immediately experienced issues with their laptop. Scammer stated his company erroneously deposited \$3,000 into victim's bank account, and victim needed to return funds by purchasing four (4) gift cards from CVS and provide scammer the card numbers. Victim disengaged in the call realizing this was a scam.


