## WEEKLY CRIME REPORT

## **ALPHA ZONE**

#### LARCENY

Olde Forge Drive, a deputy responded to a larceny. The juvenile victim advised that while playing basketball, an unknown male took his phone. The suspect was described as a black male with a tattoo on the left side of his neck and a beard.

#### **VANDALISM**

Willowmere Park, Willowmere Pond Road, a deputy responded to a report that the women's bathroom was destroyed. The deputy discovered a sink had been ripped off the wall, toilets were covered in toilet paper, and a mirror was stolen.

#### WARRANT SERVED

Pancho Villa, 754 Warrenton Road, a deputy with the Street Crimes Unit, received information that a wanted suspect was in the area. The suspect was wanted out of Stafford for a capias. With the assistance of a fellow deputy, the suspect was located and detained. He was served on his outstanding warrant and held at Rappahannock Regional Jail without bond.

Sizzling Kabob, 367 Warrenton Road, a deputy responded to a dispute at the business. While deescalating the situation, it was discovered that one of the involved parties was wanted out of both jurisdictions, Stafford and Henrico. He was served on his outstanding warrants and held at Rappahannock Regional Jail without bond.

#### **ASSAULT**

Area of Warrenton Road and South Gateway Drive, a deputy responded to an unknown problem. It was advised that an elderly male had apparent injuries. The deputy made contact with the victim and discovered he was assaulted. The victim advised that an unknown male walking a dog struck him with a piece of wood. The suspect was described as a white male wearing a black jacket and tan pants.

#### DUI

Area of Warrenton Road and Cardinal Forest Drive. During the morning rush a deputy responded to a reckless driver complaint. A Camaro was traveling in a reckless manner. The deputy observed the reckless driver as it failed to maintain the lane of travel and conducted a traffic stop. The driver had a suspended license, signs of intoxication, and admitted to consuming "four shots" before getting behind the wheel. She was charged with driving under the influence with a blood alcohol content above .2, driving while suspended, and a traffic lane violation

#### **HIT AND RUN**

Area of Northbound I-95 exit ramp to Warrenton Road. A deputy on his issued motorcycle was struck from behind while in traffic. A bystander assisted the deputy as members of the Traffic Safety Unit responded to assist. Luckily, the deputy only received minor injuries and was later released from the hospital. The suspect vehicle was described as a bright blue lower profile vehicle with expected frontend damage. The investigation is ongoing, and anyone with information is asked to contact First Sergeant W.T. Johnson at 540-658-4450.

### **BRAVO ZONE**

#### DUI

Area of Kings Highway and Blue and Gray Parkway, a deputy was in the area when she observed a Chevy failing to maintain the lane of travel and nearly crash into a tractor-trailer. The deputy conducted a traffic stop and made contact with the driver. The driver had signs of intoxication and admitted to consuming "a couple" of Bud Lights prior to driving. The driver was charged with driving under the influence and the traffic lane violation.

Jett Drive, a deputy responded to an auto accident. The caller advised he struck an unoccupied parked vehicle. The deputy made contact with the at-fault driver and discovered he was traveling on Kings Highway when he was "rerouted." This recalculation had him drive off the roadway and strike the vehicle. The driver had signs of intoxication and admitted to consuming alcohol prior to driving. He was charged with driving under the influence and reckless driving. He was held at Rappahannock Regional Jail until sober.

Sheetz, 10 Washington Square Plaza, a deputy responded to a drunk driver complaint. The caller advised that a known party was drunk and behind the wheel of a Jeep. The Jeep was located in the parking lot, and the deputy made contact with the driver. The driver had signs of intoxication, admitted to drinking "a lot," and had opened a BeatBox container in plain view. The BeatBox devotee was charged with driving under the influence and driving on a revoked license. He was held at Rappahannock Regional Jail without bond.

#### **LARCENY**

Earl's True Value Store, a deputy responded to a larceny. Staff advised two (2) males attempted to steal a Yeti cooler. When they were confronted, the pair quickly took off in a white SUV.

## **CHARLIE ZONE**

#### **ASSAULT**

Jay's Sport Lounge, 2866 Richmond Highway, a deputy was patrolling the area when he observed a still-running vehicle parked in the middle of the parking lot. The driver was running after a male and assaulted him from behind. Considering the deputy observed the offense, he quickly detained her. The driver had signs of intoxication and admitted to both the assault and driving after consuming alcohol. She was charged with driving under the influence and assault and battery.

Cavalier Skating Center, 1920 Richmond Highway, a deputy responded to a chaotic altercation. It was discovered that a verbal altercation between a group of juvenile females escalated into a fight. As a result of the altercation, three (3) juveniles received a criminal complaint for assault by mob. The fourth juvenile involved received a criminal complaint for simple assault.

Antietam Loop, a deputy responded to an assault. It was discovered that the victim had a disagreement with a group of juveniles. In response, the group assaulted the victim before fleeing the area.

#### **VANDALISM**

Naples Road, a deputy responded to vandalism. The victim advised that two (2) juvenile males kicked his door, which caused damage to the door.

#### **LARCENY**

White Pine Circle, a deputy responded to a vehicle larceny. The victim advised he exited his residence to discover his Hyundai had been stolen overnight. Deputies combed the area and were able to locate the unoccupied vehicle on Richmond Highway with newly obtained damage.

#### **PUBLIC INTOXICATION**

7/Eleven, 1947 Richmond Highway. A detective noticed a shirtless male wandering and stumbling around the area. A deputy arrived in the area and located the intoxicated male. He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

#### DUI

Area of Richmond Highway and Courthouse Road, a deputy was in the area when she observed a reckless Rogue flying down the road at 50 MPH in a 35 MPH zone. A traffic stop was conducted, and the deputy made contact with the driver. The driver had signs of intoxication and open containers scattered throughout her vehicle. After conducting field sobriety tests, the driver was charged with driving under the influence, speeding, and refusal. She was held at Rappahannock Regional Jail on a \$2,500 secured bond.

George Mason Road, a deputy responded to a drunk driver complaint involving a Mercedes. A deputy had observed the suspect vehicle tailgating another vehicle and conducted a traffic stop. The driver had open bottles of wine, admitted to consuming approximately five (5) glasses, and attempted to explain her "bubbly personality" could be mistaken for intoxication. While the wine might be bubbly, her charges were not. She was charged with driving under the influence, drinking while driving, and following too closely.

## **DELTA ZONE**

#### DUI

Pancho Villa, 155 Garrisonville Road, a deputy responded to a potentially intoxicated Mustang driver. The caller advised the driver of a Mustang was drinking beer while behind the wheel. The deputy located the driver still in the parking lot and made contact with him. The driver had clear signs of intoxication and open beer bottles within the vehicle in plain view. The driver was charged with driving under the influence with a blood alcohol content between .15 and .2, and drinking while driving.

#### **LARCENY**

Stafford Market Place, a deputy responded to two (2) larcenies regarding the same two (2) suspects. Staff advised the male and female duo stole items at Ulta before going next door to Target and stealing from there as well.

Walmart, 217 Garrisonville Road, a deputy responded to a larceny in progress. Staff advised they observed a male stuffing his hoodie with unpaid items. The deputy quickly located the suspect outside the business and detained him. It was discovered that the suspect had been trespassed from Walmart two (2) months ago. He was charged with shoplifting and trespassing.

Ulta, 1150 Stafford Market Place, a deputy responded to a beauty burglary. Three (3) males were observed picking the finest cosmetic and hair care products. Much like on the red carpet, they would strut out of the business with over \$5,000 worth of items.

Walmart, 217 Garrisonville Road, a deputy responded to a larceny. Staff advised a male suspect walked out with unpaid items, including oral care products. The suspect was seen leaving in a Malibu. The deputy located the Malibu and conducted a traffic stop. The suspect and his pearly white teeth admitted to the larceny and received a summons for the offense.

#### **WARRANT SERVED**

Super 8 Motel, 25 Wicomico Drive, a deputy responded to a wanted suspect in the area. US Marshals had information that a male suspect, who was wanted out of two (2) Virginia counties and one (1) Maryland county, was in the area. With the US Marshal's assistance, the deputy took the suspect into custody. He was served on his outstanding Virginia charges and received a warrant for fugitive from justice for the Maryland one. He was held at Rappahannock Regional Jail without bond.

Garrison Woods, a deputy received word that a wanted suspect was seen in the area. The suspect had quite the list of charges, being wanted out of Stafford, Caroline, and Maryland. The deputy was able to locate the suspect and detain him without incident. He was served on his outstanding in-state charges, and received a warrant for fugitive from justice for the Maryland charge. He was held at Rappahannock Regional Jail without bond.

#### **PUBLIC INTOXICATION**

300 block of Garrisonville Road, a deputy was in the area when he observed a male walking as his pants were falling down. The deputy made contact with the slack-less suspect, who had signs of intoxication and admitted to coming from a bar "just down the street." The suspect received a warrant for public intoxication and recommendations for a belt.

## **SCAM REPORT**

**Victim** received a message on her phone from Apple ID informing her she had multiple accounts open. The message instructed the victim to select the provided link, which she did, and it called an individual who claimed her name was "Hazel Smith" at 425-669-1076. "Hazel" informed the victim that she needed to contact her Bank to get in contact with their fraud investigators. "Hazel" then transferred the victim to "Bank of America," and she spoke with an individual who advised his name was "Jason Matthews" and worked with the Fraud unit for Bank of America. The victim was informed her accounts were associated with a Chinese Ring of Pornography and she would be arrested for a federal crime if she did not cooperate. The victim was instructed to take out \$4,000 from her Bank of America account and take the \$4,000 to a Bitcoin ATM located at 375 Warrenton Road at the Exxon. The victim was then instructed to send the Bitcoin by wire in two (2) different payments, one of \$3900 and another of \$100. The victim was assured she would receive the money back the following day. The victim wired the funds, and when she had not received them back the following day, she realized this had been a scam and filed a police report.

**Victim** received a call from someone posing as a Sheriff's Office employee informing the victim that she had missed jury duty and to avoid consequences, the victim needed to purchase a gift card and give the suspect the code on the back. The victim knew law enforcement would never call requesting payment, and disconnected from the call.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest. 
