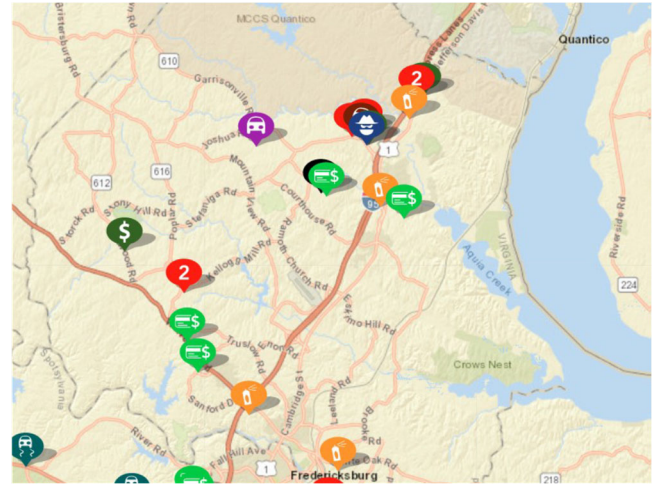

 Fraud: Victim's car intentionally "keyed."

 Fraud: **SCAM: USAA: An unknown suspect identifying himself as a USAA representative contacted victims via phone, and explained their account had been flagged for fraudulent activity. Assuming this was a legitimate call, the victims answered questions under the pretense this suspect was assisting them. Shortly afterward, it was discovered the victim's monies had been moved around and fraudulently transferred out of their account. Monetary loss of \$314,000.**

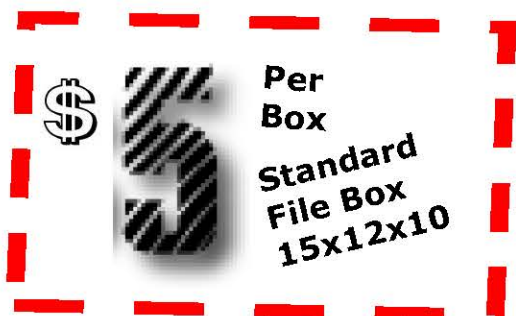
