## WEEKLY CRIME REPORT



MARCH 31ST - APRIL 6TH, 2025

## **ALPHA ZONE**

#### VANDALISM

Royal Farms, a deputy responded to a gassy grievance. Staff advised a motorcyclist would take his aggression out on a gasoline nozzle at the pump, causing it to break.

#### **LARCENY**

Harmony at Falls Run, a deputy responded to a larceny. The victim advised that her wallet was stolen. Luckily, someone found it; however, unluckily, items were taken from it.

Home Depot, 305 Worth Avenue, deputies responded to a larceny in progress. Staff advised that a male walked out of the business with his cart loaded with unpaid items. Deputies made contact with the suspect still in the area, who advised he didn't steal anything. Unfortunately for him, video evidence contradicted his claim. Over \$2,000 worth of items were recovered, and the suspect was charged with grand larceny.

#### **PUBLIC INTOXICATION**

Leite & Surfer Tax Service, a deputy was in the area when she observed a stumbling male carrying a beverage wrapped in a brown paper bag. The suspect was actively drinking a Miller Lite and had signs of intoxication. While tax season might have some reaching for the bottle, doing so in public caused the suspect to be charged with public intoxication and to be held at Rappahannock Regional Jail until sober.

#### **ASSAULT**

Fleet Road. Deputies responded to a residence for a disturbance. The victim advised that a confrontation escalated when the suspect attempted to strike him with a cane. The victim would spray the suspect with pepper spray to defend himself. The cane-swinging suspect was charged with simple assault.



## **BRAVO ZONE**

#### **VANDALISM**

Giant, 35 Town and Country Drive, a deputy responded to a "pebble" pounder. The victim advised that while enjoying her breakfast, her vehicle was pelted with rocks, causing damage.

#### **LARCENY**

YMCA, 212 Butler Road, a deputy responded to a larceny. The victim was working out when he received a notification on his phone that elevated his heart rate more than any cardio. His bank alerted him to fraudulent transactions, and it was discovered that the victim's credit card had been stolen while he worked out.

ABC, 43 Town and Country Drive, a deputy responded to a larceny. Staff advised two (2) suspected juveniles just left the business. What caught the staff's attention was one of the suspects was wearing a jacket, despite the pleasant weather. After a review of camera footage, it was discovered that the pair stole four (4) bottles of Don Julio.

ABC, 43 Town and Country Drive, 4/4, 7:44 p.m. Twice in one day the business had a larceny. Deputy A.G. Hart responded to a report of a male suspect stealing two bottles of expensive and tasty whiskey.

#### **PUBLIC INTOXICATION**

Yellow Finch Way, a deputy responded to an intoxicated person report. It was advised that a female was stumbling and falling while walking in the area. The deputy located the suspect in an intoxicated state, and would admit to consuming a mix of Buzz Balls and vodka shots. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

#### **WARRANT SERVED**

All Star Pawn and Gold, 404 Kings Highway, a deputy responded to a wanted suspect being sighted. A detective advised that a male suspect, wanted out of Stafford for numerous larceny offenses, was in the area. The deputy located the vehicle in question and conducted a traffic stop. The suspect attempted to lie about who he was by using someone else's information, but that plan didn't pan out. The suspect was served on his outstanding warrants and charged with identity theft and providing a false identity to law enforcement. He was held at Rappahannock Regional Jail without bond.

Advance Auto Parts, 91 Washington Square Plaza, deputies were on a traffic stop when it was discovered the driver was wanted out of Ashland. The driver would also have no driver's license and an open title on the vehicle. He was served on his outstanding warrant and additionally charged with driving without a license and possession of an open title. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

## **CHARLIE ZONE**

#### DUI

Area of Richmond Highway and Woodstock Lane, a deputy responded to a drunk driver complaint. It was advised that a known party was driving a Dodge Ram in the area. The deputy located the vehicle in question, with both an expired registration and inspection sticker, and conducted a traffic stop. The driver had signs of intoxication and admitted to consuming "quite a few Buzz Balls." The "few" Buzz Balls were located within the vehicle, mostly consumed. The driver was charged with driving under the influence with a blood alcohol content above .2, drinking while driving, and having both an expired registration and inspection.

Enterprise Rent-a-Car, 2875 Richmond Highway, a deputy was on an unrelated traffic stop when he was interrupted by an extremely loud scraping sound. A Honda passing by had obvious damage as it drove past him. The deputy would catch up to the vehicle in question as it failed to maintain the lane of travel and conducted a traffic stop. The driver advised her vehicle was just "a little wonky." Wonky or not, there was considerable damage to her vehicle from an unknown source, and she displayed signs of being under the influence. The driver admitted to having "a little bit" to drink. She was charged with driving under the influence and the traffic lane violation.

Bells Hill Road, a deputy observed a Hyundai failing to maintain the lane of travel and informed nearby deputies. Deputies would locate the vehicle as the driver got out and began urinating. For obvious reasons, deputies made contact with the driver and observed signs of intoxication. An open box of wine was located within the vehicle, which also had a fake registration. The driver was charged with driving under the influence, refusal, drinking while driving, having an altered license plate, and the traffic lane violation. He was held at Rappahannock Regional Jail on a \$3,000 secured bond.

Last Stop Mart, 3315 Richmond Highway, a deputy was patrolling the area when he observed a Honda traveling 60 MPH in a 45 MPH zone. A traffic stop was conducted at the Last Stop Mart. This would be the driver's last stop before jail. The 18-year-old had signs of intoxication and an open bottle of liquor in his possession. He was charged with driving after illegally consuming alcohol, drinking while driving, speeding, and underage possession of alcohol.

#### **PUBLIC INTOXICATION**

Stafford County Courthouse, a deputy was working within the Courthouse when she was informed that a female had shown up intoxicated. It was further discovered that the suspect was wanted for a capias offense. The deputy located the wanted suspect indeed in an intoxicated state. She was served on her outstanding warrant, as well as the public intoxication. She was held at Rappahannock Regional Jail until sober.

#### **DRUGS**

Rappahannock Regional Jail, a deputy responded to a drug scavenger hunt. Jail staff conducted a search of a cell when they discovered a suspect with a controlled substance. The baggie was seized, and charges are pending.

#### **THREATS**

Dent Road, a deputy responded to a disturbance. The victim advised they received messages from a known female regarding her "burning down the house." To prevent the Talking Heads situation, a warrant for threats to burn was obtained and served. The suspect was held at Rappahannock Regional Jail on a \$2.500 secured bond.

## **DELTA ZONE**

#### **LARCENY**

Goodwill, 54 North Stafford Complex Center, a deputy responded to a larceny. The victim advised that a portable speaker was stolen off his bike while he was shopping. Using camera footage that captured the whole incident, the deputy was able to identify the suspect and made contact with him at his residence. While at first the suspect denied stealing anything, when confronted with video evidence, he caved and admitted to the larceny. A warrant for larceny was obtained.

#### **WARRANT SERVED**

7-Eleven, 378 Garrisonville Road, a deputy was patrolling the area when he observed a wanted suspect who was wanted out of Stafford for a probation violation. The deputy attempted to detain her when she resisted and would not confirm her identity. Luckily, she had a tattoo of her name and the deputy's suspicions were correct. She was eventually detained and was discovered to be in possession of a white powdery substance. The suspect was served on her outstanding warrant and additionally charged with obstruction of justice and possession of controlled substances. She was held at Rappahannock Regional Jail without bond.

#### **PUBLIC INTOXICATION**

Brafferton Boulevard, a deputy responded to a loud visitor. The caller advised that an unknown intoxicated female was knocking on her door. The deputy located the stumbling suspect and observed signs of intoxication. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

#### **VANDALISM**

Paddy's Steakhouse & Pub, a deputy responded to a vandalism. Staff advised that a window was shattered; however, the vandal was kind enough to sweep the broken glass into an easy-to-clean pile. No entry was made to the business.

Spring Lake Drive, a deputy responded to a vandalism. The victim had the driver-side window of his vehicle smashed.

#### **DRUGS**

Ebenezer Methodist Church, a deputy responded to a suspicious person report. It was advised that a male was hanging around the dumpsters behind the church. The deputy arrived and made contact with the suspect, who advised that he was there to clear his head. Apparently, "clearing" meant filling it with narcotics, for the deputy located suspected controlled substances i"n his possession. The suspect admitted it was "probably molly." While thou shalt not speak evil, it appeared this individual was smoking it. He was charged with possession of controlled substances.

## **SCAM REPORT**

**Victim** received a pop-up message on her iPad stating it had been compromised. The pop-up message provided a phone number to call. A male identified himself as "Davis" and explained he was attempting to find the individual responsible for compromising the victim's iPad. "Davis" further explained the victim would need to go to a Capital One Bank and withdraw enough money to lower her balance. The victim complied with these instructions and withdrew \$28,000 from her Capital One bank account and deposited it into a Bitcoin ATM. The victim was then instructed to go to a secondary Capital One Bank to withdraw even more cash to deposit into the Bitcoin ATM. It was during this attempt that the victim began to question "Davis" and did not withdraw any more money from her bank account and disconnected from the call, and reported the fraud to the Sheriff's Office.

This report does not encompass all of the reported crimes that may have occurred in the county, but only those noted for media interest. 
