# ALPHA ZONE

## TRESPASS

Elkton Drive, a deputy responded to an unwelcome guest. The victim advised she arrived at her residence to discover maintenance had left the door unlocked. When she entered, an unknown male was hiding in her closet. He would flee the area, but not before the victim took video of the suspect. Using the video, the deputy identified the suspect and obtained a warrant for trespassing.

## VANDALISM

Brushy Creek Circle, a deputy responded to a vandalism. The victim advised that during her vehicle had been keyed.

Target, 25 South Gateway Drive, deputies responded to a graffiti artist in action. Staff advised a male was vandalizing the walls with paint. When deputies made contact with the suspect, he would deny vandalizing the property. Despite this, the deputies noticed his hand, which was covered in paint, matched perfectly with the hand mark on the wall. The finger painter was charged with destruction of property and held at Rappahannock Regional Jail on a \$1,000 secured bond.

## DRUGS

Wawa, 9 South Gateway Drive, a deputy observed a vehicle make an illegal U-turn and conducted a traffic stop. The deputy would find suspected controlled substances and the passenger was charged with possession of controlled substances. She was held at Rappahannock Regional Jail without bond

## WARRANT SERVED

Rising Sun Road, deputies responded to a warrant service. The male suspect was wanted out of Spotsylvania for two (2) misdemeanor charges. Despite deputies observing the suspect through a window at the residence, the suspect was hesitant to open the door. After a bit of back and forth, the suspect eventually opened the door; however, would refuse commands and quickly attempt to retreat back into the residence. Deputies attempted to detain the suspect when he resisted. The suspect was detained and additionally charged with two (2) counts of obstruction of justice. After being served on his outstanding warrants the suspect was held at Rappahannock Regional Jail on a \$5,000 secured bond.





# BRAVO ZONE

## **ALCOHOL OFFENSE**

Cambridge Street, a deputy responded to some tipsy teens. The caller advised they were awoken by a bunch of loud and intoxicated teenagers. The deputy made contact with the late-night party and discovered the teens, ranging in age from 15 to 18, under the influence. The juveniles involved received a criminal complaint for underage possession of alcohol while the 18-year-old was issued a summons for the same offense.

Cambridge Street, deputies would respond back to the area for the same problem. Two (2) teens, who were also involved in the previous alcohol offense, were back in the area causing a disturbance. Each 17-year-old provided a breath sample above .2. Criminal complaints for public intoxication and underage possession of alcohol were submitted. Juvenile Intake was contacted, but denied detention, so the pair was released to a responsible adult.

## **PUBLIC INTOXICATION**

Little Whim Road, deputies responded to an intoxicated person report. It was advised an intoxicated male was "staggering" down the street. When deputies arrived, it was easy to locate the suspect due to him still staggering and stumbling in the middle of the road. The suspect had signs of intoxication and admitted his poison of choice was "some vodka." He was charged with public intoxication and held at Rappahannock Regional Jail until sober.

## **HIT AND RUN**

Enon Road, a deputy responded to a hit and run. A biker, down on his luck with a flat tire, was walking on the shoulder. While doing so, a red Toyota with dealer tags came off the road, struck multiple trees, a Verizon utility box, and nearly struck the bicyclist. Luckily, the bicyclist was able to avoid being struck.

## **TRAFFIC OFFENSE**

Falmouth Drive, a deputy observed a vehicle with a stolen license plate being operated in the area. Deputies responded to assist and the driver was detained. The license plate was confirmed to be stolen out of Spotsylvania County and the driver had a revoked license. He was charged with possession of stolen goods and driving while revoked. He was held at Rappahannock Regional Jail on a \$2,000 secured bond.

Cool Springs Road, a deputy responded to a road rage incident. The caller advised after cutting off a Jeep, the Jeep driver began following them for approximately 8 miles straight. The deputy located the victim driving on Brook Road with the suspect vehicle still closely following behind her. A traffic stop was conducted and the deputy made contact with the driver. The driver advised he was driving aggressively and following the victim in an attempt to "scare'em" As a result, warrants for disorderly conduct, following too closely, and aggressive driving were obtained.

# CHARLIE ZONE

## ASSAULT

Brooke Point High School, a deputy was conducting his SRO duties when he observed a student with apparent injuries. It was discovered the victim was assaulted by a large group of students while in the boy's bathroom. One of the attacking students was identified and criminal complaints for assault and battery, as well as, malicious wounding were submitted. Juvenile Intake was conducted and elected to detain the student. The investigation is ongoing.

## DUI

Area of Richmond Highway and Castle Court, a deputy located an early morning drinker. While traveling in the area, the deputy observed a Nissan swerving and taking up two lanes of travel. A traffic stop was conducted and the driver was observed to have several signs of intoxication. Not only did he have no driver's license and admitted to drinking "10 to 12" Miller Lites before getting behind the wheel, but the driver was also wanted for a hit and run. The driver was charged with driving under the influence, driving without a license 2nd offense, the traffic lane violation, and served on his outstanding warrant. He was held at Rappahannock Regional Jail without bond.

## WARRANT SERVED

Townes Place, deputies attempted to serve a warrant. The suspect was wanted for two (2) Stafford warrants. The deputy would make contact with a male at the front of the residence while a 2nd deputy watched the rear. While the male claimed that the suspect they were looking for was not there, the deputy would observe that exact suspect attempting to sneak out the back. His plan failed and he was detained. The wanted suspect was served on his outstanding warrants while the male who answered the door was charged with obstruction of justice. Both were held at Rappahannock Regional Jail without bond.



# DELTA ZONE

## LARCENY

Home Depot, 305 Worth Avenue, a deputy responded to some trouser troubles. Staff advised a male “shoved” merchandise down his pants and attempted to leave the store with it. While the merchandise was recovered, it is unlikely someone will want it. The deputy identified the suspect and discovered he was wanted for a failure to appear charge. The problem-pants-patron was served on his outstanding warrant and additionally charged with shoplifting. He was held at Rappahannock Regional Jail without bond.

Walmart, 217 Garrisonville Road, a deputy responded to some bad banana behavior. Staff advised a male walked out with unpaid cases of Bud Light and bunches of bananas. Besides buzzing off in a bustle, the busy burglar was identified. The bizarre blend of bananas and beer were brought back to the business and the suspect was issued a summons for shoplifting.

Petco, 309 Worth Avenue, a deputy responded to a barking-mad larceny. Staff advised a female stole over \$100 worth of dog food. The *paw-sitively* rough larceny was caught on camera as the suspect entered a dark Audi SUV.

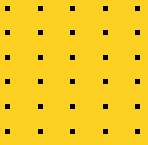
Giant, 317 Worth Avenue, a deputy responded to a larceny. Staff advised a suspect stole a basket full of snacks. The deputy would observe the basket-wielding bandit near Woodstream Boulevard where the deputy attempted to make contact with the suspect when they fled on foot. Luckily, cars are faster than fleeing suspects and the deputy was able to catch up to the suspect and detain them. They were charged with shoplifting and obstruction of justice. They were held at Rappahannock Regional Jail on a \$500 secured bond.

## THREATS

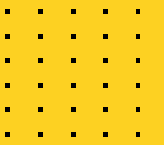
North Stafford High School, a deputy was conducting his SRO duties when he was informed of a threats report. A student sent threatening messages to another student via Instagram. The 18-year-old suspect was charged with threats of death and released by the magistrate on personal recognizance.

## ASSAULT

Rodney Thompson Middle School, a deputy was conducting his SRO duties when he was informed of an assault. It was discovered a student assaulted another after a verbal altercation. Staff would attempt to de-escalate the incident and they too would be assaulted. The investigation is ongoing and criminal complaints are pending.

Deputies informed the victim of the scam and no law enforcement agency would request money over the phone or by cryptocurrency.

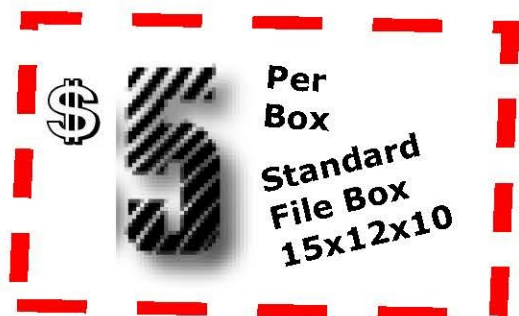
