WEEKLY CRIME REPORT

ALPHA ZONE

DUI

At the intersection of Warrenton Road and Cardinal Forest Drive, the deputy responded to a complaint of drunk driving. The caller advised a vehicle was driving all over the road and nearly struck a median. The deputy easily discovered the vehicle due to it swerving and traveling in two lanes of traffic and conducted a traffic stop, making contact with the driver, who had immediately noticeable signs of intoxication. While the driver denied consuming any alcohol, the odor of an alcoholic beverage coming from his breath and half-consumed bottle of alcohol next to him would prove otherwise. The driver was charged with driving under the influence, drinking while driving, reckless driving, and refusal.

FRAUD

America's Best Value Inn, deputy responded to a rather unusual scam. A staff member requested a tenant to watch the front desk for him, he was not feeling well. During this time, the tenant received a call from someone posing as the business owner. The fake owner advised he needed money sent to him and the best way to do so would be to have the tenant break into the safe and take cash. While the safe was broken into, luckily, the scam was stopped before the suspect could get the money.

ASSAULT

Waffle House, deputy responded to an assault. Staff advised three (3) male suspects began assaulting a male victim inside the business. The parties were separated and the three (3) suspects fled in a black SUV.

LARCENY

Waffle House, deputy responded to a failed larceny. Staff advised a male suspect attempted to reach over the counter and open the register. When it did not open, the suspect fled in a black Mercedes.

LARCENY

Birds Nest Way, deputy responded to a larceny. The victim advised his vehicle was unlawfully entered and a drone was stolen. Luckily, the deputy has eyes as powerful as our own Drone Team and located the stolen drone abandoned in the neighborhood. He returned the property to the victim.

DISTURBANCE

Setter Circle, a deputy responded to an indecent exposure call. Multiple victims advised they observed a male exposing his genitals from the window of an apartment. The deputy made contact with the suspect in that apartment who, not shockingly, was barely dressed. Instead of continuing the conversation, the suspect refused to identify himself and closed the door on deputies. Despite that, the deputy was able to identify the suspect and obtained warrants for indecent exposure and obstruction of justice.

BRAVO ZONE



ASSAULT

Brentwood Lane, a deputy responded to an assault with a weapon. When the deputy arrived, he was met by the victim who was actively bleeding from the head. While providing first aid, the deputy discovered the victim was assaulted by a roommate with a frying pan over a disagreement with the thermostat. She was charged with aggravated malicious wounding and held at Rappahannock Regional Jail without bond.

DISTURBANCE

The intersection of Cambridge Street and Spring Valley Drive, a detective observed the passenger of a vehicle produce what appeared to be a firearm out the window. Additional deputies responded and conducted a high-risk traffic stop in the area of Centreport Parkway. When both occupants were detained it was discovered the firearm was a toy Glock for their game of "senior assassins." The juvenile occupants received a heavy lecture from both deputies and their parents, on the dangers of playing such a game.

PUBLIC INTOXICATION

Wawa, a deputy responded to an assault. The caller advised a known party threw a bottle at her. The deputy made contact with the caller, who was intoxicated, and found no evidence of a bottle brawl. She was charged with public intoxication and held at Rappahannock Regional Jail until sober.

CHARLIE ZONE

ASSAULT

Edward E. Drew Middle School, deputy was conducting her SRO duties when she took notice of a large group gathering. As she approached, one juvenile began assaulting another. The deputy physically separated both females and de-escalated the situation. A criminal complaint for assault and battery for the predominant aggressor was filed.

DRUGS

Brooke Point High School, deputy was conducting his SRO duties when he was informed of drug activity. Staff advised they received information on a student selling vapes within the school. During an administrative search, staff discovered the student in possession of 11 THC vapes. Criminal complaints for underage possession and possession on school grounds were submitted.

PUBLIC INTOXICATION

7-Eleven, deputies responded to a public intoxication call. Staff advised there was a group of intoxicated males attempting to purchase more alcohol. Deputies located the four (4) suspects in the parking lot in an extremely intoxicated state. All four (4) were charged with public intoxication and held at Rappahannock Regional Jail until sober.

Brooke Road, deputy responded to a disturbance. The caller advised a group of trucks were doing burnouts. While investigating the disturbance, the caller responded to investigate it himself, despite being in an intoxicated state. The caller advised he wanted to “come teach them” before deputies arrived. He was charged with public intoxication and held at Rappahannock Regional Jail until sober. None of the reported drivers were located.

DRUGS

Stafford High School, deputy was conducting his SRO duties when he was informed of a vape offense. Staff discovered a student in possession of a nicotine vape for the fourth time. A summons for unlawful possession of vape products was obtained.

VANDALISM

Norman Drive, a deputy responded to vandalism. A bus driver advised their window had been shattered by a BB gun, possibly. The investigation is ongoing.

DELTA ZONE

DRUGS

Red Roof Inn, deputy responded to a groaning guest. The caller advised they could hear a female making loud groans and screams all night. Deputy Sullivan made contact with the suspect who advised she just got out of prison, but didn't remember anything after that. She was found to have suspected controlled substances, as well as, prescribed medication that did not belong to her. She was charged with two (2) counts of possession of controlled substances and held at Rappahannock Regional Jail without bond.

LARCENY

Walmart, deputies responded to a larceny. Staff advised they were watching two (2) female suspects skip scanning items. Deputies made contact with both of them as they passed all points of sale with two (2) carts full of items. Over \$400 worth of items was recovered and both suspects walked out with a summons for shoplifting.

Home Depot, 305 Worth Avenue, deputy responded to a larceny. Staff advised they had a video of a suspect motivated for a DIY project stealing over \$1,100 worth of vinyl flooring.

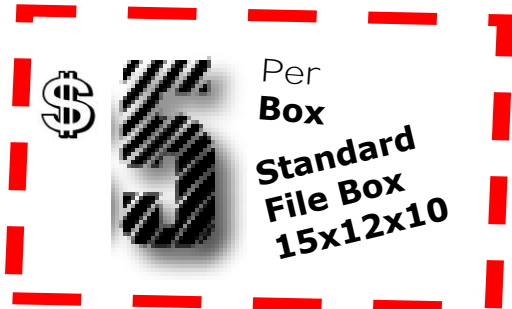
