Vista Woods Road Vista Woods 05/02/23 Fraud: SCAM: Victim received three (3) pop-ups while using their home computer. The pop-ups provided a number for the victim to call "immediately"; victim complied. After speaking with an unknown male, he advised the victim that their computer had been compromised and the victim would need to pay for the computer to be "fixed." Over several weeks, victim would speak with the unknown male for several hours at a time. During this time frame, the unknown suspect requested copies of the victim's identification and online banking information ; victim complied. Eventually, the unknown suspect instructed the victim to visit their banking institution and transfer monies with a beneficiary of an unknown person. Victim's bank was suspicious and conducted their own investigation, holding the transfer, and determined it had been a scam. Banking institution canceled the transfer and instructed victim to contact the Sheriff's Office. Due to the banking institution stepping in, victims avoided a fraudulent transfer of \$94,000.

Poplar Road 05/03/23 Larceny: Theft of chainsaw from victim's residence. Courthouse Road 05/03/23 Burglary: Two suspects attempted to break into a vacant residence. Suspects were caught by Stafford County's deputies while attempting to enter the property. Vista Woods 05/04/23 **Stevens Drive** Fraud: Victim's credit card was compromised and sustained five (5) fraudulent charges. Monetary loss of \$790. **Boundary Drive** Lake Arrowhead 05/04/23 Fraud: SCAM: UTILITIES: Victim received a call from the suspect who identified himself with the electric company and informed the victim that their service would be disconnected for not paying an initial deposit. Victim paid the suspect \$1,500, then an additional \$1,500. When the suspect called back asking for more funds, victim became suspicious and with the help of a family member was able to contact the electric company only to find that the victim had in fact been scammed. Monetary loss of \$3,000.

05/04/23 Stefaniga Road Fraud: Victim's credit card was compromised and sustained fraudulent charges. Monetary loss of \$1,000.

305 Worth Avenue 05/04/23 Home Depot Embezzlement: Theft of items from business by an employee.


