The individual who interviewed the victim stated they would send the victim a check to deposit for expenses, which the victim received and deposited into their personal account. A few days later, the victim received a second check and attempted to deposit. It was at this time the victim was informed by their banking institution the checks were fraudulent. Victim reached out to Creesy Everett Real Estate and found they had not interviewed the victim, and this had been a financial scam. Luckily, no monetary loss to the victim.


