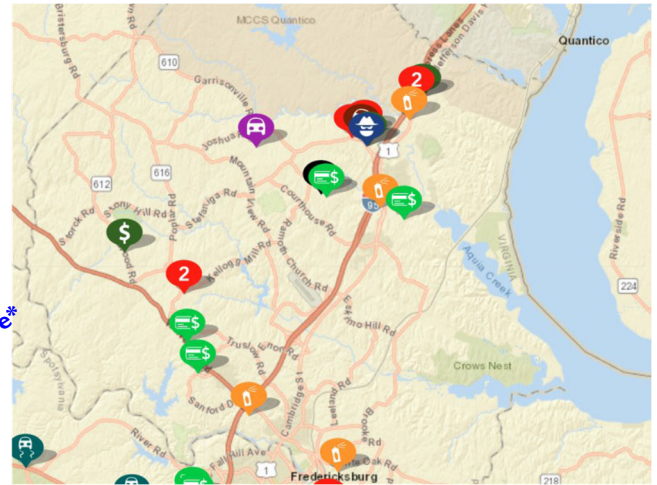

750 Kings Highway Rappahannock Community Services Board 05/24/21
Larceny: Theft of catalytic converter from company vehicle.

125 Washington Square Plaza Walmart 05/27/21
Larceny: Suspect changed bar code on items to a lesser price before scanning. Suspect also skipped scanning additional items, placing items directly in the bag. Monetary loss \$84.15.

Lord Fairfax Drive Blythe 05/27/21
Fraud: **SCAM: COX CABLE: Victim received phone call regarding "Internet issues" that could be resolved over the phone, but would need access to victim's computer; victim complied. Suspect mentioned victim had been overcharged and in order to refund the monies, he would require online -access to personal bank account. Victim does not use online banking; no monetary loss.**

Fraud: **SCAM: LAW ENFORCEMENT: Victim received call from "Deputy Diggs" stating victim had missed jury duty and subject to arrest unless a fine of \$4,000 was paid immediately. Caller instructed victim to purchase Money Pak cards and provide him with card numbers; victim complied. Monetary loss of \$4,000.**

Larceny: Theft of car cover.

Vandalism: Destruction of exterior security cameras.
